Dear Mr. Dickerson:

The Delaware Positive Behavior Support Project (DE-PBS) offers annual recognition to schools that exemplify specific components of the DE-PBS Key Features. The Project recognized four phases of School-wide Positive Behavior Support (SWPBS) program implementation based on schools' programs for the 2016-2017 school year.

To achieve Phase 1 recognition, schools reported existence of a representative SWPBS team, positively stated behavior expectations and teaching strategies, an acknowledgment system, collaboration with families, and a framework for managing problem behaviors. Teams were also asked to administer a Needs Assessment or School Climate Survey to the staff and to answer a reflection question.

For Phase 2, earning an exemplary or proficient level of implementation on the DE-PBS Key Feature Evaluation (KFE) was a pre-requisite for application. As the DE-PBS Project fidelity measure for schoolwide PBS implementation, this tool was a logical requirement. Schools earning an exemplary level were automatically recognized, and those earning a proficient level developed and submitted an action plan based on the KFE.

To be recognized as a Phase 3 school, schools documented their group-based interventions, including providing information about the problem solving team structure, use of behavioral interventions, data tracking, and providing information to parents. Teams also summarized a case study of a student supported through this intervention process.

Phase 4 schools have developed a strong Tier 2 system. Schools documented this system including overall intervention effectiveness, identifying evidence-based group interventions, and monitoring student responses to the interventions. This phase acknowledges the systemic structure of Tier 2 and the ongoing collection of intervention response data.

Milford School District can be proud of the efforts of the following schools that received DE-PBS Phase Recognition for the 2016-17 school year:

- Phase 1 – *Morris Early Childhood Center*;
- Phase 3 – *Ross Elementary*.

Phase 1 recipients receive a certificate and blue ribbon, and Phase 2, 3 and 4 recipients receive a certificate and banner for display. We congratulate your schools on creating safe and caring learning environments that promote the social-emotional and academic development of all children.




What's going on in the classroom!



Reading: In reading this month the students will be learning about making predictions while they read and stretching out the sounds in words. You might hear your child refer to Prickles the Porcupine as a predicting buddy and Stretchy the Snake as a decoding buddy. The students are also learning that they things they know about it called their "schema" and good readers always make connections while they read so that they understand what they are reading.

Math: In math they will be learning about numbers 6-10 and comparing and ordering the numbers. They will also learn about shapes and addition.



Nurse News

Screenings for vision and hearing from the nurse are going well, if there are any concerns, letters will be sent home with your child. Please call the nurse's office at 422-1652 if you have any questions.

As the weather is getting colder please remember to swap out your child's spare change of clothes for long pants and shirts/undershirts. If your child does not have a change of clothes at school please send an extra set to school in a labeled bag, they will stay in the classroom or if you prefer your child's backpack. If your child borrowed clothes from the nurse please return them as soon as possible. Thank you for the clothes that have already been returned.

With Cold and Flu season among us please remember:

1. Prevent the Flu, contact your child's doctor to set up an appointment to get their yearly Flu Vaccine.
2. In the event your child does become sick, they must be fever free without fever reducing medication (Tylenol or Ibuprofen) for 24 hours before he/she can return to school.
3. If your child is vomiting or has diarrhea, those symptoms must be gone for 24 hours before he/she can return to school.
4. If your child needs medications during school, you must come in with the medication to sign a consent form for the nurse to be able to administer the medication. Medicine is NOT to be put in student book bags.
5. If your child has Asthma please make sure the nurse has your child's medication and consent forms signed. If you do not have medication here at Morris for your child, please bring them in or please make sure all of your contact numbers are up to date in the event of an asthma attack. If you are unable to be contacted and your child is having an asthma attack, the nurse will call 911.
6. Just remember, the best way to control the spread of germs is with good **HAND WASHING**. Practice with your child at home. Wet their hands, take them out of the water, apply soap and scrub while singing the ABC's. We try to reinforce the correct technique at school, however we see many children putting soap on their hands and sticking them right under the water, immediately washing all of the soap off. Friction with the soap out of the water is the best way to eliminate germs.

My name is Maud Forsberg-Davis, the students call me Mrs. Davis since my full name can be a little long and hard to remember for them. I am the school counselor here at Morris. I will start my 8 year here at Morris this year. As school counselors, we hold many hats in the different schools in Milford School District, such as counselor, teacher, team member/leader, coordinator, parent resource, Food Bank coordinator, etc. At Morris ECC I teach all students Life Skills; how to be a good friend; how to handle anger, how to recognize feelings in themselves and others; coping skills; career awareness; personal and internet/computer safety and many other topics. What we will be starting with is how to be a great listener so they can become great learners.

- Listening is the most important communication skill
- Listening should be the most used of our skills
- To be a great listener takes practice (as does any other skill that we want to succeed in)
- Listening is an active process
- Listening requires
ATTENTION

Practices to do at HOME:

READING STORIES aloud is a good way to capture your child's attention and encourage listening. Discussion questions can further enhance learning and listening. You can use questions like:

What did you think about...?


What was your favorite part?

Do you think that...will...?

Who is your favorite character so far?

DIRECTIONS

Giving directions verbally an easy way to make sure that your child gets practice in listening. You can explain how to do an art project, tell your child where to get his supplies for an activity, or tell him what to do for a science experiment. You can also give oral directions for age appropriate chores.



Tattling vs. Reporting

| TATTLING | REPORTING |

Some of the lessons we have been working on is **Tattling vs. Reporting**. It is very important that students learn to stand up for themselves instead of asking for help when there is a minor incident. Major issues do need adult help to be solved. Ask your child if they or someone else is hurt or in danger when you suspect that they are about to tattle on someone. That should trigger what we discussed in our lessons about Tattling vs. Reporting. We will work on the next step in the spring – Bullying, a word that they all knew and were using very frequently to explain the smallest incident. With that said, if you think that your child is bullied by someone, please hear them out and contact the school if it is taking place here.

Currently the students are working very hard on recognizing feelings in themselves and in others. We have been pictures of happy, sad, angry and scared. HAPPY FALL, BANNEKER BULLDOGS!

Throughout your child's school years, there is always a need for school personnel and parents to communicate. Working together for our children's health, our goal is to provide an environment that promotes optimal wellness for all Banneker students. To accomplish that goal, full cooperation and communication between home and school is essential.

Please advise the school nurse and teacher of any health conditions that may affect your child's learning and that the nurse may have to manage during the school day. This would include any medical, psychological, emotional or behavioral conditions.

Please bring all medication that your child needs to take at school, to the nurse's office. All medication needs to be in the original container with the prescription label. Over the counter medication needs to be in the original container, as well. Please do not bring medication in baggies!

Inhalers need to be in the original box with the prescription label. Parents need to provide all nebulizer tubing, masks or mouth pieces. We have a very limited supply of these items.

This is just a reminder to keep the school updated with any changes in contact information, so we can always be able to reach you for any problems or emergencies.

During the month of September, I conducted the 5th grade Scoliosis screenings. If there was a problem, a letter was sent home with your child. A physical therapist from A.I. DuPont will be here in the spring to further evaluate your child.

The 2nd and 4th grade vision and hearing screenings have also been completed at this time. If there were any problems, letters were sent home. Please contact me if you need assistance with appointments and glasses.

Reading: Reading stories with informational text, realistic fiction, fantasy, and folk tales, 48 sight words, Reviewed all of our short vowels, Learned about beginning blends (r, l, s-bends), Sequence of events, Main ideas and details, Understanding characters, Shades of meaning, Synonyms, Nouns, adjectives, verbs, Using text evidence, How to write a short answer response., AR books

Math: Spatial patterns, Addition to 10, Subtraction to 10, Word problems, Drawing pictures to solve a problem, Number lines, Missing parts

Writing: Using a graphic organizer, Brainstorming, Narrative Writing, Complete sentences, Using commas in a series

Science: What is a mechanical engineer?, Wind technology, Engineering process, What is wind?, Building sails.

Social Studies: Community Helpers, Citizenship, Role of a Leader, Elections, Voting

Keep up the great work! Also, please remember to practice your child's high frequency word cards, spelling words, and complete homework each night. The agenda book should also be checked and initialed each night.

2nd Grade news.....

There is a LOT happening in second grade! First of all, thank you to all the families who came in and met with their respective teachers for family conferences. We appreciate that you took the time out of your day to come in and speak with us. Your child's success is important to us and your participation displays that it is important to you as well.

We have had a great start across the curriculum with our new second graders as we have begun strengthening their comprehension skills through the use of our reading series as well as through our Accelerated Reader program. Thank you to all the families who read AR books with your students every night or who listen as they read to you. Reading homework is critical to success in school.

Second graders have been busy working on their addition and subtraction facts to 20 and beyond. This year it is expected that students pass timed math tests on their facts. Please help your student by using flashcards or online math fluency games. A little practice each week goes a long way.

Handwriting is a focus this year as well for us. We are working through the alphabet with the hopes of moving into cursive this year. Emphasizing correct handwriting and legibility when doing homework would be a plus for your child.

3rd Grade news.....

October was a busy and exciting time for Banneker third graders. Third grade classes enjoyed their first field trip of the school year. From Jay Lingo, M. Ed., School Counselor:

Welcome back to Ross for another fantastic school year! For those parents and guardians of first graders or of students new to Ross, I would like to briefly introduce the counseling program and myself. My name is Jay Lingo, and I am starting my 30th year here at Ross as the school counselor.

I work with ALL students by providing a comprehensive, developmentally appropriate guidance program. I teach Life Skills, an expressive arts class, to reinforce the areas of safety, manners, friendship, coping skills, feelings, and conflict resolution. Basically, as the name Life Skills implies, these are lessons which will benefit students throughout their lives. I also am available to work with students individually and in small groups to address common issues, which may be affecting your child's school performance: death, divorce, grades, friendship issues, self-control, etc. Please feel free to contact me if you need to meet with me concerning your child's school adjustment or if you have questions about the guidance program. I can be reached at 422-1640, ext. 257. This marking period we have learned about giving and receiving compliments, using coping skills such as 1) Walk Away, 2) Ignore and 3) Name Your Feelings, practicing effective communication skills, exploring feelings, and learning about drug and alcohol safety. I have been extremely pleased with the overall behavior and attitudes of the students in my classes. In fact, out of the 212 classes that I have taught so far this school year, only two classes have received a "gray" for poor behavior, the rest have all been "green"😊. I am looking forward to the next three marking periods with the wonderful students here at Ross.

From Ms. Fitzpatrick:

Ever heard of MI art and MI music? Ever wonder what the MI stands for? Multiple Intelligence! Which is a theory about how people learn. Which explains that people learn differently. Which means that learning an idea or skill by engaging more than one way WORKS! When our students draw, paint, sing or play instruments, they remember an idea better. In MI, we connect our music and artwork to ideas being taught in reading, math and science. Art and music skills are taught by giving students opportunities to think, problem solve and use deductive reasoning to create something new. We are focused on the process and try our best to create a well-done product to the best of each student's ability. Along with teaching the Delaware state mandated standards for art and music, you can image how each MI class is jam packed with action. Since students only have half of the academic year for art and the other half for music, we really rock and roll during our 45 minute class period! Check my district website for ideas on how to grow your child's skills and how to have fun with the exciting worlds of art and music. Reduce screen time and give yourself a chance to create something interesting and unique!

News from Nurse Jackie

Welcome back Ross Cats! WE are off and running to another great school year at Ross!

First, the nurse has completed all Posture/Gait screenings for the 5th graders. If your child was referred for follow up in the spring by an A.I. DuPont physical therapist, you will get a note from the nurse. All vision and hearing screenings have been completed for 2nd and 4th grade. Any child who had difficulty with their vision or hearing had a note sent home by the nurse, to be followed-up by a specialist. Please try to get this done as soon as possible and send the form from the doctor of treatment provided back to nurse.

Please keep your nurse and teacher in the loop of your child's health, this also includes family illness, loss and yes, even a pet loss.

- Review hygiene tips with your child to prevent spread of infections.
- Now that school has started, check your child's hair on a daily basis. Talk with them of no head-to-head contact with other students, no sharing of combs, barrettes, hair ties, hats, scarves, jackets. Please inform the nurse if you had to treat your child for head lice.
- Make sure immunizations are up to date.
- Eat breakfast each day at home or at school.
- Help your child wear appropriate dress code clothing and shoes. On cool days keep a sweater or sweat shirt in your child's book bag in case rooms are chilly. Also, wear appropriate shoes for gym class, i.e. sneakers, no open toe shoes or shoes with high heels, or boots.
- Keep open line of communication with your child, if a concern arises (such as bullying) contact the appropriate school officials immediately.
- Get involved! Sign up for the PTA. Mark your calendars for school events and parent/teacher meetings.
- Make your child's health concern known to the school, the school nurse, and the bus driver.
- For any treatments, medications given at school, or allergies requiring epi pens, bring a current signed healthcare provider order for treatments, allergy plans or asthma plans to the nurse. All medication must be kept in the health office, in the original pharmacy container with prescription label. The parent must write a note or fill out the medication consent form for the nurse to give any medication.
- Provide updated physical to the nurse.
- Give permission for your school nurse to talk with your family's healthcare provider.
- Provide parent/guardian contact information and update the school with any address or phone number changes.

Don't let the flu stand in the way of your school work, sports, extracurricular activities and social life. Follow these tips to protect yourself:

1. **Common sense can help you, and your friends, avoid the FLU**
Group gatherings like football games, school dances, and even classrooms are ideal places for the flu bug to spread. Protect yourself and others by following these simple steps:
 - **Practice Healthy Habits**-Wash your hands often with soap and water for at least 20 seconds to help prevent germs from spreading. Also avoid touching the "T Zone", eyes, nose, and mouth, because the virus can spread when hands touch surfaces that are infested with germs.
 - **Mind your manners**-Cover your mouth and nose with a tissue when coughing and sneezing, and throw away your used tissues. You can also cough into the bend of your arm and sneeze into your arm.
 - **What's mine is mine, What's yours is yours**-Don't share drinks, water bottles, eating utensils or cell phones with friends.
2. **If possible get a FLU SHOT**-Many children are at higher risk for complications from the flu. Talk to your doctor about whether a flu shot is best for you
3. **Is it COLD or FLU?-Know how to tell the difference:**
 - If you have a stuffy nose, sneezing, sore throat and a hacking cough, you probably have a **COLD**.
 - If you have a high fever, severe headache, muscle and body aches, extreme tiredness, and a dry cough, you probably have the **FLU**.
4. **What to do if the flu catches up with YOU**-If you do get the flu, you don't have to suffer:
 - **Contact your Doctor**. If you have flu symptoms, stay home from school. Your doctor may decide to prescribe an antiviral medication, which can shorten the number of days that you are sick.
 - **Talk to the School Nurse**-Discuss with her the symptoms your child is having, she may advise you to keep your child home from school and request you to have your child seen by a doctor.

WE are off to a great start! Let's make this a healthy, safe school year! Here's to a HEALTHY and SAFE 2017-2018!

RE: K-3 Student-Instructor Ratio Requirements and 98% Rule

DATE: October 31, 2017

Title 14 Section 1705A of Delaware Code states in part “The ratio of students to instructors in any class in kindergarten or grades 1-3 in a Delaware public school shall not exceed 22 students as of the last school day of October.” While most of the district’s K-3 class sizes meet this requirement, some do not. Delaware Code provides a waiver provision in which the Milford School District Board of Education can waive this requirement at their discretion.

Also, Section 1704, Title 14 of Delaware Code states in part “Each local school board shall allocate Division I units to schools in its district such that as of the last school day of October each school receives not less than 98% of the Division I units it generates as a result of the actual unit count.” Final unit count will not be not certified until late November and in order to utilize earned units to offset state budget reductions per Section 368 of the Fiscal Year 2018 Appropriations Bill (H.S. 1 for H.B. 275), the board should waive this requirement.

What is State Procurement?

- Procedures for making purchases using public funds
- Delaware Code Title 29, Chapter 69 sets regulations for all state agencies
 - Definition of a State Agency: Every board, department, bureau, commission, person or group of persons or other authority which directly receives moneys under any budget appropriation act or supplemental appropriation act and which was created and now exists



Why follow State Procurement Regulations?

- It is Delaware Law!
- Violations of Procurement regulations have strict consequences

§ 6903 Violations and penalties.

- Any person, who, with intent to avoid compliance with this chapter, willfully fragments or subdivides any contract for the purchase of materiel, nonprofessional services, public works or professional services, shall be subject to the penalties listed in this section.
- Any individual or firm which commits a violation of this chapter, as listed in this section, shall be punished by a fine of not less than \$1,000 and not more than \$2,000 or by imprisonment for not more than 6 months, or both, and upon a second or subsequent conviction thereof, shall be punished by a fine of not less than \$2,000 and not more than \$5,000 or by imprisonment for not more than 1 year, or both.
- The Superior Court for the State shall have exclusive original jurisdiction over offenses listed in this section.



Exceptions to the rules

- Delaware Code allows certain exceptions to Procurement Procedures
 - If any provision of this chapter conflicts or is inconsistent with any statute, rule or regulation of the federal government
 - This chapter shall not apply to any purchase of materials or services from the federal government or from the government of the State including any agency of the State
 - **This chapter shall not apply to contracts for the transportation of school children. Such contracts shall be submitted to the Secretary of Education through the Department of Education Transportation Office for approval.**
 - **This chapter shall not apply to any purchase of library materials such as books, periodicals, subscriptions and software by libraries of any agency**
 - If no state contract exists for a certain good or service, covered agencies may procure that certain good or service under another agency's contract so long as the arrangement is agreeable to all parties.

Sole Source Procurement

- **§ 6925 Sole source procurement.**
 - A contract may be awarded without competition if the agency head, prior to the procurement, determines in writing that there is only 1 source for the required contract
 - Sole source procurement shall not be used unless there is sufficient evidence that there is only 1 source for the required contract and no other type of goods or service will satisfy the requirements of the agency
 - The agency shall examine cost or pricing data prior to an award
 - Sole source procurement shall be avoided, except when no reasonable alternative sources exist
 - A written determination by the agency for the sole source procurement shall be included in the agency's contract file
- **Textbooks and related instructional materials are sole source purchases.**
- An agency seeking a sole source procurement shall prepare written documentation citing the existence of a sole source condition. The document shall include the specific efforts made to determine the availability of any other source and an explanation of the procurement need. The agency may, for confirmation, submit this documentation to the Section for review and comment prior to the intended date of award.

Emergency Procedures and Critical Need



- An agency head may waive any or all provisions of this chapter to meet the critical needs of the agency as required by emergencies or other conditions where it is determined to be in the best interest of the agency.
- The agency head may determine an emergency condition exists by reason of extraordinary conditions or contingencies that could not reasonably be foreseen and guarded against.
 - An emergency condition creates an immediate and serious need that cannot be met through normal procurement methods for the protection of public health, safety or property.
- Any procurement pursuant to this subsection shall be limited to those materials and/or services necessary to satisfy the emergency.
- A copy of each emergency determination processed under this procedure shall be kept on file by the agency.

Procurement Classifications

- Materiel and Non-Professional Services
- Public Works
- Professional Services



Materiel and Non-Professional Services

- "Materiel" means materials, equipment, tools, supplies, or any other personal property, but does not include real property or electric, gas, water, telephone or similar utilities.
- Non-professional services are skilled or unskilled labor or professional work, but do not include professional and consulting services (ex: Carpet Installation, Courier Service, etc).



Public Works



"Public works contract" means construction, reconstruction, demolition, alteration and repair work and maintenance work paid for, in whole or in part, with public funds.

Professional Services

- "Professional services" means services which generally require specialized education, training or knowledge and involve intellectual skills.
- Examples of professional services include, but are not limited to:
 - Engineering and environmental engineering
 - Environmental monitoring
 - Land surveying
 - Landscape architecture
 - Geology
 - Architectural
 - Archaeologists
 - Architectural historians and historians
 - Educational consultants
 - Management
 - Medical
 - Teaching
 - Planning
 - Computer information management
 - Financial
 - Accounting
 - Auditing
 - Construction Management
 - Arbitration services

fact or promise made by ADVANTECH shall not be deemed to create an express warranty; that ADVANTECH does not make any representation or warranty, including any implied warranty of merchantability or fitness that the system or service supplied may not be compromised, circumvented, or the system or services will in all cases provide the signaling, monitoring and response for which it was intended; that CLIENT is not relying on ADVANTECH's skill or judgment in selecting or furnishing a system suitable for any particular purpose; that there are no express warranties which extend beyond those on the face of the agreement hereof, or herein, and that all implied warranties, if any, coincide with the duration of this warranty.

2) MONITORING, INSPECTION &/OR SERVICE COVERAGE PLANS - TERM, RENEWAL & RATES. The term is one (1) year beginning on the Effective Date listed on this Agreement. At the end of the initial one (1) year term or any subsequent renewal term, the Agreement will automatically renew for an additional one (1) year term, unless either CLIENT or ADVANTECH gives written notice to the other of cancellation at least ninety (90) days before the expiration of the term. ADVANTECH has the right to terminate this Agreement ten (10) days after written notice, if CLIENT fails to make timely payments or if CLIENT willfully or negligently causes repeated false alarms. Client may terminate this Agreement after thirty (30) days written notice.

3) Upon CLIENT request ADVANTECH shall provide service to the system. Unless covered by a Service or Software Support Plan CLIENT agrees to pay for services in accordance with rates stipulated in the **Delaware State Building Access Security Services contract GSS15599-BLD_SECURE**. ADVANTECH shall acknowledge CLIENT requests for service within one (1) business day. Expected response for emergency service is no more than four (4) hours.

4) CLIENT understands and acknowledges the System may transmit video, voice and data to a monitoring location or elsewhere using one or more forms of communication equipment or services, including, without limitation, a telephone network, computer network or data cabling. Furthermore some or all of these communications equipment or services may fail and that all of these services are outside the full control of ADVANTECH, and ADVNTECH has no responsibility for video, voice, and data transmission failure.

5) CLIENT understands that ADVANTECH makes no guarantee, representation or warranty including any implied warranty of merchantability or fitness for a particular purpose, that the product or service supplied will avert or prevent occurrences or the consequences there from which the system or service is intended to detect or avert. CLIENT understands and agrees that if ADVANTECH is found liable for any loss or damage from a failure to perform its obligations or from an equipment failure, ADVANTECH's liability is limited to the total price of this agreement.

6) IF any payment by CLIENT is received by ADVANTECH more than 30 days after the due date, CLIENT agrees to pay interest form the due date on the entire balance due and owing at the rate of 1% per month or maximum amount permitted by Delaware law. This agreement may not be altered, modified, or otherwise changed except with the written consent of both parties as an addendum to this agreement. If any of the terms or conditions of this agreement shall be declared invalid or inoperative, all of the remaining terms and conditions will remain in full force and effect. CLIENT here by acknowledges receipt of a copy of this agreement, and that CLIENT has read and thoroughly understands its terms. The conditions of this Agreement shall cover all subsequent work for CLIENT by ADVANTECH, its sub-contractors or assignees and shall remain in full force and effect even after the termination of any monitoring, inspection or service term. This agreement shall be enforced in accordance with the laws of the State of Delaware
