BOARD PRESIDENT'S REPORT

Mr. Wyland recognized the achievements of the Mt. Lebanon High School football team in winning the District's first ever PIAA State Championship. He congratulated Coach Palko, the coaching staff, and players.

He reflected on the District's Covid vaccination clinics for students and staff and being one of the first districts to offer pool testing. He thanked Dr. Steinhauer and the administration and noted that in-person learning is able to continue due to mitigation strategies, vaccinations and pool testing.

Howe Elementary School Counselor, Mrs. Han Karbowski, was recognized with The Extra Mile award.

SUPERINTENDENT'S REPORT

Dr. Steinhauer commended the efforts of the Mt. Lebanon High School football team, marching band, cheerleaders, school board, coaching staff, athletic department and entire community. He spoke about Coach Palko's work ethic and the positive relationships he has built with the team. Coaches will be honored at the January School Board meeting.

During his Covid update, Dr. Steinhauer reported that the state of Pennsylvania has returned decision making regarding masking to individual districts. The District will continue to follow the recommendation of the Centers for Disease Control and the Allegheny County Health Department and continue to require universal masking for all district facilities, regardless of vaccination status. The District continues to offer pool testing and encourages all staff to become vaccinated. The Test to Stay program, which is being offered by the Pennsylvania Department of Health, is being explored. Community conditions will continue to be monitored and recommendations will be made to the Board.

Dr. Steinhauer concluded his report by wishing all students, staff, administrators, and families a happy, healthy, and fun winter break.
