



2022-2023 INNOVATION GRANT GUIDELINES

The Mesquite ISD Education Foundation is now accepting Innovation Grant Applications for the 2022-2023 school year.

APPLICATION DEADLINE - MARCH 31, 2022

\$150,000 is budgeted for Innovation Grants. Innovation Grants must be a minimum of \$10,000 and no more than \$15,000.

GENERAL ELIGIBILITY REQUIREMENTS

- Applications are limited to MISD campuses. Campuses may submit more than one Innovation Grant Application.
- Programs should address a need, challenges, and concerns unique to their campus.
- Programs may be experimental but must be innovative, imaginative and originitive.
- Preference is given to new program ideas; verses repeat programs on a specific campus.
- The proposal is appropriate for submission only if the following questions can be answered in the affirmative:
 - Is the proposal congruent with the District’s Strategic Plan and Campus Improvement Plan?
 - Will the proposal improve student learning?
 - Does the application directly or indirectly affect students?
 - Can the program be completed in the timeframe allowed?
 - Are the objectives measurable?
- The Education Foundation is seeking to fund programs creating learning environments that:
 - Provide high-impact learning that emphasize personalization, choice, and flexibility for student learning.
 - Are designed as prototypes to measure outcomes of proposed learning innovations.
 - Acknowledge and allow for learning differentiation and/or project-based learning.
 - Encourage the acquisition of 21st Century “soft skills” needed for our current and future workforce.
 - Create time for student curiosity and purposeful play.
 - Foster entrepreneurialism and/or sharing of student-produced work to worldwide audiences.

SUBJECT CATEGORIES & PRIORITIES: Applicants will select a subject category when completing the application from the options below. Program ideas are not limited to those listed here.

SUBMISSION DEADLINE & PROCEDURES Grant Applications are due on **March 31** by midnight.

Submission Procedures: Please follow these steps to electronically submit your grant application. Applications are only accepted electronically. Applications must be approved by your Principal.

1. Create a folder in Google Drive using your FIRST and LAST NAME – CAMPUS NAME.
2. Make a copy of this file and save it in the Google Drive folder that you have created.
 - Name the file in the following format: INNOVATION GRANT – GRANT TITLE - CAMPUS NAME
 - If applicable, upload completed Technology Approval Form and/or Facility Approval Form to your folder. Name THE file in this format: TECHNOLOGY OR FACILITY FORM – NAME OF GRANT – CAMPUS NAME
3. Once your application is final and saved in the folder you created you will share the entire folder with Randy Lewallyn (hlewallyn@mesquiteisd.org). **Do not share the folder until final. Once shared, changes may not be made!**

GRANT TIMELINE

- March 31, 2022 Grant Application & Approval Form Deadline (by midnight)
- April 2022 District administration team scores grants anonymously.
Foundation meets to draft grant-funding recommendation.
- May 2022 Grants awarded
- May 30, 2022 Grant Evaluations due from previous year's (2020-21) grant recipients
- July 2022 Unused 2021-2022 grant funds returned to the Education Foundation
- August 1, 2022 2020-21 Grant Funds made available to grant recipients

SCORING PROCEDURE

A Mesquite ISD administrative team will vet all grants. If the grant request includes any technology or facility components, you must submit a Technology and/or Facility Approval Form.

STEP 1: Members of Dr. Vroonland's Leadership Cabinet will score applications. Scorers will give each application a score of 1-10 based on the eligibility criteria. Applications will be number-coded rather than identified by campus name to ensure scoring is done anonymously. **Any specific reference to campus name should be limited to the application cover page.**

STEP 2: Once scoring concludes, the Mesquite ISD Education Foundation Programs Committee, consisting of Education Foundation Board Members, meets to review the grant applications. The Programs Committee will make a funding recommendation to the full Education Foundation Board at the April Board Meeting. Grants are funded until the budgeted amount is expended. Unused grant funds may be re-allocated to fund other Education Foundation grant categories.

ACCESS TO FUNDS

Funds for the approved projects will be available in August prior to the fall semester in which the projects are to be implemented. Grant funds will be deposited into a designated account through the MISD business office. Recipients must adhere to all Mesquite ISD purchasing policies and procedures using district approved vendors. Items purchased with grant funds become the property of the District, not the individual(s). Any unspent funds will revert to the Mesquite ISD Education Foundation at the conclusion of the school year. Grants may cover travel or honorariums. Items which will not be funded by the Mesquite ISD Education Foundation include non-school related door prizes, as well as cash, checks, gift cards, and gift certificates, as these are considered taxable income and violate IRS individual benefit restrictions. **Athletic and Fine Arts extracurricular activities are not eligible to receive grant funding.**

GRANT EVALUATION

A summary evaluation of the project with expenditure receipt copies is due no later than 10 days prior to the last day of school in May, 2023. Randy Lewallyn will send the Evaluation Form to grant recipients in April, 2023.
