I feel it is important to speak up about the most recent announcement of boundary changes. The new lines have come as a bit of shock to our Whitford Park neighborhood and our small community. My hope is that it is an oversight and a bit of not knowing our unique community dynamics. I hope my comments can be seen in the light of not grumbling about tactics BSD is using, but rather to inform you of details you may not have. I personally was okay with our children being redirected to Southridge High School. But, the newest lines have divided our local neighborhood and redirected our small development of homes from what is a natural connection with the Raleigh Hills School community.

While Garden Home road is convenient boundary line to draw, it does not fully inform how our local community works and plays together. The area in which we live is unique. My friends, fellow business owners and acquaintances frequently comment about how our amazing community is truly full of friends and acts in the spirit of what neighbors should be. A big part of that friendship and love for our neighbors is built through raising our children together. Our community preschool, Small Friends, launched our connections to a wider area that is now Raleigh Hills School and has been forward looking to Beaverton High School. Good morning. I was reviewing the latest Beaverton High School boundary update map and noticed a change that will significantly impact my local neighborhood community. In the original version, the dividing line between Southridge HS and Beaverton HS east of Western Blvd was along BH Hwy. In the new version it is Garden Home Rd. I understand the seeming logic of using Garden Home Rd as a divider, however it splits our neighborhood from the Vista Brook neighborhood with whom we have strong community links.

We live in the Whitford Park neighborhood, a community of about 100 houses on the southwest corner of Garden Home Rd and SW 92nd Ave. Our connections with the Vista Brook neighborhood (located on the northeast corner of Garden Home Rd and SW 92nd Ave) include not only a common elementary, middle, and high school experience for our children, but also connections through youth sports, a shared community center and library (Garden Home and Oleson Rd), a neighborhood pool located in the Vista Brook neighborhood, and the THPRD Harman Pool and park complex located adjacent to our neighborhood. Families in our neighborhood share holidays, picnics, parties, and vacations. We and our children see each other daily while out walking, walking dogs, riding bikes, going on runs, etc. We are one community and I ask that you not separate our children in the district boundary re-alignment.

Maintaining our connection with the Vista Brook communities would have a small impact on the overall attendance numbers. On average there have been 4 or 5 high school aged children per year in Whitford Park over the last 11 years I have lived here. Whichever way the boundary lines are drawn, I urge you to keep our neighborhood linked with Vista Brook.

To the committee and Superintendent Rose:

My family lives in Whitford Park, a neighborhood that is actively engaged in the Garden Home and Raleigh Hills communities through the schools, Vista Brook community pool, and the Garden Home recreation center. My husband Brian and I have two sons - a freshman at Beaverton HS and a 7th grader at Raleigh Hills K-8. (Once upon a time, I attended what used to be called C.E. Mason, Greenway Elementary, Whitford Junior High, and Beaverton High School.)

Our friends and neighbors - as BHS booster club and support fund volunteers - have been among the catalysts, with Principal Anne Erwin, for the positive momentum and the groundswell of support BHS is experiencing. It's been so inspiring to see and we have looked forward to following their lead the rest of our sons' years at BHS.

Even so, the first proposed boundary change that would have sent our boys to Southridge was a shock but still palatable because the communities to which we belong - largely united by the schools - were kept intact. We understand that boundaries must change and aren't so arrogant to believe that they should *only* affect other families.

The most recent proposal, however, has us concerned and motivated me to speak up.

- 1) Our neighborhood south of Garden Home Road has been split off from most of the rest of the neighborhoods that make up our school and neighborhood identity. On a bigger scale, I feel that change weakens both our neighborhood and the schools that are affected.
- 2) On a smaller scale, the change that will separate our children from most of their friends and home community will be finalized before my freshman son starts his sophomore year at Beaverton HS but won't actually take effect until his junior year. I worry about him disengaging with high school for that "limbo" year when he's attending BHS and knowing he'll be finishing at SHS, where the students and teachers will be strangers. Joseph, our son, thrives on continuity and tradition and I worry what this disruption will do to him and other students in his situation.
- What kind of a challenge will it be for him to stay motivated and active in a school community that he'll be forced to leave? Practically speaking, what will that do to his grades?
- How will the schools be impacted in terms of volunteer time and financial support when changes are imminent but not yet in place?

Recommendations:

I hope that moving the rest of the Garden Home/Raleigh Hills community south of Garden Home Road back to the BHS attendance area is among the options being seriously considered, especially since the latest proposal has left BHS under enrollment targets.

Regardless of whom the final changes affect, I'd love to see the high school changes phased in so that students would, if they choose, be able to finish at the high school they started. It's such a critical time in their lives in terms of growth and confidence-building that a lost year or two could have a big impact on them in the future.

As the high school boundaries currently stand, my neighborhood of Whitford Park will be divided between Beaverton and Southridge because we straddle SW Garden Home Road. We have an extremely tightknit neighborhood, going back generations, and dividing our children would be detrimental to our community. In addition, many residents of Whitford Park are members of the Vista Brook Pool, located just north of Garden Home Road. Vista Brook and Whitford Park have long been tied together by this neighborhood association which, again, straddles Garden Home Road.

Because Whitford Park is the only neighborhood that is divided by, rather than bordered by, Garden Home Road, my request is you keep us intact and connected to our Vista Brook community by moving our 105 homes back within the Beaverton High School boundary. By my estimate, this would mean an impact of roughly 14-16 students, who could be offset elsewhere.

Dear Boundary Committee,

Thank you for your hard work on this process. It is a very difficult and anxiety provoking process for families and for all involved.

Keeping the Cedar Mill elementary community together and attending Sunset High School fulfills **MOST (if not all)** of the criteria set forth by the Boundary Adjustment Committee.

- 1) <u>Available space</u>: There is available space at Sunset High School for the roughly 130 students remaining students from Cedar Mill Elementary who would otherwise get split up from their community.
- 2) <u>Proximity to School</u>: Cedar Mill elementary is 1.9 miles to Sunset High School straight down Cornell vs 3.7 miles to Beaverton High School via the shortest via Cedar Hills Blvd. It is 5.1 miles via 217. There is no comparison in the traffic though. Traffic is significantly less on Cornell than on 217 or Cedar Hills Blvd.

Furthermore, because of the horrible traffic to this area, my sons will not be able to participate in after school activities at Beaverton High School. We work and will not be able to pick them up at 5 or 6 pm in Beaverton. My sons can participate in after school activities at Sunset High School because they can get themselves home. *Please do not take the opportunity to participate in the high school community away from the families of Cedar Mill.*

- 3) <u>Neighborhood Unity</u>: These students have all grown up in Cedar Mill and identified with Cedar Mill sports, programs, business and community. They are Sunset Apollo's since a young age. Sunset High School is their neighborhood school, not Beaverton High School. We identify with Cedar Mill and Sunset is in Cedar Mill, not Beaverton. Making us go to Beaverton is just dividing this community.
- 4) <u>Safety:</u> There is no comparison about the safety for the students. It is <u>significantly more dangerous</u> (and frankly irresponsible of BSD) for the students in the Cedar Mill area to commute to Beaverton High School than to Sunset High School. There are several dangerous intersections that students would be required to cross if they have to go to Beaverton High School. This is not an issue with the Cedar Mill students going to Sunset. PLEASE consider the safety of our Cedar Mill Elementary students and not put these students at risk of traffic accidents.
- 5) <u>Transportation</u>: Keeping the Cedar Mill Elementary Students all together and going to Sunset will reduce transportation time and costs. In particular, BSD will need to continue to provide bus service on Cornell for students on the north side of Cornell for students to go to Sunset High School. So why should they also run buses along the same, two lane road, for students on the south side of Cornell to go to Beaverton High School? That makes no sense. It costs more and causes more traffic havoc on this narrow road.

There is a ravine just south of Cornell so these neighborhoods do not connect to any other roads. These students on the south

side of Cornell have to wait for buses on Cornell as there is no access to streets further south due to the ravine. Please keep all students that wait for a bus on Cornell (who happen to also be Cedar Mill Elementary Students) stay in the Sunset High School district with their community.

6) <u>Student Body Configuration:</u> Based on the Free and Reduced Lunch Student Population Map shared on 12/17/2015, having <u>ALL</u> students from Cedar Mill elementary continuing to Sunset High School will <u>add back</u> some students who live in a higher frequency area for F&R lunch to Sunset instead of sending these students to Beaverton. This will help balance the student body configuration as well as keep the community together.

7) Staffing patterns: this is the only criteria that I do not know if this request meets or not. It might, I just don't know.

In addition, the Superintendent also has the objective to minimize transitions for students. Clearly, keeping the remaining 130 students from Cedar Mill elementary minimizes transitions for the entire Cedar Mill elementary community.

Neither the Springboard Map nor the Learning Map fulfills the Superintendent's other objective of 90% capacity or less.

PLEASE keep Cedar Mill Elementary Students together and allow all of the students in this neighborhood go to Sunset High School. This fulfills 6 of the 7 boundary committee criteria (and perhaps all 7) as well as one of the Superintendent's objectives.

Like most of the Ridgewood families, we moved to the Ridgewood/Cedar Park/Sunset area because it's an IB school. The schools are highly successful—this is a well-known fact. It's disappointing that the boundary adjustments will take that away from kids who have worked for **10 years** in some cases to learn at an IB school and have those critical learning experiences that will forever change their lives. IB students learn differently and it could be detrimental to change the only learning methodology they have known at one of the most critical times in their lives—preparing for adulthood.

There are also public safety concerns about the boundary proposal, particularly around traffic: Transportation on the already packed streets to/from BHS will become more of a nightmare. More kids will be riding bikes on major roads to BHS, like Cedar Hills Blvd, and that road is not equipped for bike riders. It doesn't have bike lanes in the most heavily traveled sections of the road and that will increase the number of accidents and injuries.

Schedules: the schools aren't in the middle of the proposed zones. This means that some kids will have an hour-long commute each way, to and from school. That is not good for a kids brain—they need sleep and downtime in order to reinvigorate themselves to learn. When you add in daily homework expectations, there will not be time in the day for them to have this down time and that will negatively impact their attitude, scores, attendance, behavior and engagement in school.

All of our kids have spent years socializing with the other kids going to Sunset in extracurricular activities. With the change they will be thrown into new environments, new friends, new learning—not obstacles that can't be overcome, however the damage that is done while overcoming them—potentially poor grades, lack of engagement, unclear learning expectations—can negatively impact the next phases of their lives.

This isn't easy on the families of any school being impacted—hopefully the school board can come up with a compromise, like a phased approach to changing the boundary. I know that there are smart people who will have great ideas—listen to them please, and reconsider the boundary changes.

Thank you for your careful consideration during this process. We urge you to approve adopting the recently revised "SUN1" version of the boundary map (dated 12-3-15) which would include adding the Bethany neighborhoods east of Kaiser Rd/Bethany Blvd into the Sunset district for the following reasons. At the very least, we would ask that the committee consider even a portion of the SUN1 version that would include adding the Wismer Ridge neighborhood (borders Jacob Wismer and is east of Kaiser Rd) into the Sunset boundary.

Community/Neighborhoods Surrounding Jacob Wismer-Stoller: By including neighborhoods east of Kaiser Rd/Bethany Blvd into the Sunset boundary, this SUN1 proposed revision would positively keep the immediate surrounding neighborhoods bordering Jacob Wismer and Stoller schools rightly intact as our kids move thru their K-12 years. This SUN1 proposal would essentially remove the current "powerlines" boundary that arbitrarily separates the closely linked neighborhoods surrounding the Jacob Wismer and Stoller schools - (Bethany Terrace/Wismer Ridge/BVE). The powerlines are not a natural separation of this close community. Kids from these neighborhoods grow up together, live across the street from eachother, start elementary school together, and walk to school together. It makes logical sense that they would be all slated to Sunset together, which would allow the peer group intact from K-12 as it should be. These neighborhoods make up a great intact community - c ontinuing to have it split up is no different than drawing an arbitrary line and separating the Oak Hills neighborhood, which would not make sense. The arbitrary powerline boundary has created a hardship for many kids in this area to grow up together in the same community only to be unnecessarily separated at the most influential and important time for our teens as they leave 8th grade and enter high school. Even earlier than that, our kids are required to start this unnecessary separation in 5th grade when they enter into team sports and activities as teams/leagues require kids to stay on teams within their high school attendance area. SUN1 proposal would solve this issue and allow our kids and families in our community to stay together and support eachother during all the important K-12 years from Jacob Wismer to Sunset.

Physical Boundary: The more natural and logical boundaries for this area are the major arterial streets of Kaiser Rd and Kaiser Rd/Bethany Blvd, which physically allow a more logical high school community boundary as they are the natural divides between neighborhoods. In this instance, we would ask that you approve the SUN1 revision so that Kaiser Road/Bethany Blvd becomes the division in North Bethany, with homes east of Kaiser being assigned to Sunset. At the very least, please consider a more logical physical and community boundary by merging Wismer Ridge with Bethany Terrace in the Sunset district as they would then both become included inside the major arterial roads of Kaiser/Kaiser-Bethany Blvd.

I am a parent living in Vista Hills Neighborhood which feeds into Ridgewood Elementary School. We bought our house in Vista Hills because Ridgewood and Sunset are desirable schools to send our child too. We chose our location very carefully; it was a deliberate choice.

My two biggest concerns with the new mapping are:

- 1. There is no continuity for PYP/MYP/IB: BHS is not an IB school, and Sunset is an IB school. Ridgewood kids have been participating in the program since Kindergarten. The district has made a huge financial commitment to the Primary Years Program and would expect to have the choice to continue on that educational path by attending Sunset.
- 2. The distribution of the demographic (FRL) is not equalized between SHS and BHS.

After the last meeting (Boundary Adjustment Committee), it appears that the proposed modifications make that socioeconomic disparity between SHS and BHS even more significant. My calculations show that SHS would be at 13% FRL and BHS would be at 69% FRL, this is clearly not acceptable and needs to be revamped to make sure that percentage between schools is more equal.

If you are going to change the boundaries, change them in a way that makes sense and actually aligns with policy set forth by the district (equality, proximity, community cohesion, etc..).

Please continue to work on these changes and make modifications that align with the district policy for adjusting boundaries.

I'm writing today about the proposed Sunset High School boundaries. Thank you for serving the District and the community in this important effort.

As a resident of the West TV Elementary area with two children now at Cedar Park Middle School, I join the chorus of hundreds of neighbors in advocating for the West TV and Cedar Mill Elementary areas (those North of the Sunset Highway) to continue to attend Sunset High School.

I've read the thorough and thoughtful comments of neighbors, and I share their well-documented concerns about the distance, traffic, and safety problems if the West TV area were to attend Beaverton High School. BHS is farther away on busier streets. It's clear that a "safe route to school" along Cornell Road to Sunset is far quicker, safer, and allows more transit options than a dangerous commute that would further clog Cedar Hills Boulevard and Highway 217 with hundreds more round trips per day.

Bottom line: The areas north of the Sunset Highway should remain in Sunset High School's area.

I am pleased that the newest Learning Map (dated 12/17 from your Committee's work of 12/3) shows our area as potentially remaining in Sunset's district (we're in SUN-03). Thank you for considering this the best option.

Since safety, distance, and neighborhood unity are core criteria, I urge you to use these criteria to place West TV within Sunset's boundaries. Good morning,

My children are currently zoned to attend Ridgewood Elementary, Cedar Park, and Sunset. Of course we choose our home with our childrens' schools in mind, however we understand that boundary changes have to happen to benefit all students in BSD and maintain equity across the District. With that in mind, I was glad to see the the priorities set forth by the superintendent for this process: Availability of Space, Neighborhood Unity, Student Body Configuration (I assume diversity - economic and racial - is a part of this).

I do not support the second map, recently proposed.

- 1. The demographic disparity between Sunset and Beaverton is significant. With each proposal, % of students on Free/Reduced lunch has increased at Beaverton and decreased at Sunset. I am delighted to send my children to a more diverse High School but please improve economic profile of the two schools.
- 2. I would strongly prefer that my children be able to continue the International Baccalaureate Program that they have started as Elementary Students. Our school (and the district) has made investments in this program. It is a rich part of our children's education and it should be added to student's education, not removed.
- 3. Looking at the district as a whole, it is disappointing to see Sunset become an overcrowded (114% capacity) school of advantaged students with better class and program options. This does not seem equitable. To briefly speak to the safety/transportation concern raised by some families: I don't want my High Schooler to have to drive on 217 to get to school either but a slight increase in commute time should not outweigh student body diversity.

I was happy to see that the initial Springboard proposal maintained community unity (by keeping many kids who would have gone to Sunset together at Beaverton) and diversity (at least the economic disparity is not as pronounced as compared to the 2nd proposal).

I hope my children will work hard and flourish in whatever school they find themselves and my family will continue to contribute to the school community and support its teachers. Please continue to work for a fair Boundary Proposal that is as equitable as possible in the significant factors affecting student success (not just how many minutes they have to sit in traffic).

Is surpassing the Sunset High School capacity feasible?

In the previous boundary adjustment meeting, there was a great deal of criticism about Sunset high school surpassing the number of students on the school capacity model. The school capacity model, which has not been published as part of this process, was verbally described as 35 students per classroom at 90% utilization. This might be a valid model for an elementary school where students and teachers are assigned to a specific class room but is not valid for universities with large lecture halls and open campuses. Lincoln High school, ranked as one of the best in Oregon, is currently at 200% capacity according to information I have heard. Before setting an incorrectly low limit on the school capacity, Sunset high school should carefully evaluate its actually capacity.

Historically (1970-2000), according to former students, Sunset high school student body has been much higher that it currently is today as well as much higher than it would be if there are no changes in Sunset high school boundaries. In fact, the portable classrooms at Sunset high school, where were unused were recently removed, probably to Westview or Aloha high schools indicating that Sunset has the space and facilities for additional capacity.

Additionally, the nature of teaching at Sunset high school has changed. With the advent of online courses like Kahn academy and increased availability of external classes for high school credit, a practice encouraged by Sunset teachers and counsellors, high school is changing from a lecture model to an open-campus and tutoring model. Sunset high school's period 8 (access tutorial) is an example of this. With the open-campus and tutoring model, a school can accommodate many more students than the fixed class room model predicts.

Finally, Sunset high school is routinely given the highest academic scores, according to the oregon department of education, of all of the fixed boundary schools in beaverton school district. If I wanted to provide the best educational opportunities for beaverton school district students, I would recommend expanding the number of students that attend sunset, not restrict it to an artificially low number based on an obsolete model.

The lesson from the Learning Map is that volume overcomes reason when it comes to winning a political argument. The vocal wedge group between Cornell and Hwy 26 have succeeded in shifting the proposed boundary so they can stay at Sunset. Meanwhile, neighborhoods that are closer and more economically diversified are excluded from Sunset. The south / east boundary for Sunset should be Jenkins Rd / Cedar Hills Blvd.

The arguments that are being used to advance the cause of the wedge group are being overplayed. Yes, traffic is an issue, but these same students are being shuttled back and fourth through that same congestion everyday for extracurricular activities. Yes, the IB program has many benefits, but only a very small percentage of students actually graduate with an IB diploma.

We are parents living in the Commonwealth Lake Neighborhood and our three children attend Ridgewood Elementary. We have concerns with the proposed modifications and boundary changes.

We deliberately chose this neighborhood three years ago for its strong sense of community and for Ridgewood Elementary, Cedar Park Middle and Sunset High schools so they could participate in the International Baccalaureate Primary Years Programme, Middle Years Programme and Diploma Programme, respectively. We chose our home very carefully based on its location and most importantly the schools for our three children.

Our concerns are as follows:

1) Beaverton HS is not an IB school. Sunset is an IB school. Our three children have been participating in the program since Kindergarten. The district has made a huge financial commitment to the Primary Years Programme (the Spanish and music classes have dedicated classrooms over the fifth graders)....now what? There is no continuity for PYP/MYP/IB and this does not make sense.

The boundary adjustment process is a great opportunity for the Beaverton School District to establish greater socioeconomic balance across the high schools in the district.

For example, the district average rate of free or reduced lunch (from the current boundary map) is 39%. The lowest rate in the district is a tie at 28% (11% below average) for Sunset and Southridge. The high school with the highest rate of free or reduced lunch is Aloha at 61% (22% above average).

The proposed boundary shows the low at 19% Sunset, (20% below average) and the high at Aloha at 62%, (23% above average).

Currently the difference between the highest and lowest free or reduced lunch rate is 33%. With the proposed boundary, the difference actually increases to 43%.

When the free or reduced lunch rates vary so widely between high schools in the district, all the students and communities across the district suffer the consequences. The obvious and immediate impacts for the low income schools are higher mobility rates, lower attendance, fewer available volunteers, and diminished fundraising potential for sports and activities. Negative consequences for the wider community include friction, hostility, intolerance and lack of diversity.

We need to level the playing field for all students across the district by bringing free or reduced lunch rates closer to the district average.

To Whom It May Concern:

I had the following questions and comments for the boundary committee after reviewing the Learning Map:

Based on my calculations (using 2014-2015 enrollment data) and BSD's total capacity figures, Westview is already over capacity (at 101% capacity use) while Sunset is at 92%, Aloha at 91%, Southridge at 87%, and Beaverton at 76%. Beaverton School District's projections show that Westview and Sunset will be at roughly 130% capacity use in a few years, so the need to adjust boundaries is obvious.

While the board must consider several variables, I would like to request that the board remember that the <u>status quo</u> represents household-school matches that were at equilibrium (i.e., we can assume that people were content with their assigned schools). Additionally, those households living towards the periphery of their school's boundaries would reasonably have greater expectations that they may be reassigned to other schools, so proximity of households relative to the current/old boundaries should also be considered and not just as it relates to distance. Boundary changes are hard but they do not need to be unnecessarily disruptive.

Taking one step back, the Springboard Map showed drastic adjustments to Sunset's boundaries. Similarly, the Learning Map shows what is still a significant shift north of Sunset's boundary. While it is necessary for a new school to have a domino-effect on boundaries throughout the district, it is illogical that Sunset, one of the farthest schools on the opposite side of the district, should have such a large side-step shift in boundaries. Both maps have Sunset assuming new areas while Westview does not take on any new enrollment areas. It is not worthwhile to fracture the Cedar Mill community to offset additions to Sunset's west.

Why do we not see a similar shift north for Westview's southern boundary (i.e., why are there only 44 students reassigned into Aloha from the current boundary)? While there are only under 100 Westview students being shifted east (into Beaverton), shifting Westview students into Sunset (and vice versa) does not address overcrowding (current or projected) at either schools, especially given the growth projected north of 26. These swaps from Westview into Sunset add 1,028 students into Sunset, which has a capacity of 2,203 students. What use is swapping enrollment areas between two very crowded schools? Why shift Sunset's boundaries north to only have it extend further west? Due to these east-west swaps (mainly from Westview into Sunset), Sunset ends up unnecessarily over capacity (114%) while Westview ends up under capacity (99%).

From an efficiency standpoint, it makes sense to shift Westview students into Aloha, Aloha into South Cooper Mountain (has greatest capacity in all scenarios), and shifting Sunset's students into Beaverton.

I live in the Waterhouse Neighborhood in Beaverton, and while we have been unable to attend your meetings and public hearings, wanted to send our thoughts, as we have stayed informed of the process thus far. While we understand there are many challenges and objectives you are hoping to balance, we would support either staying within the Westview school area, or moving into the Sunset area, as was initially proposed back in October.

Sunset seems the most logical given distance and transportation, where Aloha and Beaverton would provide extended commutes, which already begin early enough for high school students. I understand there is a revised map proposal (released to public on 12/17/15). I continue to be concerned that BHS is disproportionately disrupted by the boundary change process, in fact our free/reduced lunch at BHS goes from today's 49% to an alarming 59%. Meanwhile, Sunset goes from today's 28% down to 13%. I guess those more vocal families have influenced the committee? — I know those families have written the most letters and been on the news. I hope that the committee instead aims for better equity for the district's students overall and doesn't just listen to the loudest/richest voices.

I also continue to be concerned by the further erosion of the feeder school system. Jeff Rose saying that 'we'll figure out the high schools now and worry about middle/elementary later' is simply disingenuous. The decisions made today at the high school level will, in fact, dictate where the elementary and middle schools will feed to later. It is a closed system. Splitting elementary schools will have serious effects down the road that should not be dismissed as a later problem for someone else to fix.

I know my area of Beaverton best (I've lived here since 1976, attended all BSD schools, and have 2 kids at BSD), so will comment specifically on this little section: it would be best to preserve a feeder system in which Vose is not broken into multiple middle/high schools. Thus, I would hope that all of Vose would attend BHS or Southridge and not be split as the current proposal calls for.

And, finally a comment that is specific to my BSD kids. I hope that high schoolers who are caught in these painful transition years could be given the option to stay at the school where they started. My daughter, who will be in 10^{th} grade in 2017, wants to stay with Japanese at BHS and that language is not offered at Southridge. She also wants to do the AP program (again, not an option if she is forced to move to SHS). It would also be disruptive on a family level to have my son (a 2017 12 grader) at one high school and my daughter at a different one. This is a hardship for families in terms of Booster clubs, sports, clubs, and other activities/involvement — a hardship that hurts both the families and the district since it interferes with community building. Please be flexible during these transition years.

Hello and thank you for your work on the boundary adjustment process. I do not envy you all having to balance the wants and needs of so many groups.

My children currently attend William Walker Elementary and benefit greatly from the diverse student population. I am writing because it appears that many of the discussion documents being shared are creating very imbalanced schools and I think this is a large concern. The boundary adjustment team needs to consider the needs of those who are not being vocal in the process as well as those parents who have the resources and wherewithall to organize and provide feedback. I firmly believe that providing solid socioeconomic and cultural diversity to all schools is in the interests of all students in becoming well rounded, tolerant, and productive members of our community.

I would respectfully ask if the committee could work hard to identify boundary options that provide better balance in this regard and give this criteria the significant weighting that it deserves in their deliberations. While acknowledging that it is easy to color in a map from the comfort of a living room and with only one core criteria in mind... it strikes me that the new school at Cooper Mountain could draw from the area to it's North-East all the way up to Farmington and across one-block east from Murray and it would capture many more students shown as free and reduced lunch eligible currently proposed to Aloha and Beaverton. Sunset could try for a more North-South catchment, perhaps pulling the current Barnes-Elementary students down the Murray Blvd corridor and leave the Cedar Mill catchment to the west of Cedar Hills Blvd to Beaverton High. Boundaries for Westview could extend as far down as Baseline Rd.

As you continue your discussions, please consider solutions that aren't just tweaks to the springboard map if needed to get balance in the schools. Also, while some of the most vocal groups are current parents and students, remember that these changes are long term and accommodations made to suit short-term will have implications long into the future. Diverse catchments help expose and teach all our students about tolerance, community, and improve their social intelligence as well as helping to ensure that resources are more equitably available.

I realize how difficult the planning process is trying to realign so many boundaries and I appreciate all the time you are taking to listen to public comments.

I sent a letter to your committee regarding the springboard map. I am writing again because I now have greater concerns after the release of the revised map, moving West TV and Cedar Mill back to Sunset. I am a parent living in Vista Hills, my kids' current school attendance is Ridgewood, Cedar Park, Sunset.

- 1. I would like to know what criteria was used to determine that West TV and Cedar Mill should go back to Sunset?
- 2. Beaverton was once one of the top schools in the district, before Southridge opened. After Southridge opened, Beaverton lost many of its higher performing students and has struggled with performance since then. The school is currently ranked 138th in the state. My belief was part of this boundary adjustment was to help Beaverton rebuild. If you pull the West TV and Cedar Mill areas away from Beaverton and send them to Sunset, you will only increase the disparity between these two schools. Sunset will be below 20% free and reduced lunch and Beaverton will be over 50%. If equity is part of the boundary committee's criteria for setting boundaries, then this map does not make any sense to me. I think the map needs to be reworked to make the equity between BHS and SHS more equal.
- 3. I don't think it makes sense for the district to have no continuity in the IB program. The district has made a large investment into this program. Keeping Ridgewood, PYP program, aligned with Cedar Park, MYP program, and Sunset, IB program makes the most sense for the district. When the district invested in these programs, they clearly intended to see a continuity in the program from PYP, to MYP, to IB. Please consider keeping Ridgewood with Cedar and Sunset to continue their IB education.
- 4. The district has stated that Seniors will be allowed to stay at their current high schools. I am asking the committee to consider allowing the sophomores and juniors to stay at their current schools as well. Asking that many students to change high schools after they have already started is so disruptive and could have detrimental effects on the kids in high school during this change. The district definitely needs to consider having a three year transition period to allow students to finish at the school where they started. You can open the new high school to Freshman in 2017 and build each class from there.

Dear Superintendent Rose and the High School Boundary Adjustment Committee,

I am a parent of children attending Ridgewood Elementary and I am very concerned about the boundary adjustment process.

My first concern is that the entire community is being asked to make adjustments in our schools to accommodate growth in two very specific areas. I think the committee should be looking into ways to send students in the growing Bethany areas to whatever schools have space, or to the new high school. If you shift the map in the counterclockwise direction, rather than the current clockwise direction, fewer families will be impacted and many of the longstanding ties that communities have with their schools can be preserved.

If the committee decides that changes must happen and that Ridgewood Students will attend Beaverton HS instead of Sunset, then I would ask that you consider the following factors:

- Make certain that Beaverton HS offers the same rigor, opportunity and reputation as Sunset. Currently Beaverton HS does not rate as highly as Sunset. We moved into our area because of the specific schools and the IB program and it was our expectation that our children would attend a highly rated school with a full range of classes geared towards high achieving students. If the district is going to switch us, they owe the many families affected the highest effort possible to ensure we're attending a top rated high school.
- Consider equity among the students as you shape the boundaries. I think it is fundamentally important the boundary changes not create "have" and "have-not" schools.
- Keep middle school communities together. Currently you have Ridgewood, Cedar Mill and West TV students attending Cedar Park, playing on sports leagues and attending scouts together and building a sense of community in a myriad of ways. I would encourage the committee to keep these communities together.
- Implement the changes in a way that affects current students in the least way possible. While we do not currently have high school students, I am sure we will be affected by the elementary boundary changes, and I would like to see the district implement a policy where students who have already started in a school can finish their education at that particular school. You might also consider extending this to families, so that all children in a family can attend the same school. Once a family is invested in a school, you build pride in your institution and develop a sense of community. I thought the original boundaries in the October proposal were very good. We live on Cooper Mountain and associate with the area. We were pleased to see we had been originally mapped into the new school boundary. We felt that given the hefty taxes we pay up here, and our proximity to the new school, it made sense to put us in that district. We do not consider ourselves "Aloha." We never liked (and our kids REALLY hated) having to go down Miller Hill road (a road that is treacherous, and that the county is negligent in doing something about) to school every day. We felt it was a great safety improvement that the buses and kids would be going UP the road from the mid-point of Miller Hill and not down the dangerous side. It made sense and we were pleased. Also we were pleased because there has been a lot of building in this area over the last few years. These are expensive homes that pay a lot in school taxes. Mapping this area into the new school district should elevate the home values (which still are NOT at 2007 levels) and thus raise taxes (benefiting the county and in part the schools). Then we were completely discouraged when we saw the modifications. It seems like the changes were done to appease some very vocal minority -- and it doesn't even make sense since it has thrown the numbers off! So as you're finalizing the boundary map. Consider these options. We feel that mapping our area (South of the curve towards the top of Miller Hill road -- where much building has been allowed with little consideration for infrastructure or safety, up the hill and down to the new high school) will help with safety, and home values/increased taxes.

With just one more meeting left before the boundary advisory committee provides its recommendations, I would like to provide a score card to summarize the process and results:

- 1)) Of the total of 4*10^874 possible boundary configurations, 2 have been considered.
- 2) Of the 8 published objectives of the boundary adjustment process, only 2 have been quantified (available space and student body configuration)
 - 1. 10% available space
 - 2. Safety
 - 3. Proximity to school
 - 4. Transportation
 - 5. Neighborhood unity
 - 6. Student body configuration
 - 7. Staffing patterns
 - 8. Minimize students transitions

Neither of the proposed solutions is optimal for any of the criteria.

The the relative importance of these criteria missing criteria (e.g., education quality), has not even been discussed because of the archaic processing being followed.

I do appreciate the time and effort make by the boundary adjustment committee but the process they have been required to follow (and complained about universally and repeatedly) is not able to find the best solutions.

My recommendation is for the community and committee make as clear as possible to the school board and beaverton school district professional staff that the process being followed is not satisfactory for one of the most technologically advanced areas on the earth. There are many good solutions to this problem but the existing process will not find them.

In the previous boundary adjustment meeting, there was a great deal of criticism about Sunset high school surpassing the number of students on the school capacity model. The school capacity model, which has not been published as part of this process, was verbally described as 35 students per classroom at 90% utilization. This might be a valid model for an elementary school where students and teachers are assigned to a specific class room but is not valid for universities with large lecture halls and open campuses. Lincoln High school, ranked as one of the best in Oregon, is currently at 200% capacity according to information I have heard. Before setting incorrectly low limit on the school capacity, Sunset high school should carefully evaluate its actually capacity.

Historically (1970-2000), according to former students, Sunset high school student body has been much higher that it currently is today as well as much higher than it would be if there are no changes in Sunset high school boundaries. In fact, the portable classrooms at Sunset high school, where were unused were recently removed, probably to Westview or Aloha high schools indicating that Sunset has the space and facilities for additional capacity.

Additionally, the nature of teaching at Sunset high school has changed. With the advent of online courses like Kahn academy and increased availability of external classes for high school credit, a practice encouraged by Sunset teachers and counsellors, high school is changing from a lecture model to an open-campus and tutoring model. Sunset high school's period 8 (access tutorial) is an example of this. With the open-campus and tutoring model, a school can accommodate many more students than the fixed class room model predicts.

Finally, Sunset high school is routinely given the highest academic scores, according to the oregon department of education, of all of the fixed boundary schools in beaverton school district. If I wanted to provide the best educational opportunities for beaverton school district students, I would recommend expanding the number of students that attend sunset, not restrict it to an artificially low number based on an obsolete model.

Hi,

Thank you for the tremendous amount of work being done as part of this boundary adjustment process. Also thank you to the district for allowing the public to voice their comments and feedback regarding the same.

I have a couple of inputs that I would like to highlight -

- 1. Elementary school years are formative years of a child. They start to acquire social skills and form friend circles.
- 2. Middle school years are the most crucial years in terms of character development and also acquiring academic skills and study habits needed to succeed in high school years. This is also the time when great bonding of friendships, teams, circle of influence etc.. are seen. Students continue to form that trusted circle and socially they are more at ease within this circle.
- 3. High school is more of honing the skills, strengthening friendships, positive outlook towards future etc. Social, academic and peer pressure is at its height at this point of time. Adolescents also go through a lot of turmoil in addition to physiological and external factors. So having close friends, trusted members to go through this difficult period of time is very essential to emerge successful.

Given the above broad classification, it is very essential to keep kids from a middle school intact and going to the same high school. Let us take for example one of the earlier boundary proposals that did not address this concern -

- 1. Elmonica --> Five Oaks --> now being split across Westview and Sunset. Students who have had a bonding for 8 years are thrown to a completely different school (Sunset) away from neighborhood friends and social circle they are used to. This needs to go back to Westview to minimize further turmoil in students at the high school level.
- 2. Oak Hills --> Meadow Park --> currently going to Westview, but majority of students are currently in Sunset. So students from Meadow Park should be kept together and fall under Sunset instead of Westview.

I would request the district and the board to consider the following requests -

- 1. Keeping students from a middle school going to the same high school is very essential to ensure continuity and success.
- 2. Also it would be best if grandfathering is allowed for currently enrolled high school students to continue in the same high school if they are affected by the boundary changes. This will cause less disruption to the student and after all the district's success is measured by the success of their student population and any major changes in this area would only cause undesirable effects. Sophomore and Junior years of high school are very important in a students life and it forms the basis for their future. Disrupting and causing trouble to the kids during these years by having them more and start from ground zero in all aspects is not desirable.
- 3. Public is not averse to changes, but changes should also be in such a way that they are beneficial to both the district and the community. For example, if the proposed changes after taking into consideration all the pros/cons is implemented such that it will be in effect with incoming freshmen then it will be better received by the community as this does not lead to disruption for any existing high school student. Parents and students will already be aware and have enough time to let the decision sink in and take any action as needed.

One thing that would have been better is the bottom up approach, to start from elementary and then adjust middle school and high school, as this would have given a better opportunity to keep the school community intact as they

pass from one stage to another.

I have spoken to a lot of parents and the above is a collective representation of our inputs to the district. I hope the district would give due consideration to the above and help serve the welfare of the students.

Dear Dr. Rose,

I am writing to express my opposition to the proposal to force high school students to change schools during their high school experience. It is understandable that with a new high school being built boundaries will need to be adjusted. However, it is totally unacceptable to disrupt a student's high school experience. If this proposal goes forward, our oldest child will spend two years developing relationships with other students, teachers, coaches and counselors, only to have to start all over again. It will be hard to blame students in this situation for developing a "short timer's attitude" when they know they will be forced to move. One's high school experience is not simply taking classes. It's being part of something that is much bigger than one's self. It's being part of a community. Students that are not allowed to experience this for four years are cheated out of an experience that many people treasure throughout their lives. Further, you cannot manufacture this experience; it takes time. Moving students in the middle of their high school experience denies them the opportunity for a true high school experience not just at one school, but two. This proposal will cause the students that are to be moved to be in an "outsider" role at two different schools - not fully committed to one they are being forced from, and not given the time to fully become part of another. The social disruption forced upon students by this proposal is unconscionable.

Starting over will create missed academic opportunities. Last Spring we spent a lot of time creating a four-year academic plan for high school. This plan is geared to allow for the opportunity for an IB diploma. The school we are slated to move to is not an IB school, but an AP school. Two years of preparation will be for nothing. Further, we will have missed the opportunity to have taken at least one AP class. That's a missed opportunity for college credits. Having your academic plan changed halfway through high school is unacceptable.

As a student-athlete, my child and many other student-athletes will suffer under this proposal. Student-athletes will spend up to two years establishing themselves in one athletic program, only to be moved to another where they will be all but unknown to their coaches and teammates. Competing in high school athletics is a special thing, and just like everything else in one's high school experience, it takes time to fully become part of that experience. It takes time to establish oneself with coaches and teammates. Being forced to do this at two different places during the short time you spend in high school is unfair.

I have spoken of the social, academic and athletic impacts of this proposal, but there are two other issues that involve them all. For many students, simply starting a new school is an extremely difficult challenge. The anxieties that can arise with starting at a new school can be overwhelming for some. This creates negative effects in the social, academic and athletic lives of students and must not be overlooked. For another group of our students', school is one of the few places they can find stability. I find it hard to believe that any school district would purposely create this kind of disruption to students' most in need of stability. The more a student changes schools the more difficult life becomes for them. I imagine there is plenty of research to support this. Please do not create a situation that makes high school more difficult, especially for those who already find it exceptionally challenging.

I noticed that one of the two objectives proposed by you at the beginning of this process was to "minimize transitions for students." In the spirit of this objective, please reconsider the proposal to disrupt students' high school experience. High school can be equal parts difficult and tumultuous as well as positive and memorable. If this proposal moves forward, it will turn the high school experience for many students into one that is difficult and tumultuous with little that is positive and memorable. Let students' finish where they start.

Current School Boundaries: Ridgewood ES, PYP, Cedar Park, MYP, Sunset HS, IB

To Whom It May Concern:

Respectfully and in appreciation of your commission, I am writing in regards to the tumultuous/monumentous job of redistricting the high schools in Beaverton School District. There are multifactorial levels that will affect all Beaverton high schools, neighborhoods, students, families, busing routes and traffic flows with the proposed district changes. However, one factor that gravely appears to be overlooked is the well-being of the incoming 2017/18 junior class.

As parents of 5 children, we have experienced change and find that more often than not children are resilient. However, we have experienced first-handedly one of our children transferring as a junior and the extreme stress that disrupted personal health, focus, academic performance, teacher relationships, and the entire family. This child was denied entrance to the Naval Academy due to lack of a long term relationship with a junior teacher who could write a strong letter of recommendation! Although our current middle schooler will now attend a different high school, we appreciate the fact that all four years will at least be at the same school. Our concern is for our current freshman, and all freshman, who will be required to move schools at the beginning of their pinnacle year – junior year, and the effects this will have on them.

We have experienced that junior year is a highly intensive year to focus, produce and create successes in academics, sports and extra-curricular activities. Academically, it is a very intense year with Pre-SAT, SAT/ACT testing as well as starting or continuing IB/AP programs specific to the school. It is a key year for establishing grades and solid teacher relationships for excellent recommendations to college. (Academics are not as intense the first two years of high school just for the reason of easing the students into a new environment and preparing them for the intense junior year. By junior year, the students are capable of focusing more on the academics due to familiarity and comfort in knowing the building, classmates, teams, teachers, coaches and routines.) Sports continue to be a challenge, yet some comfort is established in the fact that athletes know the school's specific coaching style, expectations and the team plays built upon the foundation of freshman/sophomore years. The junior athletes are recognized, trusted and called to be leaders by JV/Varsity teammates and coaches. Juniors have a greater understanding of which extra-curricular activities they have interest and have often already established the relationships necessary for success junior year whether that be in student leadership, clubs or specific groups formed with a staff member overseeing it. Students and athletes have strived all freshman and sophomore year to establish a healthy reputation and relationship amongst their peers, teachers and coaches. Basically, the school system is set-up to help students familiarize and find grounding before entering the upper class years where outside distractions are meant to be less and opportunities for success are in place.

Emotional support is what juniors require most. (Is it avoidable to create unnecessary extra stress that will heap on top of the already extremely stressful junior year?) How will students transfer from a prepared IB program to an AP program without a gap in scheduling plans? How will the counselors handle letters of recommendations with students just as new to them as a freshman? How will the BSD school rankings perform in Pre-SAT, SAT/ACT tests and in Merit Scholarships awarded if juniors are asked not to only perform but to do it in a new school and with all the changes a freshman experiences? What results does the School District expect with these potential chaotic additional demands being placed on the students during their critical junior year? Again, is this avoidable?

We are proposing to allow juniors in the Beaverton School District the same choice as the seniors – let the students have the option to choose to stay at their current high school or to move to the newly assigned school. This option would allow the juniors that have fully invested their first two years in preparation to reap the benefits from which they have sewn. This keeps emotional stress at bay and allows the Beaverton School District to maintain great rankings in testing and awarded scholarships. The investment of teachers, students, families, and the Beaverton School District would be protected through the option of allowing students and families to choose which school (current or newly assigned) is best for them and their future.

I am a student at Sunset High School. I am a freshman so the new school and boundary lines are projected to affect me. I live in the Ridgewood neighborhood. After these new boundary lines are put in place I am supposed to go to Beaverton High School, and although I have no problems with BHS, I have a strong desire to stay at my current school. Dear Boundary Adjustment Advisory Committee and BSD technical team supporting the committee's work,

We are parents in the north end of the district and are concerned that the district and boundary adjustment committee may inadvertently overlook potential students from residential development growth areas when using the Springboard Proposal map and Learning Map in the boundary adjustment process.

It is our understanding that only new developments approved/ planned as of September 2014 are included in the committee's attendance projections and maps, though additional developments have been approved since then and would very likely add students to high school roles in the next 5 years. We are also aware that quite a bit more residential growth is in the planning stage in areas such as North Bethany. Though it was suggested at the November 12, 2015 boundary adjustment meeting — "One way to address that concern is to leave a capacity buffer for additional future enrollment" — it seems neither this strategy nor others is being used to address the likely additional growth, resulting in misleading representations of capacity at some schools on the Springboard Proposal and Learning maps. This is particularly problematic given the short 5-year planning window - as many growth areas seem poised to grow not only in the next 5 years, but also for years after th at. And, also troubling, is that high capacity utilization has been proposed via both the Springboard Proposal and Learning Map for Westview and Sunset (97-114% utilization), even before this additional growth is addressed.

We hope the committee will soon include adequate buffer capacity for additional planned residential growth in its calculations and deliberations, in order to prevent detrimental overcrowding at some schools in the next 5 years, and beyond.



Current attendance area: Aloha HS

The latest learning map has Aloha over capacity and Cooper Mountain under capacity. I recommend assigning the grids south of Gassner Road (currently in the ALH3 allocation section) to the Cooper Mountain school.

Gassner is a natural separation road. The neighborhoods north of Gassner are more fully developed (have amenities such as city sewer) and have more dense housing than the neighborhoods south of Gassner. The area south of Gassner, circled in the picture below, was identified by Metro as the "North Cooper Mountain" area in recent planning meetings for the South Cooper Mountain development process, and we were included in the planning process. The residents consider themselves part of Cooper Mountain. Granted, the assignment wouldn't impact many students, but I think it makes sense for those neighborhoods to be assigned to the Cooper Mountain school.

That said, my son will be a junior when the new high school is scheduled to open, and since he currently attends Aloha High School he doesn't want to switch schools (for many reasons). We live in that area south of Gassner Road. So while I think it makes sense in the long run for the neighborhoods south of Gassner Road to be assigned to the Cooper Mountain high school, we're hoping the transition process for the new school will allow for some flexibility the first couple years.

School being built in South Cooper Mountain, where there is currently no growth, rather than Bethany area. School over 50% over budget. Covered wetland to build it. Acquiring land from Hillsboro to get students to go to this school.

Spending a lot of \$ to re-build schools that add very few extra students. Why?? Poor planning and use of funds.

Have not been addressing the need to grow option schools despite that most are way over-subscribed. Option schools are the most equitable. They are not dependent on boundaries, socioeconomic free/red lunch, test scores: they give all students free choice to pursue the program that fits them.

Is the plan to cut schools that bring down Sunset's and Westview's stats and keep Sunset HS elite with regards to free/red lunch stats and test scores at the expense of other schools?
