To the members of the Boundary Adjustment Committee,

As a member of the Raleigh Hills K-8 Community, I ask that you put the 52 Raleigh Hills K-8 students you have moved to Southridge HS back at Beaverton HS and keep our tight-knit community together. We have three concerns about your current proposal:

1)Community: Raleigh Hills K-8 is a small, but very special school. Many kids attend from kindergarten all the way through the 8th grade (9 years!!) and make lots of wonderful friendships during that time. Our neighborhoods are very close with families sharing time at the pool, park, kids walking/biking to each other's houses, after-school activities & enjoying the Fanno Creek Trail. Your proposal takes 52 children away from most of their friends after all their years together and we ask that you focus on your priority to keep communities together and allow these kids to attend Beaverton HS with their friends.

2)Safety: Traveling from the Garden Home neighborhood to Southridge would require using Hall Blvd and/or Scholls Ferry. These are very congested roads that compromise the safety of our kids, when traveling to and from school. Traveling to Beaverton HS uses roads that are significantly less congested and will increase the safety of our children, when they are transported to/from school.

3)Capacity Utilization: Southridge HS has a higher capacity utilization than Beaverton HS. Moving these 52 students to Beaverton HS will provide some alignment of the utilizations and still allow for enrollment increases over the coming years.

We understand that shaping the future school boundaries is clearly not an easy task and, as Dr. Rose commented on Tuesday night, you have been given priorities that are often conflicting and will require compromises to satisfy. We appreciate that your challenge is to find a balanced recommendation that will support the stated priorities for the boundary adjustment. We ask that you look at our concerns and reconsider your decision to divide our strong community. Please keep the 52 Vista Brook/Garden Home RHS K-8 students at Beaverton HS with their friends.

I would also like to add that at this end of Oleson road we live on the dividing line between the Beaverton and Tigard School District. This boundary change will essentially exclude us from neighborhood communities on both sides. The teen years are difficult enough without being separated from the friends you have had for nine years as you enter high school. I was appointed legal guardian of my two relative foster children three years ago. They both had to attend two different schools for Head Start before entering Raleigh Hills K - 8. Building secure relationships is very important for their development. I feel that separation from their peers in the years to come will have a negative impact on their social, emotional and academic development. Please consider the effects this separation will have on the 52 students currently attending Raleigh Hills.

To the members of the Boundary Adjustment Committee,

As a member of the Raleigh Hills K-8 Community I respectfully ask that you put the 52 Raleigh Hills K-8 students you have moved to Southridge HS back at Beaverton HS and keep our tight-knit community together. I have three concerns about your current proposal:

1) Community: Raleigh Hills K-8 is a small, but very special school. Many kids attend from kindergarten all the way through 8th grade (9 years!!) and make lots of wonderful friendships during that time. Your proposal takes 52 children (1 in 4 from RHS) away from most of their friends after all their years together and I ask that you focus on your "Neighborhood Unity" priority to keep communities together and allow these kids to attend Beaverton HS with their friends.

I have very specific concerns about the proposed boundary on SW 90th Avenue south of Scholls Ferry Road that cuts the Vista Brook subdivision and neighborhood in half. As you can see in the photo below, the proposed boundary is a line across a roadway, not at a roadway.



This line follows Fanno Creek trail to Vista Brook park, a gathering place for our neighborhood – ironic since this proposal aims to separate our neighborhood. The Vista Brook subdivision not only has a park within its boundaries, it also has a pool where our children spend many hours during the summer, along with many others from the Raleigh Hills K-8 community. It would be a shame to separate a subdivision that creates community. The picture below was taken more than 5 years ago. 11 of the 20 children proposed to be separated in the Vista Brook subdivision are pictured below. They have spent the last 10 Halloweens together, the last 10 years at the Vista Brook pool together and countless hours together on various sports teams. I urge you to reconsider dividing our neighborhood along the path to our neighborhood park and to please utilize arterial roadways for boundary breaks (Garden Home at the south end of our neighborhood, or even further south at Hall Blvd to include all of the RHS K-8 community.)



<u>2) Safety:</u> Traveling from the Vista Brook/Garden Home neighborhood to Southridge would require using Hall Blvd and/or Scholls Ferry. These are very congested roads that compromise the safety of our kids when traveling to and from school. Both have intersections in the Top 5% of the most dangerous intersections in the Portland Metro area (see ODOT SPIS sites, http://www.oregon.gov/ODOT/TD/TDATA/gis/docs/STIPMAPS/spisReg1.pdf.) Traveling to Beaverton HS from our neighborhood uses roads that are significantly less congested and have fewer dangerous intersections, keeping our kids safer when they are transported to and from school.

<u>3) Capacity Utilization:</u> Southridge HS has higher capacity utilization than Beaverton HS. Moving these 52 students from Raleigh Hills K-8 to Beaverton HS will provide some alignment of the utilizations and still allow for enrollment increases over the coming years.

I understand that shaping the future school boundaries is clearly not an easy task and, as Dr. Rose commented on Tuesday night, you have been given priorities that are often conflicting and will require compromises to satisfy. I appreciate your challenge in finding a balanced recommendation that will support the stated priorities for the boundary adjustment. I ask that you look at my concerns and reconsider your decision to divide not only the Vista Brook neighborhood and subdivision, but also our strong Raleigh Hills K-8 community. Please keep the 52 Vista Brook/Garden Home RHS K-8 students at Beaverton HS with their friends.

Dear Boundary Committee,

Students from the West TV Elementary neighborhood are meeting nearly all the criteria as selected by BSD to remain at Sunset High School. These are: Proximity to school, safety, transportation, neighborhood unity, staffing patterns, minimize transitions for students. Why are they being sent to a faraway school on a treacherous route during the busiest times of day?

With these students heading to Beaverton High School instead of the much closer Sunset High School, they will have a longer, environmentally-damaging bus commute that will require them to leave earlier to anticipate the daily traffic on the 217 freeway. When other progressive school districts like Seattle are adjusting bell schedules to provide high school students with more sleep, the Beaverton School District is needlessly taking it away. Sleep is essential for the developing adolescent brain.

Students wanting adequate sleep would need to commute themselves but this route is more dangerous, crossing railroad tracks, navigating Portland's most dangerous intersection (Highway 26 and Cedar Hills Blvd) and/or joining the scrum of agitated commuters on highway 217. Since teenagers are five times as likely to have car accidents, this is a dangerous proposition you are making for our children.

The Beaverton School District community of parents, students and taxpayers are seeking common-sense solutions to the rapid growth in our area. The BSD is harming this coalition of the formerly-willing by not allowing parents to give meaningful input in the process. Other than this "junk drawer" of submitted letters, there have been very limited ways that the citizenry have been allowed to participate. Often, parent concerns have been met with accusations of snobbery or elitism. I applaud the innovative dads' whom created the mapping app that allowed the public to participate in the process. This tool finally introduces fact-based and quantitative reasoning to the BSD boundary discussion.

It is especially galling that the West TV Elementary neighborhood is meeting your criterion but still they are being required to move. The question remains: are you planning to follow your own boundary guidelines or is this whole charade to obviate the mission of forced bussing to extract more Title 1 funds from the Federal Government? The process that Superintendent Rose and his consultants have established, one that doesn't allow parents with a stake in the outcome to meaningfully participate, is surely harming the warm relationship that BSD had with it's previously generous supporters.

Frankly, this boundary process feels like a "done deal" that was created before the process even began and that we are all just going through the motions. I do not think it is too late to set aside current plans to complete a qualitative and qualitative analysis that your stakeholders require and deserve. By doing this you will have a more authentic outcome without alienating your supporters and squandering the formerly strong reputation of the Beaverton School District.

Dear Boundary Advisory Committee-

We live in Oak Hills, and our family walks and bikes everywhere. We walk to and from school nearly every day, we walk to donuts on Saturday mornings, and on good days, we ride everywhere from the library to dinner. So, throughout this boundary process, you can imagine I had been thrilled to see the maps showing the Oak Hills neighborhood going to Sunset. This would mean our kids in Oak Hills could walk to high school. We could easily walk to and from football games and after-school extracurricular activities. We would feel like a part of the local community where we buy groceries, go to the library, and spend so much time.

I was disappointed to see that at the last meeting, the Oak Hills neighborhood has been shifted back to Westview. I understand you have a long and complicated list of things to look at when assigning neighborhoods, but I wish you would prioritize proximity to the school. We hear Sunset's band during football games, as we are only 0.7 miles away. If Sunset were an elementary school we would be walkers. How does it then make sense for the district to pay to bus our kids to a different high school? Or from a safety perspective, should we be adding more brand-new drivers to the ever-increasing traffic congestion in all areas around Bethany and north of Hwy. 26? This letter is *not* about choosing one great school over another great school. This letter is about choosing boundaries that make more sense for your students, and more sense for the communities surrounding your schools.

I completely understand the calls for school unity, as I too would love for our school community to stay together, but those calls seem premature given that none of us know what the future will hold with regard to as-yet-undetermined elementary- and middle-school boundaries. I understand a transportation and safety study was not done for this change in high school boundaries. But I do want to call your attention to the fact that by having West TV community members and students drive to Beaverton High School, this will severely impact traffic in front of St. Vincent's Hospital on Barnes Road. Most people exiting our West TV neighborhood travelling to Beaverton High School via 217 will pass in front of the hospital. I believe this dramatic increase in traffic could have a major impact on emergency vehicles entering and exiting the hospital, and something that should be considered before a final decision is made. I have not seen anyone else mention this.

As you might know, our neighborhood exits onto Cornell Road on our way to Sunset High School, and thus has no impact currently on St. Vincent's Hospital traffic.

Dear Principal John Huelskamp and Committee Members,

My sister in law told me a story of when she worked for Principal Huelskamp as a teacher. As an exercise of engagement, he challenged the teachers to go out into the neighborhoods and understand them. To know where the kids in the district live and what type of neighborhoods they are a part of. I couldn't agree more.

Principal Huelskamp and respected board members, I ask for you to heed this advice! I challenge you to acknowledge the body of evidence below, walk my neighborhood, and continue to land on the conclusion that my neighborhood does not belong in the Cedar Mill Neighborhood.

I am an Engineer so I'll get to the points and facts. Simply stated, I am very concerned that the committee is overweighting equity and incorrectly weighting the stated Primary Criterion.

REGARDING BOUNDARY CHANGES VS TRANSITION PLANS

My kids are illiterate... that is to say they are age 0, 2, and 3. Although they are not currently in the school system they soon will be. I moved into the West TV Elementary from the Elmonica area, prior to that, Seattle. I myself am a graduate from Cedar Mill Elementary, Cedar Park, and Sunset HS. For these reasons I am very concerned with the proposed Boundary changes, and do not support convoluted transition plans.

WITH REGARDS TO EQUITY:

Please understand that as the son of immigrant parents and the father to three minority children, I am very concerned with Equity. While honorable and well intentioned, I believe that school boundaries are fundamentally the wrong trigger to create equity in neighborhoods. That responsibility is not the responsibility of the committees, but rather on city planners. It is a fallacy to think the issue of Equity/Diversity is as simple as moving a boundary line. This is short term thinking and short sighted. As you have probably heard, many people have chosen to move into our neighborhood for school district, and just as easily many will also move out due to school district.

Numerous scientific articles highlight the ineffectiveness of school boundaries as an effective means for creating diversity. To quote a few:

"Some scholars and policymakers contend that such (income based integration) policies will also reduce racial segregation. ...
The article finds that, in general, income integration is no guarantee of even modest racial desegregation."

Implications of Income-Based School Assignment Policies for Racial School Segregation, Joint study Stanford, UCSB, UCDavis

WHAT HAPPENS IF WE TRADE OUR PRIMARY CRITERION FOR EQUITY

Policy JC, School Attendance Areas clearly states;


"In planning and developing an adjustment of attendance area boundaries, the superintendent first shall consider the following primary criteria: availability of space, proximity to school, safety, and neighborhood unity."

At this point (10+ meetings), the committee has clearly represented it's intention of excluding the West TV Elementary area. Despite being one of the loudest and most active participants in this public "process" (/public ignoring), we have yet to see any concessions in our area. **Three of the Four Primary criterion** have been traded for 1 Primary Criterion and consideration to "student body composition". The result is a **disastrous geographic divorcing** second only to the folks in the Waterhouse neighborhood. This is not an emotional stance, but an objective one.

Availability of Space + Equity VS Proximity to School, Safety, and Neighborhood Unity WITH REGARD TO NEIGHBORHOOD UNITY (150 yrs!)

This is a map of my Friends, Family, Church, Grocery Stores, Hardware Store, Library, Bank, etc...






WITH REGARDS TO SAFETY AND PROXIMITY AND TRANSPORTATION

Safety and Transportation in a Nutshell:

- Proximity: 3.1 miles (Bike Accessible) vs 5.1 miles (Drive Only)
- Cornell and Leahy (Residential roads) vs Hwy 217, 2 Major Interchanges
- ODOT traffic report data states HWY 217 is more dangerous route
- Transportation cost for buses is greater and more dangerous

As an Aloha parent, I want to chime in with my thoughts about the boundary decisions. It looks like a complicated and confusing puzzle, and I appreciate the difficulty of the committee's task. I want to speak on Aloha's behalf about my family's hope that student diversity will be a priority in these decisions, even if it means busing from greater distances. Our neighborhood has been considered for South Cooper Mountain's boundaries, and we feel strongly that whether we stay at Aloha, or move to the new school, a more even distribution of economic and cultural diversity is in each school's best interest.

My oldest son graduated from Aloha in 2013, with a 4.4 GPA, 34 on the ACT, and a full tuition scholarship to BYU, where he started with a year and a half worth of credits, thanks to Aloha's AP program. This was a reserved boy who did not stand out in elementary or middle school, but became accomplished and self-assured at Aloha through sports, clubs, and academics. My current junior son is on a similar track. So I can't say enough good about the opportunities at Aloha. I have an incoming freshman in the fall; she is thrilled with the vast selection of classes at Aloha, and a current 6th grader who hopes to follow in her siblings' footsteps as a Warrior. Both of these daughters are in Summa, and many of their friends are heading to Jesuit, which we consider jumping ship. Public school has served us well.

Hello,

Thank you for your work with the boundary adjustment. I was very impressed with the way the meeting was handled on Tuesday. I felt that the committee was listening and that my neighbors and I were heard. Below is a repetition of the comments that I made in that meeting.

My name is Sam Behunin. I live in Beaverton at 280 SW Delta Drive in the Blueleaf at Waterhouse neighborhood right next to Elmonica Elementary. My neighborhood has been in Westview boundaries since that school was built. In the various boundary proposals, our neighborhood has been bounced back and forth to three different high schools – Westview, Sunset, and Aloha. In the most recent proposal, we were carved into the Aloha boundaries. Being on the border as we are, it is understandable how we might get tossed back and forth to achieve the desired numbers and to balance statistics.

However, my neighbors and my family are not just numbers. The fact is that the community in which we live, work, recreate, and worship is located in Westview and Sunset boundaries. Both of these high schools are a mile closer than Aloha high school. But it's not just proximity that makes us part of Westview and Sunset, there is a logical and existential reason that our community extends to the north of my neighborhood and not to the south.

Directly south of our neighborhood (toward Aloha high school) is a power substation, a huge nature park, acres of greenhouses, retail space, storage units, and not just the max line, but also the Trimet garage. We are literally separated from Aloha neighborhoods by a wide buffer. In fact this buffer is clearly visible on aerial maps as a large green swath of the least populated space in the entire district. Let me be clear; there simply is no more obvious natural boundary in the entire district.

This green/commercial/industrial space shapes our community. It will make the integration of my neighborhood into the Aloha community extremely unlikely if not impossible. And, moving my neighborhood to Aloha will isolate us from the community we actually live in. At the meeting on Tuesday, our neighborhood was referred to as the blue peninsula. That is not quite accurate. The Baseline Buffer actually separates Waterhouse from the Aloha High School boundary, making my neighborhood, not a peninsula, but an island.

I respectfully request that you consider my neighborhood not numerically, but functionally. Allow us attend school with the community of which we are a part. Please assign my neighborhood to Westview or to Sunset.

I have three kids in the Beaverton school district, two attending Raleigh Hills as option middle school kids and one attending Hiteon Elementary, our neighborhood school. My older children will likely have a choice to make when the new high school is open because they have parents in both the Southridge and South Cooper Mountain area. I tell you all of this to let you know that I don't necessarily have a dog in this fight as far as preference and we would go wherever we were told anyway. Both of my older kids attend a school out of our neighborhood now for the experience of attending a new school through the option school program. My now 8th grader couldn't wait to go to a new school in 6th grade and checked the mail daily to see if he made the lottery. He was elated to make it even though he knew it meant leaving his friends and community behind. My 6th grader was very reluctant to leave his friends and join his big brother this year but I asked him to tr y it and if he didn't like it, we would change schools next year. He has blossomed this year, went from not knowing one kid besides his brother to having many friends, and can't imagine going anywhere else. I tell you this to ensure you that kids will adapt regardless of the outcome of this process. Please do not let the emotional pleas sway you in making the right decisions for the district overall. Every neighborhood and school is a community but kids join and leave communities all the time. It's not the end of the world although I'm sure many have said it will be. Change is inevitable and the only thing certain in life. Learning that young isn't a bad thing at all.

The Raleigh Hills community is up in arms because they don't want to go to Southridge, the Murrayhill community is up in arms because they thought they were going to attend the "elite" new high school and some may not. I implore you to block out the noise and make the decisions that are right for the district as a whole, not the individuals that are yelling "not my kid", "not my neighborhood", "not my school". I promise you three years from now these same people, having made a move will not feel this strongly. Their kids will have adjusted and went about life like kids do. I have 2 kids in BSD. 1 in middle school at Conestoga, 1 in elementary school at Hiteon.
I also went all 12 years through the BSD, placing my kids in this district came with great pride.

I recognize the struggles you are faced with in opening of the new high school. All of the feedback you're receiving can't be easy. I commend the district for allowing the families to give their input. I believe you've made great strides in listening to those families. I have not been able to attend the meetings nor have I given feedback. We live near Southridge so the boundary change won't ever be of concern for my kids, directly.

My daughter will start at Southridge in the Fall, 2016. The following year the new HS will open. I understand the plan today is to open the new HS with 9th grade only and 10th grade is still up for consideration. I want to strongly suggest that 10th grade year NOT be an option. This is the class that will be the most affected by this change in enrollment, I don't think this will be a positive affect. HS can be hard enough, breaking apart ties kids have developed after their first year and bringing in new students will create a weaker support system at the schools. There is something to be said for the majority of the students spending all 4 years together. I think this consideration is a huge mistake for the district.

My belief is enrolling the new school in 2017 with just 9th graders is by far the most streamlined process that will bring a larger success rate for all the students affected by this change, both direct and indirect. Keeping that class together for 4 years, and continuing that process.

Hi. My name is Katie Briggs and I am the mother of both an eighth grader and a sixth grader at Highland Park Middle School. Starting with their elementary school education at Fir Grove, my kids have grown up as "Future Beavers," thinking they would attend Beaverton High School. They have played in Beaverton Youth Sports, attended activities at Beaverton High School, and now my eighth grader is attending Beaverton for her math class and has played at basketball games with the BHS Pep Band. My daughter considers herself part of the BHS Community. She is heartbroken that Beaverton will be her school for only one year, and we, as a family, are disappointed that this will not be the high school home we had anticipated and envisioned.

But from the start of this whole process, we understood that once ground was broken at the South Cooper Mountain site, boundary shifts were inevitable, and that we might be affected by these shifts. And while we would be ecstatic to hear that our Fir Grove/Highland Park Community would get to stick together and become Beavers as we have pictured ourselves being, we understand that in order to make things work on many levels, this may not be possible. Here is what we cannot understand...

Why would a school district so invested in their children even consider moving children from one high school to another after one or two years at the school? Why would adults, who were once fourteen and fifteen years old themselves, experiencing the ups and downs of adolescence, think that it is okay to take a child away from a place they have recently moved to and started to put down roots, forcing them to start again in so many ways? Our (and when I say our, I speak for the parents of BSD children) kids are involved not only in academic tracks, but in sports, music programs and social clubs. They form relationships with teachers, coaches, mentors and other school staff. And the impression many parents are getting from the district is that these things are of little concern. It feels as though the attitude is that it is okay to make children who only a year before (for the class of 2020, or two years before for the class of 2019) transitioned from middle school to high school transition all over again. In addition to their academic lives being disrupted, these kids will be affected in so many other ways: They will be playing for a different team and/or with a different band, they will need to seek out adult support from a completely new set of faces, they will have to learn a new school "culture" and the routines/traditions that go along with that culture... The list goes on.

Yes, our family would love to hear that we will be Beaverton Beavers after all. But more importantly, regardless of whether our kids are Beavers or Skyhawks, it is imperative that they are only ever one of the two. Our request, like that of so many others, is that our children start their high school experience where they will finish it. If our eighth grade daughter starts at Beaverton next year, please let her graduate from BHS. (And let her brother attend BHS so the family is not split up.) Alternatively, if the boundaries do not change and she remains slated to go to Southridge for 10th-12th grade, please let her start at Southridge next year as a freshman. Do not allow her, and the other freshman/sophomore students, to put down roots at one school only to be uprooted and have to start again. It is unkind and unjust to do this to our children.

Thank you for taking the time to read this, and for strongly considering my words as you put forth your recommendations.

We are very disappointed to have to learn the changes through my neighbors, instead of being notified through mail on this important topic.

One of the major factor in choosing our permanent home is the proximity to schools and safety of commute for my children.

While I have no issue in the quality of Beaverton High School, seeing all the great public comments on the work being done at BHS, I am extremely concerned about the infrastructure of the city to support the change of traffic.

Currently from our community at Peterkort Village, just north of US26 on SW Cedar Hill Blvd, is a 6-7 minute drive to Sunset High School during traffic hours.

Dear committee, community members, and BSD administrators,

How are you going to make your final decision of where the new high school boundaries will be? You have a seemingly impossible task on your hands, for each time you edit the map, another community hates it because they will end up in Aloha High School, or a group will love it because they've been taken out of Aloha or because their elementary school gets to stay together. I even read that once you put Oak Hills Elementary back together, there were angry emails from people who disagreed.

Perhaps you should let all of us community members, students, and families know what your penciled lines for the new elementary school boundaries will be while you are doing this high school boundary adjustment process. I know that a lot of people in my area are concerned that we will be pushed out of our elementary school boundary if we remain in our current high school (which is a great school, btw).

The IB versus AP dichotomy is also presenting quite a dilemma. Can all high schools offer both IB and AP? Only a small percentage of students complete full IB and AP, so why not offer both programs at ALL high schools or adopt only one system at ALL high schools.

Transportation with all of the grandfathering will also pose a HUGE problem. Do you plan for taxpayers to pay for all the additional bus routes necessary to transport all the grandfathers kids into their preferred schools, or will the extra pollution and increased traffic jams have to be the accepted reults from people driving their kids to and from school every day because there is no bus transport. Transportation for the grandfathering option really must be addressed before agreeing to grandfather seniors, juniors, or all siblings or existing seniors.

My kids go to an amazing options school, ISB. The students come from all over the district and it is a very diverse school. There is great variation in SES and student race/ethnicity, and I must say that there is a great sense of community and acceptance at this school. 
It is called O-2. Please look for it on Friday or Monday.



Dear High School Boundary Committee Members,

Please restore our high school students to the Westview High School or the Sunset High School boundaries as has existed in all your high school boundary maps issued prior to 11Feb16.

We live in the Waterhouse housing development (i.e., north of Walker Road). We believe that a high school student's proximity to their high school is far more important than the particular elementary school boundaries that they happened to have lived in four years ago. Indeed, over the years educators have stressed the substantial influence of a high school student's participation in high school extra-curricular activities on the healthy development of their interpersonal skills and their ability to function well in society. Such participation is, of course, highly dependent upon the availability of transportation for the student to and from the high school outside of regular school hours when school bussing is not provided.

The Aloha High School is located about 5 miles from our home, and much of that distance is over roads that oft times have heavy vehicular traffic. It can take one as much as 25 minutes to drive to or from the Aloha High School. Transporting children to the Aloha High School in the early morning so they can attend before school activities like chorus practice or seminary, or from school after formal school hours are over so they can participate in sports, clubs, social functions, and special school presentations will be difficult, and may not be possible. On the other hand, Westview High School is only 2.5 miles from our home and Sunset High School is less than 2 miles from our home (almost within walking distance). For the good of our high school students it makes the most sense to reinstate the approximately 50 high school students living in our area into either the boundaries of the Westview High School or the Sunset High School. That would allow them to be full y engaged in school activities and gain the benefit there from.

Our Bottom line: High school student transportation needs in our area far exceed in importance considerations based upon existing elementary school boundaries. It's inevitable that the high school boundary adjustments to be made by you must split some elementary school populations like the Elmonica Elementary School between a number of high schools, and that's OK. Please restore our high school students to the Westview High School or the Sunset High School boundaries as has existed in all your high school boundary maps issued prior to 11Feb16.

Is distance important? When I attended the public hearing (thanks for listening!) I heard most families saying that proximity to school is most important to them. That distance from school is what drives them to or not to do after- or before-school activities.

Is proximity more important than FRL? Will especially less-advantaged kids choose to or be able to do beforeor after-school activities if they're far from their school?

I heard all the north Elmonica/Waterhouse/Stonegate families saying that going to Aloha is too far for them. They're from 4.5 miles away from Aloha HS.

West TV families are also about 4.5 miles from Beaverton HS. But their route is a much more dangerous route than the Elmonica-Aloha route:

Elmonica-Aloha HS crash rate: 8.24 West TV-Beaverton HS crash rate: 10.00

Another tidbit:

Heritage mobile home park-Westview HS crash rate: 5.68 (3.3 miles)

Heritage mobile home park-Aloha HS crash rate: 8.44 (2.8)

Heritage is both closer to Aloha HS and has a safer commute to Aloha HS.

I hope this information helps you as you design high school boundaries that provide safe routes.

As a member of the Sexton Mountain community, I urge you to revisit the guiding principles that were established to guide the boundary setting process.

Availability of space

Safety

• Proximity to school

Transportation

Neighborhood unity

Student body configuration

Staffing patterns

From my vantage point, it appeared that these principles were being adhered to up to the time that the map was published for public input in mid-January. Murray was established as a reasonable boundary and the schools to the west of Murray were kept together. I had not seen any resistance to the routing of SMES to the new school, nor was the new school anywhere near capacity, so I was quite surprised when the February 12th map suddenly had Sexton Mountain feeding into Southridge. I respectfully request that you move Sexton Mountain Elementary back into the boundaries for South Cooper Mountain High School. Those who live in the Sexton Mountain neighborhoods really do have close relationships with members of Cooper Mountain, Nancy Ryles and Scholls Heights, and to break up this close knit community would be very disappointing.

One solution to consider is to reinstate the 93 Hiteon students south of Scholls Ferry back into the Southridge boundary, which keeps their community together, and move Sexton Mountain back into the South Cooper Mountain High School boundary. Feeding Aloha Huber/Chehalem/Sexton Mountain/Cooper Mountain/Nancy Ryles/Scholls Heights to the new high school will increase its utilization to 87%, and decrease the overcrowded Southridge High School to 86%. This solution enables the committee to maintain its commitment to the principles established early on of Neighborhood unity and Availability of Space. Thank you for your consideration.

Boundary Adjustment Committee:

I've had the opportunity to follow, read and review the various feedback from the ongoing boundary adjustment process for the new High School designations. Unfortunately I've been unable to attend the public review forums due to work travel.

This is a follow up email to earlier submissions and feedback I've provided earlier in the process.

The process continues to look for short term pleasing of various lobbying organizations and community groups as evidenced by the proposed map. It is understandable that various groups want things to stay intact. The committee not only needs to address the long term boundaries, but equally importantly should consider creative means to satisfy the near term needs of district families. The district map should focus on long term, and transition rules can best accommodate current attendance.

It would be beneficial for the committee to test the proposed boundaries against the factors for enrollment, FRL, distance, etc, but importantly should consider tests of reasonableness. In this particular case, the test of reasonableness would be the perspective of a landowner/taxpayer, funding the district, who does not have students attending school. Would the reasonable individual see the maps as logical? I would assert no.

From a long term perspective:

- The tendrils for the various High Schools boundaries do not have logical or reasonable associations with the local elementary schools, undermining a long term sense of community. Schools nearly adjacent to a particular High School will now be associated halfway across the district. Chehalem as an example, should by any measure be associated with Aloha, and logically, Hazeldale is closer to SCMHS, both with similar demographics, but different geography.
- The proposed map, with boundaries stretched north/south will result in longer, more complicated travel for students, straining an already expensive bus service and requiring longer bus routes for some students. We should work to put dollars into teachers and the classroom, not a complicated transportation network. Many students already spend too much time on buses. Having students north of Beaverton High School bussed to SCMHS highlights this. The proposed plan would be challenge for any operations team. No individual with regard to students time and our tax dollars would consider such a transportation effort as reasonable.
- Growth will continue to the north of the district and the south, yet the maps are set to strain attendance and staffing as soon as any new building is completed, resulting in overcrowding and ultimately another redistricting effort. Continuity and consistency are better for long term community. Building through edge of district housing tracts as well as in-fill, a key initiative of Metro, will happen faster than the system can district. Westview & Sunset need to plan for infill and north expansion. Westview must have additional capacity, 98% isn't sufficient to deal with north district expansion, and hence, not reasonable. Aloha boundaries need to move north, and consequently SCMHS as well. Major roads tend to not only designate communities, but also minimize travel. Hgwy 26/Farmington are reasonable N/S boundaries.

It is a challenge to consider total school enrollment rate, socio-economic status, transportation distance, transportation complexity, transportation safety, long term growth prospects, and importantly intact neighborhoods. The BSD High School Boundary Map of 2/12/16 defies all reasonable standards.

Near term optimization - As a point that has not been discussed as broadly, while the boundaries are reviewed, is the transition of current Middle School and High School Students. Many of the complexities in the proposed map maybe mitigated with a more involved student transition plan. One potential suggestion would be to allow Sophomore and/or Juniors and/or Seniors to transition to their new target school, starting in 206/2017 with the burden of transportation responsibility on the parents.

Parting thought: What would the map look like if the school bus network was taken away, and the finances shifted to direct education?

Regards, Kevin Heidrich Since the BAC is taking maps made by community members into consideration, we present the following map - *Public Hearing Map Improved* – as a possible solution. It is the same as the *Public Hearing Map*, except for four changes that affect Sunset, Beaverton and Aloha High Schools as outlined below.

- 101 Barnes students (THPRD Nature Park/Millikan area) from Beaverton to Aloha.

 These students join the 26 Barnes students already in Aloha boundaries on the *Public Hearing Map*, and they are closer in proximity to Aloha than Elmonica is to Aloha.
- 161 Elmonica students (north of Baseline, east of 170th) from Aloha to Sunset. Elmonica is closer in proximity to Sunset than it is to Aloha (Elmonica's third farthest school). Elmonica is a title one elementary school and brings much needed diversity to Sunset. Even without Heritage Park, Elmonica raises Sunset's low FRL% by several points, giving Sunset its highest FRL% since the Springboard Proposal.
- 27 Barnes students (lining Murray Rd.) from Beaverton to Sunset.
 They are closer in proximity to Sunset than to Beaverton, and just as close to Sunset as other Barnes students already in the Sunset boundary on the Public Hearing Map.
 Ridgewood's westernmost border creates a natural boundary separating these Barnes students from the rest of their elementary school neighbors to the south.
- 199 Cedar Mill students from Sunset to Beaverton.
 The area of Elmonica moved into Sunset is slightly closer to Sunset than the portions of Cedar Mill that have been removed. Also, the farthest area of Cedar Mill from Beaverton (4.8 miles) is closer to Beaverton than the farthest area of Elmonica is to Aloha (5 miles). These portions of Cedar Mill significantly lower the FRL% at Beaverton.

The following analysis of the *Public Hearing Map Improved* focuses on the criteria given to the BAC by the School Board.

- 1. **Availability of Space.** All schools on *Public Hearing Map Improved* are below capacity.
- 2. **Proximity to School.** This map keeps Elmonica, Barnes and Cedar Mill students who are closest to Sunset HS in Sunset. Most of Elmonica is going to their closest school. Most of Barnes is going to their closest school. On this map, the farthest Barnes student in Aloha is 2.2 miles closer to Aloha than the farthest Elmonica student in Aloha is on the Public Hearing Map. No one north of TV Hwy is being sent to the third farthest school from their neighborhood.
- 3. Safety. At the Public Hearing, State Representative Ken Helm provided data from Washington County identifying major problem areas on 170th Ave., the most direct route to Aloha HS from Elmonica. A large chunk of this road is restricted to one lane in each direction, with traffic backing up at Merlo due to the absence of a left turn lane. The other route from Elmonica to Aloha is by taking Walker Rd or Baseline Rd. to 185th Ave. According to a study by State Farm Insurance, the intersection at 185th and SW Baseline is one of top 10 most dangerous in the state of Oregon. (http://www.prnewswire.com/news-releases/seven-of-oregons-10-most-dangerous-intersections-in-portland-state-farm-study-shows-74981032.html) The area around TV Hwy and 185th is one of ODOT's top safety concerns as stated on their website: "The crash rate in this section of TV Highway is very high, and is one of the top safety concerns in

Washington County. Between Jan. 2010- Nov. 2014, there were 176 crashes and 54% of those resulted in injuries." (http://www.oregon.gov/ODOT/HWY/REGION1/Pages/tv185th.aspx)

- 4. **Neighborhood Unity.** *Public Hearing Map Improved* keeps all but one elementary school north of Sunset Hwy intact, as they were on the *Public Hearing Map*. On our map, portions of Cedar Mill would go to Beaverton HS with neighboring West TV students, **creating a larger Beaverton HS community north of Sunset Hwy**. This provides better neighborhood unity for West TV students and Beaverton. Elmonica and Barnes remain split, but the "blue peninsula" from the *Public Hearing Map* that seems disconnected from Aloha's boundary has been eliminated, and Barnes students north of Walker Rd. would not be the only neighborhood south of Sunset Hwy. in Sunset. This is better neighborhood unity for those Barnes and Elmonica students. The boundary for Aloha HS is more compact on the *Public Hearing Map Improved*, resulting in better neighborhood unity for Aloha.
- 5. Transportation Costs. Elmonica and Cedar Mill are both about the same distance from Sunset. The farthest area in Elmonica from Aloha is 5 miles, while the farthest area in Cedar Mill from Beaverton is 4.8 miles. The farthest area in Elmonica from Sunset is 2.9 miles, while the farthest area in Cedar Mill from Sunset is 3.1 miles. Elmonica has a slight edge in proximity over Cedar Mill, but transportations costs would be similar. However, the farthest home in the area of Barnes going to Aloha on this map is 2.8 miles, while the farthest home in Elmonica is 5 miles from Aloha. The THPRD Nature Park/Millikan section of Barnes is much closer to Aloha than Elmonica is. Sending this area of Barnes to Aloha with their closest classmates, instead of portions of Elmonica north of Baseline, would result in a substantial transportation savings.
- 6. **Student Body Composition.** The Springboard Proposal that placed Elmonica in Sunset gave Sunset the HIGHEST FRL % of any map presented by the BAC to date, including the map that puts part of Barnes in Sunset. Elmonica is a title one elementary school and brings much needed diversity to Sunset. **Even without Heritage Park, Elmonica significantly raises the low FRL% at Sunset, almost to the same percentage it was on the Springboard Proposal.** Also, the portions of Cedar Mill going to Beaverton significantly lower the high FRL% at Beaverton.

I would like to provide additional information in support of my testimony given at the public hearing, regarding the severe transportation and safety impacts of the most recent proposal to move Stonegate, Merewood and Waterhouse nieghborhoods from Westview to Sunset. I urge the committee to apply the boundary adjustment criteria and revert the Waterhouse neighborhood to the Sunset district, as was proposed in the Springboard proposal.

The Springboard proposal, which places Waterhouse in the Sunset district, demonstrates the application of the criteria. Waterhouse neighborhood represents 37 students. According to the public hearing map forecast of projected capacity, these students could be placed in to Sunset without displacing any other neighborhoods currently proposed for that district.

However, I encourage the Committee to consider additional changes in order to better address proximity, safety, and FRL % leveling. Attached is a new community-proposed map and an analysis of changes and benefits. In addition to significantly improving proximity, this map also improves Sunset FRL to its highest level since the Springboard Proposal.

As the BAC seeks to meet its charter of applying the adjustment criteria in making its recommendation, I would appreciate your review of the attached map and its benefits.

Finally, I would like to submit additional comments regarding the substantional transportation and safety burden imposed by the Public Hearing map proposal to move Waterhouse from Westview to Aloha.

The most direct route for residents of Stonegate, Merewood, Waterhouse travelling south toward Aloha High School is down 170th Ave.

1. 170th between Merlo and Alexander is severely constricted to one lane for most of that distance. The Washington County Transportation System Plan (which is the county's roadmap for how and when road projects will be undertaken) identifies this section as a problem. It is slated for road widening to 4 lanes at some point in the future. However, the TSP states that work will cost over \$15,000,000. Washington County's project list is underfunded and currently has a significant funding shortfall.

In the list of Capital Projects in the TSP, Appendix 2, the County estimates that the project is a "medium term" project for which funding has not been appropriated and no present plans are in place for actual construction. This means that it will likely be at least 10 years before work can begin on 170th.

2. Nike is quickly building their new world headquarters. They forecast 2500-3000 new workers living and driving through the area between Hwy 26 and TV Hwy in the very near future. In our neighborhood, that means the east/west roads like Baseline/Jenkins and Walker, and Merlo, as well as north-south roads like 158th, 170th and 185th, are going to see increased peak period use, like 7:00 - 8:30 a.m.

Travelling the nearly 5 miles from our house to Aloha will require either 170th or 185th. We are already seeing impact from Nike's growth, and the proposed change to Aloha makes a difficult situation that much worse.


It will take a lot more time and the intersections will be forced to deal with more vehicles - and waiting times at the lights will increase. We all know that at times it takes several cycles to get through any of those intersections. Beyond the safety concerns that other groups have identified, the sheer time required to get kids to school in the morning, home in the afternoon, or back for extra-curricular activities, is unreasonably burdensome - not just on parents driving, but on the bus service as well.

I appreciate your service on the committee, and thank you for your ongoing committment to a fair, open and rigorous process, including your efforts to apply the adjustment criteria in your recommendations.

Dear Boundary Adjustment Committee:

I am a parent of a Conestoga Middle School student and I'm writing to urge you to consider carefully the long term economic, community and academic impact the school boundaries will have. The boundary maps proposed so far haven't clearly articulated the priorities considered or what the long term effects would be for each of the proposals. I'm also worried that many of the public comments have focused on the short term concerns of individual elementary school areas and communities, and don't consider the bigger picture of the community as a whole over time.

I feel that the economic balance of the high schools will have the biggest impact on the future of the Beaverton school district. Studies have shown that the economic status of students impacts test scores and graduation rates, and schools with high test scores and grad rates attract students and families with higher economic status. Other studies show that when lower income students attend the higher performing schools with higher economic status, their test performance increases. But this requires the continued attendance of the higher economic status students. Therefore, it is crucial to keep the high schools balanced to discourage the movement of higher economic status students to just a few high schools and to encourage the best performance at all schools.

While your task as a committee is a difficult one, it is also an incredibly important one that will affect the district long after our current students have graduated. The future of Beaverton is in your hands; I hope that you create boundaries that can benefit ALL the students in the district for many years to come.

I am writing to encourage the boundary committee to consider a few tweaks to the map (praise for the existing map overall, I think its a huge improvement from previous ones) that would further improve outcomes for our highs school students. RESEARCH shows that moving lower income students to lower performing schools has a definite impact on their graduation rates, whereas moving higher income students to a more diverse FRL % school does NOT impact their graduation rates...

I am a Sunset parent who is open minded part of a large parent group who is very open to moving our kids to of Sunset to Beaverton- the majority of parents are very open to this change, to becoming part of a new community and a new chapter. I live in Cedar Hills which has sixty years tradition of feeding into Sunset, and we understand the need for change - we are just hoping that the balance can be improved between both Sunset and Beaverton, as well as Westview/Aloha.

I am saddened by a very SMALL MINORITY of Sunset parents who are fighting against equity for all kids in the district. This boundary process should reflect interests of ALL students, not a tiny pocket of the affluent who have the means and resources to organize and make noise. It feels like the 1950's to sit and hear parents say they're going to sue the district (further draining resources of the board and our tax payer money) because their child may not be able to attend the richest, most affluent school at the expense of other deserving students.

By creating a school with 14% FRL it creates a school that NO FRL kid will feel comfortable at. It is an unacceptable number. Proximity and safety have already been satisfied with the current map; the primary criteria have already been met as best as I feel like they can be. Now its time to focus on the secondary criteria, which are arguably more important, as proven by research, to the outcomes of students.

Please consider grabbing more of the Barnes population into Sunset, and perhaps shifting Cedar Mill down to Beaverton... this makes so much more sense for outcomes of students- which should truly be our first priority, not the WANTS of a vocal few.



Dear Boundary Committee,

I had heard how unsafe it would be for West TV to travel to Beaverton HS, so I did my own research on the matter. I went straight to the sources at ODOT's Highway Crash

Tables (at www.oregon.gov/ODOT/TD/TDATA/car/docs/2013_Crash_Rate_Book.pdf), Washington County Traffic Counts (https://www.beavertonoregon.gov/DocumentCenter/View/7754), and Oregon Metro's Crash Maps. This took me numerous days of research and I hope it will be useful to you in guiding your boundary decisions.

Below is a guick summary of what I found.

West TV (middle) to Sunset HS (along Cornell) crash rate: 2.53; distance: 2.7 miles West TV (middle/bottom) to Beaverton HS (along 217) crash rate: 10.00; distance 4.7 miles

An increase of 2 miles each way along an already overcrowded slow-moving corridor represents a huge increase in travel time for the children. Going from a crash rate of 2.53 to 10.00 is treacherous.

I'm attaching a map and graph I made so you could more easily get a sense of crash rates on various routes in the district. This was helpful to me in getting a handle on what a crash rate number looks like on different routes. I chose routes that were close to the 2.7 miles (West TV to Sunset) and 4.7 miles (West TV to Beaverton) so easier comparisons could be made.

Please notice that other 4.7-ish mile routes are significantly safer (much lower crash rates) than West TV to Beaverton's route.

Also notice that other 2.7-ish mile routes are similar in safety (crash rates) to West TV to Sunset's route.

I urge you to take this information into careful consideration as you kindly volunteer your time to arrange our high school boundaries.

Subject: Late Start for BHS ALOHA to combat safety issues for North to South Traveling students

I am a parent form Ridgewood community. We will likley be moved to BHS. I'm fine with that but I understand the concerns of West TV parents, and our parents about safety of travel. My thought was to simply delay the start time of the schools where majority of students are traveling either a long comparative distance OR on heavily traveled roads during rush hour.

1) LATE START BHS AND ALOHA ---830AM

a) LOWERED TRAFFIC LEVELS for south traveling students - (helps west tv, ridgewood and Elmonica. I would assume sections going south to South Cooper Mountain as well)

Traffic on 217 is the worst before 8 AM (I don't have info on 185th) and particularly bad around 720-740.

If high school students are on that road during peak times the dangers of accidents are much higher and inconveniences of long commutes are drastically worse.

So let's move all that extra traffic we will add to the roads (another 20% from what I understand) to a non-peak time -- only 45 minutes later when traffic isn't nearly as bad.

b) BENEFITS TO STUDENTS - There have been a lot of studies that show teenagers and schools benefit HIGHLY from later starting high schools - **including**

Improvement in grades, test scores

Better overall health (including mood!),

Decreases in accident rates

Decrease substance abuse

Better Attendance rates.

This could go a long way to combat the issues that all schools, and especially those dealing with low performance or graduation rates have.

I was able to go to to the public hearing on February 16, and was impressed with how you all listened to everyone so intently. I do not envy the position you are all in, it's impossible to please everyone. Since then I have tried to look at the map more holistically. I want to share my thoughts. I can appreciate that you need to draw the boundary line somewhere where one side of the street will go to one school and one side will go to the other. This is a very apparent at Nancy Ryles elementary which is on Wier Road on the corner of Wier Road and 160th. On the west side of Wier Road there are houses that look directly onto Nancy Ryles and to get there all you have to do is cross the street but instead they walk the one mile to Sexton Mtn. Wier is the boundary and one side goes to one school one side the other. It makes sense, easy to explain. What I am going to have a hard time explaining in a few years is why there are random shapes for boundary lines. I think we can all agree from the meeting on the 16th was the blue rectangle going to a Aloha needs to somehow go to Westview or Sunset, that's way too far of a distance for kids to go to the school and there is a closer one. Unfortunately they did not offer a solution. Due to Aloha having the highest f/r lunch wouldn't it make more sense for Cooper Mtn elementary to go to Aloha? Another awkward shape is the sexton mail random triangle. We are basically a bubble with all the schools around us going to the new high school and we are a bubble in our own zone. This has been extremely evident to me the past few days between picking up my kids and their activities after school and work I spend a lot of time driving north and south on 155th St. I think it's great you extended the boundary to the new high school all the way to TV Highway and out to 170th. I work on 165th and TV highway and am very happy to see that there's going to be more diversity and more f/r lunches at the new high school. Where I have the concern is basically buses will pick up kids in the Chehalem area and to get to the new high school will drive down 155th to get to the Nancy Ryles area this is driving through sexton Mountain neighborhood where 80% of kids that go to Sexton Mountain could walk to 155th and get on the bus. So basically there's a bus that's going to go right by my house but my kids won't be getting on it. This bubble boundary as I'm going refer to it is much harder to explain. As drove to the dry cleaners by Chehalem and then went to the library in Murrayhill it really hit me the boundary is around us and buses will be going through us. i don't know how to explain that because it does not make sense to me. I will hypothesize that Sexton Mountain was cut out to lower Southridge f/r lunches lunch and extending the boundary to TV highway was bringing up the f/r lunch for the new school. If this is the main reason I have concern. If you build a school in a high socioeconomic area you are going to have data that represents that. The reason we live in Sexton Mtn instead of Nancy Ryles is we couldn't afford houses there. The irony isn't lost on me that they are still zoned for the new school. In looking at the maps that of come out this far I have some concerns of the way the bubble of Sexton Milton has been treated to the weight other schools have happened. First Sunset high school started out on map one at 19% free reduce lunch not sure what the people complained about then because I don't know much of what's happening on that side of town since I never go over there but on the second map it had dropped to 11%. Now it's back up at 14% and it seems like people are happy with 14%. First of all I had no idea that that was such a high income school who knew! The new high school in the first map was at 24% we were still in it, second map 25% we were still in it, currently at 34% we are not in it so I can hypothesize that moving us back in would put it between somewhere and 25% and 34%. Mind you from the second to the third map there was also much more taken from Aloha and moved to the new school which I think might even out that number so if this is the sole reason for putting the bubble around sexton Mountain how can you justify that when Sunset made a move from 19% to 14% and it seems to stay there. We also suggested that the 93 Hiteon kids move back to Southridge where they want to be and move us back to the new high school which. If you look at the map three Murray is a perfect natural boundary line. Allen is a dividing line TV highway is a dividing line sunset highway is a defining line 170th is a dividing line. I apologize for the length and my random thoughts but it have gotten them all out now. I ask you to reconsider having Murray be the line boundary for the reasons that I have put forth here. Dear Boundary Adjustment Committee Members,

I hope the committee will remember the arguments given by the numerous Elmonica families at the Public Hearing last week. Remember, too, the various community members from other parts of the district who said the "blue peninsula" on the Public Hearing Map doesn't make sense. That blue peninsula jutting out of the top corner of Aloha's border doesn't create neighborhood unity either for Elmonica or for Aloha. And it doesn't follow proximity to school or transportation safety criteria either.

Several Aloha grads live in our neighborhood, and we know a few current Aloha families. We have nothing against Aloha, or any other school in the district. We know our children can get a good education at any BSD school. Both our children attended Elmonica from K-5th grade, and Elmonica is a title one school with 51% FRL students (data from 2014-15 OR State Report Card.) If we didn't think they could thrive at their school because of its economics we would have packed up and moved years ago. But we didn't, because we love our community. We're asking to stay at Westview or move to Sunset because those two schools are closest to us and are both part of our community. On the other hand, Aloha is five miles away from the farthest home in Elmonica, and to get there, more parents, buses and student drivers would be sent down an already congested 185th Ave., crossing through two of the most dangerous intersections in Oregon (at Baseline and at TV Hwy, see note below.) No other neighborhood north of TV Hwy is being asked to send their kids to the third farthest school from their home. No current Sunset students are being asked to drive through Sunset boundaries to get to Beaverton. Why are Elmonica students being asked to drive through Westview boundaries to get to Aloha, when those neighborhoods are closer to Aloha than we are?

Now we'd like to address one of the the additional criteria: student body composition. Please note that the Springboard Proposal, which placed Elmonica in Sunset, gave Sunset the HIGHEST FRL% of any BAC map to date, including the map that puts part of Barnes elementary school in Sunset.

FRL% for Sunset HS on Boundary Adjustment Committee Maps

Springboard Proposal (includes most of Elmonica but not Barnes) 19%

Committee Learning Map (12/03) 13%

Committee Learning Map (12/17) 11%

Preliminary Proposal 11%

Public Hearing Map (includes part of Barnes but none of Elmonica) 14%

It's hard to get anyone to agree on the best solution for the boundary adjustments, but one thing everyone can agree on is that Sunset has the lowest FRL% by far. While boundary changes aren't meant to equalize FRL% at every school, they aren't meant to make the divide even larger either. Sunset could really use the economic and cultural diversity Elmonica has to offer. Even without Heritage Park, Elmonica raises the FRL% at Sunset by several percent, and sending us to Sunset fits the proximity, transportation safety and neighborhood unity criteria, too.

Option 1 - Keep all of Elmonica in Westview. It's our current school and would mean no transition for our kids. How to do this? One way is by sending Oak Hills to Sunset. The majority of the public comment from Oak Hills last week was asking to be put in Sunset. Doing so leaves room for most of Elmonica at Westview. (If Oak Hills has to be split, remember that eight elementary schools south of Hwy 26 are split on the Public Hearing Map, and none of the elementary schools north of Sunset Hwy are split.)

Option 2 - Leave Heritage Park at Westview per Dr. Franco's request. Put remaining Elmonica students in Sunset - our closest school - which raises Sunset's FRL numbers to 18.1%. (See Public Hearing Map Improved.)

Option 3 - Put all of Elmonica in Sunset per the Springboard Proposal and raise Sunset's FRL numbers to 19%.

Option 4 - We would love for our Elmonica friends between Walker and Baseline to join us at either Westview or Sunset, and there are ways to make that work and still follow the school board's criteria. (Public Hearing Map Improved, Springboard Proposal, etc.) But, if the committee is unable to make room for everyone, we ask that you at least keep the 53 Elmonica students north of Walker Rd (the closest Elmonica neighborhoods to Sunset and to Westview) at Sunset or Westview.

The boundary change process is drawing to a close and I am sure it has been tough on committee members. It's certainly been tough on our community. Thank you for the time you have dedicated thus far. Please be sure to take enough time to make sure your final recommendation follows the criteria.

(http://www.prnewswire.com/news-releases/seven-of-oregons-10-most-dangerous-intersections-in-portland-state-farm-study-shows-74981032.html) On their website, ODOT states this about TV Hwy and 185th: "The crash rate in this section of TV Highway is very high, and is one of the top safety concerns in Washington County. Between Jan. 2010- Nov. 2014, there were 176 crashes and 54% of those resulted in injuries." (https://www.oregon.gov/ODOT/HWY/REGION1/Pages/tv185th.aspx)

Since the BAC is taking maps made by community members into consideration, we present the following map - *Public Hearing Map Improved* – as a possible solution. It is the same as the *Public Hearing Map*, except for four changes that affect Sunset, Beaverton and Aloha High Schools as outlined below.

- 101 Barnes students (THPRD Nature Park/Millikan area) from Beaverton to Aloha.

 These students join the 26 Barnes students already in Aloha boundaries on the *Public Hearing Map*, and they are closer in proximity to Aloha than Elmonica is to Aloha.
- 161 Elmonica students (north of Baseline, east of 170th) from Aloha to Sunset. Elmonica is closer in proximity to Sunset than it is to Aloha (Elmonica's third farthest school). Elmonica is a title one elementary school and brings much needed diversity to Sunset. Even without Heritage Park, Elmonica raises Sunset's low FRL% by several points, giving Sunset its highest FRL% since the Springboard Proposal.
- 27 Barnes students (lining Murray Rd.) from Beaverton to Sunset.
 They are closer in proximity to Sunset than to Beaverton, and just as close to Sunset as other Barnes students already in the Sunset boundary on the Public Hearing Map.
 Ridgewood's westernmost border creates a natural boundary separating these Barnes students from the rest of their elementary school neighbors to the south.
- 199 Cedar Mill students from Sunset to Beaverton.

 The area of Elmonica moved into Sunset is slightly closer to Sunset than the portions of Cedar Mill that have been removed. Also, the farthest area of Cedar Mill from Beaverton (4.8 miles) is closer to Beaverton than the farthest area of Elmonica is to Aloha (5 miles). Proximity is similar, but these portions of Cedar Mill significantly lower the FRL% at Beaverton.

Criteria based analysis:

- 1. **Availability of Space.** All schools on *Public Hearing Map Improved* are below capacity.
- 2. **Proximity to School.** This map keeps Elmonica, Barnes and Cedar Mill students who are closest to Sunset HS in Sunset. Most of Elmonica is going to their closest school. Most of Barnes is going to their closest school. On this map, the farthest Barnes student in Aloha is 2.2 miles closer to Aloha than the farthest Elmonica student in Aloha is on the Public Hearing Map. No one north of TV Hwy is being sent to the third farthest school from their neighborhood.
- 3. Safety. At the Public Hearing, State Representative Ken Helm provided data from Washington County identifying major problem areas on 170th Ave., the most direct route to Aloha HS from Elmonica. A large chunk of this congested road is restricted to one lane in each direction, with traffic backing up at Merlo due to the absence of a left turn lane and there is a large stretch of road with no sidewalks. The other route from Elmonica to Aloha is by taking Walker Rd or Baseline Rd. to 185th Ave. According to a study by State Farm Insurance, the intersection at 185th and SW Baseline is one of top 10 most dangerous in the state of Oregon.



- 4. **Neighborhood Unity.** *Public Hearing Map Improved* keeps all but one elementary school north of Sunset Hwy intact, as they were on the *Public Hearing Map*. On our map, portions of Cedar Mill would go to Beaverton HS with neighboring West TV students, **creating a larger Beaverton HS community north of Sunset Hwy**. This provides better neighborhood unity for West TV students and Beaverton. Elmonica and Barnes remain split, but the "blue peninsula" from the *Public Hearing Map* that seems disconnected from Aloha's boundary has been eliminated, and Barnes students north of Walker Rd. would not be the only neighborhood south of Sunset Hwy. in Sunset. This is better neighborhood unity for those Barnes and Elmonica students. The boundary for Aloha HS is more compact on the *Public Hearing Map Improved*, resulting in better neighborhood unity for Aloha.
- 5. Transportation Costs. Elmonica and Cedar Mill are both about the same distance from Sunset. The farthest area in Elmonica from Aloha is 5 miles, while the farthest area in Cedar Mill from Beaverton is 4.8 miles. The farthest area in Elmonica from Sunset is 2.9 miles, while the farthest area in Cedar Mill from Sunset is 3.1 miles. Elmonica has a slight edge in proximity over Cedar Mill, but transportations costs would be similar. However, the farthest home in the area of Barnes going to Aloha on this map is 2.8 miles, while the farthest home in Elmonica is 5 miles from Aloha. The THPRD Nature Park/Millikan section of Barnes is much closer to Aloha than Elmonica is. Sending this area of Barnes to Aloha with their closest classmates, instead of portions of Elmonica north of Baseline, would result in a substantial transportation savings.
- 6. **Student Body Composition.** The Springboard Proposal that placed Elmonica in Sunset gave Sunset the HIGHEST FRL % of any map presented by the BAC to date, including the map that puts part of Barnes in Sunset. Elmonica is a title one elementary school and brings much needed diversity to Sunset. **Even without Heritage Park, Elmonica significantly raises the low FRL% at Sunset, almost to the same percentage it was on the Springboard Proposal.** Also, the portions of Cedar Mill going to Beaverton significantly lower the high FRL% at Beaverton.

I need to first thank you for your time and diligence in getting this process to work for everyone. I appreciate your transparency. I've been to all but 1 meeting, so I have an inkling of how hard this must be for all of you.

My subject line has probably clued you in to where I live:

(We reside in the 'blue peninsula" or "blue thumb' that makes up the current Aloha boundary proposal)

The recent map proposal presented at Southridge HS last week had brought up several concerns that I share whole-heartedly with my neighbors. We live close to not one, but 2 nearby high schools, namely Westview and Sunset. We have multiple ways of getting to both schools in reasonable time even in congested traffic. Our daily lives are spent north of Baseline Rd; we work at Intel and Providence, we shop at the nearby Fred Meyers and Tanasbourne malls, and we send our kids to elementary and daycare all north of Baseline Rd. Our daily chores and activities rarely take us south of Baseline, let alone TV highway. Our kids will eventually go to Elmonica Elementary and Five Oaks Middle—all their friends and associates all will have some connection to Westview or Sunset. We want to preserve these connections to their friends and communities to the best of our abilities.

- 1) Our oldest son is a freshman at ISB but would like to move over to the new high school as a junior. There has been discussions that you will not allow Juniors and Seniors to move over but <u>what about option school students</u>?
- 2) Sports: Will you have JV/Varsity sports at the new high school starting from Day 1 (and which sports will they be)?
- 3) Extracurricular Activities: How about clubs, newspaper, Student UN, Debate Team, Science Team, Robotics, Yearbook?
- 4) Will the school have IB and AP programs? Which ones will be up and running that first year?

I have looked at the updated public hearing map (2/12/16), and I would like to share my opinion.

I believe Errol Hassell ES boundary (and south part of Hazeldale ES boundary) should be included in South Cooper Mtn HS Boundary instead of stretching South Cooper Mtn HS Boundary to North of Farmington Rd.

1. Transportation, Safety and Proximity to school.

When you draw a boundary, it makes more sense try not to cross major road. Farmington road is a very high traffic road, especially after south Beaverton area is developed. Currently, both 170th and 185th are already packed during commuting hours both in the morning and evening, and high school students will start driving to school as well. This will increase major traffic issues.

Also, this will make school bus drivers to spend more time for South Cooper Mtn HS if the boundary is laid narrow north-south way crossing Farmington road.

On top of that, students who live east of 170th, Aloha HS is only about 2 miles away, but they will have to go to South Cooper Mtn HS which is about 4 miles away. This does not make sense.

I am submitting these comments to provide additional information in support of testimony given at the public hearing, and to further urge the committee to apply the boundary adjustment criteria and revert the Waterhouse neighborhood to the Sunset district, as was proposed in the Springboard proposal.

Strong arguments were raised at the hearing regarding proximity (just over 1 mile to Sunset vs nearly 5 miles to Aloha), transportation and safety (high capacity 4 lane arterial roads to Sunset, with sidewalks and bike paths, vs severely constricted 2 lane road without sidewalks or bike paths to Aloha). Application of the neighborhood unity criteria was also questioned at the hearing. Many community members noted the "blue peninsula" and "odd thumb" created by moving Waterhouse, Stonegate and Merewood to Aloha, when those neighborhoods are surrounded on 3 sides by Westview and Sunset.

The Springboard proposal, which places Waterhouse in the Sunset district, demonstrates the application of the criteria. Waterhouse neighborhood represents 37 students. According to the public hearing map forecast of projected capacity, these students could be placed in to Sunset without displacing any other neighborhoods currently proposed for that district.

Alternatively, if the Committee is willing to consider larger changes in order to better address proximity, safety, and FRL % leveling, I attach a new proposed map and analysis of changes and benefits. Our neighborhood has worked together to create this map, and compared it to the 250 other maps on sensibleboundaries.com. In addition to significantly improving proximity, this map also improves Sunset FRL to its highest level since the Springboard Proposal.

I would appreciate your review of the attached map and the analysis of changes, and demonstration of how it meets the adjustment criteria.

Finally, I would like to submit additional comments regarding the substantional transportation and safety burden imposed by the Public Hearing map proposal to move Waterhouse from Westview to Aloha.

The most direct route for residents of Stonegate, Merewood, Waterhouse travelling south toward Aloha High School is down 170th Ave. There are a few problems with forcing parents, kids driving or biking, and buses to move south along that roadway:

1. 170th between Merlo and Alexander is severely constricted to one lane for most of that distance. The Washington County Transportation System Plan (which is the county's roadmap for how and when road projects will be undertaken) identifies this section as a problem. It is slated for road widening to 4 lanes at some point in the future. However, the TSP states that work will cost over \$15,000,000. Washington County's project list is underfunded and currently has a significant funding shortfall.

In the list of Capital Projects in the TSP, Appendix 2, the County estimates that the project is a "medium term" project for which funding has not been appropriated and no present plans are in place for actual construction. This means that it will likely be at least 10 years before work can begin on 170th.

2. Nike is quickly building their new world headquarters. Functionally that means there will be 2500-3000 new workers living and driving through the area between Hwy 26 and TV Hwy in the very near future. On the ground that means the east/west roads like Baseline/Jenkins and Walker, and Merlo, as well as north-south roads like 158th, 170th and 185th, are going to see increased peak period use, like 7:00 - 8:30 a.m.

Travel north to south on 170th and 185th will take a lot more time and the intersections will be forced to deal with more vehicles - and waiting times at the lights will increase. We all know that at times it takes several cycles to get through any of those intersections. Beyond the safety concerns that other groups have identified, the sheer time required to get kids to school in the morning, home in the afternoon, or back for extra-curricular activities is unreasonably burdensome - not just on parents driving, but on the bus service as well.

Thank you for your careful consideration of this information, and your continued committment and service.

Since the BAC is taking maps made by community members into consideration, we present the following map - *Public Hearing Map Improved* – as a possible solution. It is the same as the *Public Hearing Map*, except for four changes that affect Sunset, Beaverton and Aloha High Schools as outlined below.

- 101 Barnes students (THPRD Nature Park/Millikan area) from Beaverton to Aloha.

 These students join the 26 Barnes students already in Aloha boundaries on the *Public Hearing Map*, and they are closer in proximity to Aloha than Elmonica is to Aloha.
- 161 Elmonica students (north of Baseline, east of 170th) from Aloha to Sunset. Elmonica is closer in proximity to Sunset than it is to Aloha (Elmonica's third farthest school). Elmonica is a title one elementary school and brings much needed diversity to Sunset. Even without Heritage Park, Elmonica raises Sunset's low FRL% by several points, giving Sunset its highest FRL% since the Springboard Proposal.
- 27 Barnes students (lining Murray Rd.) from Beaverton to Sunset.
 They are closer in proximity to Sunset than to Beaverton, and just as close to Sunset as other Barnes students already in the Sunset boundary on the Public Hearing Map.
 Ridgewood's westernmost border creates a natural boundary separating these Barnes students from the rest of their elementary school neighbors to the south.
- 199 Cedar Mill students from Sunset to Beaverton.
 The area of Elmonica moved into Sunset is slightly closer to Sunset than the portions of Cedar Mill that have been removed. Also, the farthest area of Cedar Mill from Beaverton (4.8 miles) is closer to Beaverton than the farthest area of Elmonica is to Aloha (5 miles). These portions of Cedar Mill significantly lower the FRL% at Beaverton.

The following analysis of the *Public Hearing Map Improved* focuses on the criteria given to the BAC by the School Board.


- 1. **Availability of Space.** All schools on *Public Hearing Map Improved* are below capacity.
- 2. **Proximity to School.** This map keeps Elmonica, Barnes and Cedar Mill students who are closest to Sunset HS in Sunset. Most of Elmonica is going to their closest school. Most of Barnes is going to their closest school. On this map, the farthest Barnes student in Aloha is 2.2 miles closer to Aloha than the farthest Elmonica student in Aloha is on the Public Hearing Map. No one north of TV Hwy is being sent to the third farthest school from their neighborhood.
- 3. Safety. At the Public Hearing, State Representative Ken Helm provided data from Washington County identifying major problem areas on 170th Ave., the most direct route to Aloha HS from Elmonica. A large chunk of this road is restricted to one lane in each direction, with traffic backing up at Merlo due to the absence of a left turn lane. The other route from Elmonica to Aloha is by taking Walker Rd or Baseline Rd. to 185th Ave. According to a study by State Farm Insurance, the intersection at 185th and SW Baseline is one of top 10 most dangerous in the state of Oregon. (http://www.prnewswire.com/news-releases/seven-of-oregons-10-most-dangerous-intersections-in-portland-state-farm-study-shows-74981032.html) The area around TV Hwy and 185th is one of ODOT's top safety concerns as stated on their website: "The crash rate in this section of TV Highway is very high, and is one of the top safety concerns in

Washington County. Between Jan. 2010- Nov. 2014, there were 176 crashes and 54% of those resulted in injuries." (http://www.oregon.gov/ODOT/HWY/REGION1/Pages/tv185th.aspx)

Dear Committee Members,

I wanted to thank you for the opportunity to speak to you at the Public Hearing. We can all appreciate that this is a very serious and thoughtful process that will be highly impactful for all the families within the BSD boundaries.

I live in the Waterhouse North/Stonegate community of Elmonica. Many of us attended the Public Hearing and expressed our concern about our neighborhood being placed in the Aloha High School boundaries.

I want to first state that we are new to this area, but I have talked to several families that attend Aloha and they are very happy with their children's education and experience there. All schools have their strengths and challenges. If our community's desire to attend Sunset or Westview was based solely on not wanting to attend Aloha, we would have a very weak argument.

However, based on the criteria set forth by the school board we feel we have very strong and compelling reasons to remain in Westview or be moved to our closest school, which is Sunset.

- Proximity to school- Our closest students in Elmonica are around 1 mile from Sunset, from my house in Waterhouse North we are 1.5 miles from Sunset. These students and all of Waterhouse North and possibly Waterhouse South are easily walking distance from Sunset High School. Westview is only 2.5 miles from my home, which is still walking distance with pedestrian sidewalks the whole way.
- Safety- Aloha is 4.5 miles away from my house and requires crossing MAXS track, Pacific Rail tracks, and at least one intersection ranked by State Farms Insurance as one of the top 10 most dangerous intersections in Oregon. If you travel an alternative route to Aloha then you cross by the same MAXS tracks, Pacific Rail tracks, and an intersection deemed by the county to be a known problem area. The area is slated for improvements as stated by State Representative Ken Helm at the Public Preview, but he said it is only a medium priority and he does not anticipate any action being taken for at least 10 years.
- Neighborhood Unity- As a result of where we are located between Westview and Sunset we feel a strong community with both of these schools. Obviously, sending our area to Westview, our current High School, would minimize transitional changes. However, our kids would adjust quickly moving to Sunset. Moving our "Blue Peninsula" to Aloha, out of Westview and Sunset boundaries, would cause our area to feel very cut off from our community. We stand out like a sore thumb on the map.

- On the Public Hearing map, the Sunset areas north of the 26, but farther from Sunset then our neighborhood, are bordered by Beaverton boundaries and would have a large community support if they were moved to Beaverton whose new student body will be approximately half former Sunset students.
- Student Composition-There are a few areas that can rightly argue that their home is closer to Sunset, than another school, and that the route to the new school is a less safe commute. However, Elmonica can argue all those points, and is also a title one school that will significantly bring up the very low FRL rate at Sunset, even if Heritage Park is kept at Westview.

I would like to present a map and some thoughts for your consideration. This map shows changes that we feel could contribute to a very strong final map for consideration by the superintendent and board. Much of the work the committee has already done is not changed. While we have studied and listened to the committee and the public about the concerns in the south end of the district, we do not claim to understand that area as well as we do the north.

We would obviously love to keep as much of Elmonica together as possible. This map places most of Elmonica in Sunset minus Heritage Park area, which was requested by Westview Principal. This map is the most impactful for bringing up the FRL rates at Sunset.


If it is not possible to keep most of Elmonica together, please consider placing the 53 Waterhouse North students, due to proximity to schools, safety, and increase in Sunset FRL rate, in either Westview, or Sunset, or split down the green space.

Since the BAC is taking maps made by community members into consideration, we present the following map - *Public Hearing Map Improved* – as a possible solution. It is the same as the *Public Hearing Map*, except for four changes that affect Sunset, Beaverton and Aloha High Schools as outlined below.

- 101 Barnes students (THPRD Nature Park/Millikan area) from Beaverton to Aloha. These students join the 26 Barnes students already in Aloha boundaries on the *Public Hearing Map*, and they are closer in proximity to Aloha than Elmonica is to Aloha.
- 161 Elmonica students (north of Baseline, east of 173rd) from Aloha to Sunset. Elmonica is closer in proximity to Sunset than it is to Aloha (Elmonica's third farthest school). Elmonica is a title one elementary school and brings much needed diversity to Sunset. Even without Heritage Park, Elmonica raises Sunset's low FRL% by several points, giving Sunset its highest FRL% since the Springboard Proposal.
- 27 Barnes students (lining Murray Rd.) from Beaverton to Sunset.
 They are closer in proximity to Sunset than to Beaverton, and just as close to Sunset as other Barnes students already in the Sunset boundary on the Public Hearing Map.
 Ridgewood's westernmost border creates a natural boundary separating these Barnes students from the rest of their elementary school neighbors to the south.
- 199 Cedar Mill students from Sunset to Beaverton.
 The area of Elmonica moved into Sunset is slightly closer to Sunset than the portions of Cedar Mill that have been removed. Also, the farthest area of Cedar Mill from Beaverton (4.8 miles) is closer to Beaverton than the farthest area of Elmonica is to Aloha (5 miles). These portions of Cedar Mill significantly lower the FRL% at Beaverton.

The following analysis of the *Public Hearing Map Improved* focuses on the criteria given to the BAC by the School Board.

- 1. **Availability of Space.** All schools on *Public Hearing Map Improved* are below capacity.
- 2. **Proximity to School.** This map keeps Elmonica, Barnes and Cedar Mill students who are closest to Sunset HS in Sunset. Most of Elmonica is going to their closest school. Most of Barnes is going to their closest school. On this map, the farthest Barnes student in Aloha is 2.2 miles closer to Aloha than the farthest Elmonica student in Aloha is on the Public Hearing Map. No one north of TV Hwy is being sent to the third farthest school from their neighborhood.
- 3. Safety. At the Public Hearing, State Representative Ken Helm provided data from Washington County identifying major problem areas on 170th Ave., the most direct route to Aloha HS from Elmonica. A large chunk of this road is restricted to one lane in each direction, with traffic backing up at Merlo due to the absence of a left turn lane. The other route from Elmonica to Aloha is by taking Walker Rd or Baseline Rd. to 185th Ave. According to a study by State Farm Insurance, the intersection at 185th and SW Baseline is one of top 10 most dangerous in the state of Oregon. (http://www.prnewswire.com/news-releases/seven-of-oregons-10-most-dangerous-intersections-in-portland-state-farm-study-shows-74981032.html) The area around TV Hwy and 185th is one of ODOT's top safety concerns as stated on their website: "The crash rate in this section of TV Highway is very high, and is one of the top safety concerns in

Washington County. Between Jan. 2010- Nov. 2014, there were 176 crashes and 54% of those resulted in injuries." (http://www.oregon.gov/ODOT/HWY/REGION1/Pages/tv185th.aspx)

- 4. **Neighborhood Unity.** *Public Hearing Map Improved* keeps all but one elementary school north of Sunset Hwy intact, as they were on the *Public Hearing Map*. On our map, portions of Cedar Mill would go to Beaverton HS with neighboring West TV students, **creating a larger Beaverton HS community north of Sunset Hwy**. This provides better neighborhood unity for West TV students and Beaverton. Elmonica and Barnes remain split, but the "blue peninsula" from the *Public Hearing Map* that seems disconnected from Aloha's boundary has been eliminated, and Barnes students north of Walker Rd. would not be the only neighborhood south of Sunset Hwy. in Sunset. This is better neighborhood unity for those Barnes and Elmonica students. The boundary for Aloha HS is more compact on the *Public Hearing Map Improved*, resulting in better neighborhood unity for Aloha.
- 5. Transportation Costs. Elmonica and Cedar Mill are both about the same distance from Sunset. The farthest area in Elmonica from Aloha is 5 miles, while the farthest area in Cedar Mill from Beaverton is 4.8 miles. The farthest area in Elmonica from Sunset is 2.9 miles, while the farthest area in Cedar Mill from Sunset is 3.1 miles. Elmonica has a slight edge in proximity over Cedar Mill, but transportations costs would be similar. However, the farthest home in the area of Barnes going to Aloha on this map is 2.8 miles, while the farthest home in Elmonica is 5 miles from Aloha. The THPRD Nature Park/Millikan section of Barnes is much closer to Aloha than Elmonica is. Sending this area of Barnes to Aloha with their closest classmates, instead of portions of Elmonica north of Baseline, would result in a substantial transportation savings.
- 6. **Student Body Composition.** The Springboard Proposal that placed Elmonica in Sunset gave Sunset the HIGHEST FRL % of any map presented by the BAC to date, including the map that puts part of Barnes in Sunset. Elmonica is a title one elementary school and brings much needed diversity to Sunset. **Even without Heritage Park, Elmonica significantly raises the low FRL% at Sunset, almost to the same percentage it was on the Springboard Proposal.** Also, the portions of Cedar Mill going to Beaverton significantly lower the high FRL% at Beaverton.

Please keep the proposal to grandfather juniors.

I did some research about the effect of forcing kids to change high schools and this is what I found. (Each paragraph below is from a separate source.)

- Having a teen change schools during the latter part of high school can have serious academic, social, and psychological consequences.
- Research has consistently shown that students experience both social and academic adjustment problems after switching to a new high school. While one would think that older students would be able to more easily deal with going to a new school, this is not the case at all. Teens more often develop problems. Students who switch schools are less likely to complete high school than students who stay in the same school. Their engagement in school also drops. Students who change high school after beginning their high school career are less engaged; they miss more school, perform more poorly on tests, and complete less homework than students who remain at the same school. It is the disruption in their social life that is likely to bring about trauma and crisis for teens. Because teens are engaged in finding their identity and a stable peer group, changing schools interferes with those processes. Leaving their friends creates significant problems.
- Studies have found a significant relationship between changing schools and both lower school achievement and dropping out. Changing schools during high school had the greatest impact on dropout rates. In some cases, the increase in dropout rates associated with changing schools was as large as 30%. Research suggests interactions among changing schools, involvement with the criminal justice system, and lower academic achievement.
- Doctors and educators are finding that changing schools is harder on kids than previously thought. And it's not just academic performance that is at risk. There's a clear association between changing schools and an increased risk for behavior problems. Kids want stability. It's very disruptive for them to change schools. Changing schools should be looked at especially long and hard, particularly during the tumultuous high school years.
- There's strong evidence that changing schools can put a teen at higher risk of dropping out of high school and of academic and behavior problems. The best advice, experts say, is to avoid moving a teen from one school to another.
- Teens who change schools do worse on exams than peers who do not. Grades decline and poorer teens suffer disproportionately.
- A teen who has worked hard to excel in sports, theater, or music may find it impossible to participate in the same way at a new school. If the teen can stay at the current school, it is a positive choice in terms of the teen's mental health.

Please do not force juniors to change schools. Please retain the proposal to grandfather juniors. Juniors' futures should not be sacrificed in order for the new high school to have a varsity sports program or a good band in the first year it opens. Juniors should not be forced to change schools just so that underclassmen at the new school can see juniors walking down the halls in the first year the school opens. The effect of changing schools on juniors is traumatic and their mental health is more important than making sure that the new high school has every single

extracurricular activity in the very first year it opens. Give juniors a better chance to succeed by allowing them to stay at their current schools.


