It is our hope that Mr. Grotting and the DIstrct will review the transition of the class of 2020 piece again as the boundary committee was not given enough time to look at various scenarios to allow this group of students to stay where they start high school. After attending ALL the boundary meetings it was clear to me the committee was not allowed the time, nor were they given the resources to fully examine this important issue. It appeared Mr. Rose did not fully understand the issue when questioned about it by the board. It was deemed that the new high school would open with sophomores and making the class of 2020 transition was the only way. That is not correct, nor is it remotely fair or good for those students.

My daughter is a freshman this year. The transition to high school has been by far the most challenging thus far. There is so much to learn about her school and I expect it will take the majority of the year for her to find where she fits in, which sports to try, which clubs to join and which teachers she can trust at high school. These students are at a very vulnerable stage of their youth as the pressure of school is much greater than at any other time, and not just academically. Social pressures, work/home demands and sports/club connections are the most intense as well. I see how absolutely important it is for kids to plant their seed their freshman year from where they can really start to grow.

It is irresponsible to ask these kids to start over and go through all of this again after such a tumultuous freshman year. As leaders of this district, you must put EVERY child's needs first. The class of 2020 is not a sacrificial lamb to meet numerical needs at a new school. We suggest that you allow just the these students to CHOOSE which school they attend next year and declare their choice by January or February of 2017. There might be some adjustments to make, but the students and district will gain so much by allowing students and parents to have a choice. The new school will still open with sophomores and I bet it will be a large class seeking the new school. It is just one year of adjustments and even the district can manage one potentially awkward year.

Portland School District recently underwent a high school boundary process for their west side schools. They grandfathered students all the way down to 6th grade! You can't tell me making children transition to high school twice is the best option for our district and most importantly our students' futures. Please, I beg you as a mother and one time high school student who somewhat remembers the pressure cooker called high school, please reconsider transferring the class of 2020. Superintendent Grotting,

I am a Findley/Stoller/Sunset parent, not directly impacted by the new HS boundary proposal but severely impacted by overcrowded schools. The task to redraw BSD school boundaries is very challenging and the proposed boundaries are creating major angst in many communities as school boundaries impact people's way of life. However, change is inevitable and our kids are very resilient, we should not underestimate our kids. I wish some parents put their energy on embracing change rather than fighting to stay the same. That said, the HS Boundary process lacked feedback to the community on decisions' rationale. The community still doesn't understand why some ideas are rejected and the rationale behind proposed map.

My main concern at this time is the lack of a district-wide view that comprehends all boundaries. It seems to me that we shouldn't draw new HS boundaries in isolation from new ES and MS boundaries. By now, BSD has a good enough HS boundary proposal with some minor changes needed. We are starting an ES Boundary discussion that seems "lazy" as it only impacts Springville and Jacob Wismer. Why aren't we taking the opportunity to address the new ES split (Oak Hills) caused by the new Sunset HS Boundary? Additionally, Findley ES is also overcrowded and BSD seems to ignore that fact by not including Findley in the new ES boundary conversation. There could be other scenarios/situations that I am not aware but the district should look at.

New Middle School Boundaries should also be understood as we create the ES boundary and finalize the HS Boundary. I know drawing new boundaries is very challenging but it seems BSD is taking a very easy route by not looking at this holistically to optimize large areas when given the opportunity. It raises the question...are we taking a long term view of this process? We should have data that tell us where the future growth will be, where is the most likely area of a 7th HS and new schools, and draw boundaries taking this into account. Please take a long term approach...not just new schools (5 yr view), think strategically on how Beaverton will grow in 10-20 years. I know it is easier said than done...someone must do it.

Dear Superintendent Grotting, Mr. Phillips, Mr. Mead, and Mr. Sparks, and Mrs. Kister,

Thank you for all of your hard work on the new high school boundary adjustment process. I live in the Oak Hills neighborhood and have 17 and 14 year old sons who proud members of the Westview community. They have both enjoyed enriching and rewarding at each of the schools that they have attended within the Beaverton School District.

I am very concerned about the current transition plan. My 14 year old son has been a proud and enthusiastic "Wildcat" since kindergarten. He has participated in Westview youth sports, cheered for his brother on both youth and high school teams, and has been attending high school activities, plays, fund raisers, and sporting events at Westview with our community. The current transition plan will pull him out of this community and place him into Sunset High School where he will be isolated from his social support groups, both peers and adults. Out of the 2017/2018 Sunset sophomore class, only 2% will be kids from Oak Hills. Only 9% of the total Sunset population will be from Westview. These Oak Hills sophomores won't know any of the upperclassmen. Not only will their high school experience be impacted socially, they will also be greatly impacted academically which will in turn, affect their grades, test scores (SAT, ACT, SBAC) and college applications. Research shows that students are the most vulnerable socially when they enter high school. They rely nearly solely on their friends and need those deep bonds to help them make good choices, feel connected to their community and to be successful academically. I am very concerned that these children, which includes my son, will be separated from their elementary and middle school peers with this proposed change. A recent University of Florida study (Ferrer and Fugate, June 2014) states, "Children tend to have better attitudes about school and learning when they have their good friends there." Less than 15 freshman from Oak Hills will be forced to make this transfer to Sunset. This small group of sophomores will be losing the majority of their academic community. They will also be isolated from the broader communities that many have built relationships with since kindergarten, which includes peers, and supportive adults including friends' parents and coaches. Transitioning from middle school to high school is hard enough for adolescents. This plan has these students changing schools three times in as many years. The current transition plan has placed an emphasis on the students of 2018, 2019, and 2021. The class of 2020 is left to deal with the impact of these changes in isolation.

There is an abundance of research that supports the relationship of academic success with social support, and the challenges of transitioning during adolescence:

- NEA Today, July 29, 2015 states, "Changing Schools often can be detrimental to normal adolescent development by disrupting relationships with peers and educators as well as altering a student's educational program. Effect of student mobility can be seen on test scores and high school graduation rates."
- NCBI (National center for Biotechnology Information) article "Switching Schools: Reconsidering the Relationship Between School Mobility and High School Dropout", June 2012 states,
- "Changing schools can affect educational achievement in many other ways. In addition to severing relationships between children and local neighborhood adults (and breaking ties between parents and the parents of their children's friends), changing schools alters important connections to teachers, peers and extracurricular opportunities and can disrupt instructional practices."
- PsychCentral article about moving with teens from 2016 states, "Unlike younger children, for whom the family is

the center of their universe, teens are at the state of life where they are beginning to separate from the family. A move at that time either can push the teen back into a more dependent stage he or she can't tolerate or may artificially accelerate an independence he or she isn't ready for."

- "High School Transfer Student Transitions and Changes" Benjamin M. Grain of Loyola University Chicago, 2011 stated student worries and fears when transitioning to a new school included, "A strong sense of anxiety, results from newfound anonymity." This research also stated, "high school peer group association is far more influential than the family or the school."
- A research report entitled, "Support Student Transition from Middle to High School" for SEDL, a nonprofit educational research organization cited multiple reasons why transitions are challenging including:
- "In addition to factors such as a larger environment, increased academic demands, and reduced personal support (Smith, 2007), students also face social challenges—both real and perceived—as they move to high school, including harassment or teasing by older students, reestablishing popularity, and difficulty in making new friends."
- "The transition from one school to another can be challenging for many students and their families, particularly when it involves moving to a different building and losing the familiar routines and long-established social support systems."
 - "Social issues such as peer relationships, bullying and getting lost overshadow concerns about academics."

I hope you will see that we are in a very unique situation. I urge you to reconsider the transition plan to allow the current Oak Hills Freshman the option to continue at Westview so they can graduate with their peers in the class of 2020.

I greatly appreciate all of your time and effort in this matter. Thank you!

Dear Superintendent Grotting, High School Boundary Listening Board, and School Board:

Our family lives in the Waterhouse South neighborhood, the area recently designated as Area #4. We have two sons, a 3rd grader and a 6th grader, that will be directly impacted by the High School Boundary process. We were in attendance at the public comment meeting at Westview High School on Tuesday, September 13, 2016, as well as many of the other meetings during this process. We support the comments that the four members of our neighborhood made at the September 13th meeting. We strongly oppose moving our neighborhood from Westview to Aloha High School, primarily due to proximity and the impact this change will make on our neighborhood unity.

Aloha High School is much farther away from our neighborhood than either Westview or Sunset High Schools. Aloha is the third, or fourth, farthest school from our neighborhood. For some in our neighborhood, Beaverton High School is the same distance or closer than Aloha High School. The routes to Aloha High School are significantly more dangerous and congested than the routes to either Westview or Sunset. Westview and Sunset, even though being across Highway 26, provide quick and safe travel by car, bike or foot from our neighborhood. If our neighborhood must be moved from Westview, we ask that the change be to the closest high school to the neighborhood, Sunset High School. Aloha, besides being further away, does not have a safe walking or biking route from or neighborhood. Our family is very active, we often go on extended walks or bike rides together through our local neighborhoods. We have safely traveled the paths and roads towards Westview and Sunset High S chools. It will become even easier and safer as the Tualatin Hills Park & Recreation District completes and unifies the Waterhouse Trail, which runs through the middle of sections #3 and #4. We recently attempted to ride our bikes to a restaurant near Aloha High School. We tried different routes along both 170th and 185th, but determined that there was no safe route - not for adults and definitely not for children. Additionally, We've been witness to several severe accidents, or their aftermath, along these routes. These accidents include pedestrians hit by MAX trains and cars going off the road on 185th killing pedestrians, drivers, and passengers. We are against transferring our neighborhood to Aloha High School due to the distance and lack of safe routes to the school.

We also are opposed to the switch because of the impact of longer travel times to Aloha High School. Buses and students in private transportation will be delayed as they have to cross two sets of active train tracks every day. Students will lose time commuting. There will be more obstacles to participate in extracurricular activities and for families who want to volunteer to support their student's school. The impact on extra curricular activities will begin in elementary school because sports teams and practice fields, even at elementary age, are determined by High School boundary.

Moving our neighborhood to Aloha High School will have a severe impact on our neighborhood unity and the unity and health of Elmonica Elementary. When looking at the map proposed by the High School Boundary Committee, our area is often referred to

as the Blue Peninsula, but it is actually an isolated Blue Island due to the geography of our neighborhood. The area immediately to our south on Baseline, which with good reason is the current school boundary for both Elmonica Elementary and Westview Elementary, physically cuts us off from the Aloha neighborhoods to the south. Baseline is strong natural boundary with the Tualatin Hills Nature Park, St. Mary's Power Station, Trimet train yard, Elmonica Park and Ride, MAX tracks and crossings, Merlo Station Athletic Fields, and light industrial buildings separating us from the neighborhoods to the south. For these reasons we consider our neighborhood to be a part of the neighborhoods to the north, even on the other side of Highway 26. It is easier to cross Highway 26 via 185th or Cornell Road to shop, to go to the library, play in the park, or to go to soccer practice, than it is to cross over Baseline and TV Highway via 170th or 185th.

The Blue Island isolation is extremely severe and senseless if only area #4 is moved, keeping area #3 with Westview. My family walks across Walker Road on foot or bike daily. We travel the nature paths, visit friends, walk to Fred Meyer and surrounding stores for shopping and entertainment. That is our neighborhood. To arbitrarily carve off our small section to send them to a school that is the 3rd or 4th farthest High School is not justifiable if distance to school and neighborhood unity are the decision criteria. Even if areas #3 and #4 are kept together and both moved to Aloha, all that is done is enlarging the Blue Island slightly, but maintaining the isolated Blue Island. This larger Waterhouse neighborhood is still physically cut off from the rest of the proposed Aloha High School community to the south as described above. The other sides of our new island are bordered by the Westview and Sunset attendance areas, and Nike World Headquarters campus (assigned to Beaverton High School attendance area).

The proposed boundary splits our Elmonica Elementary attendance between Westview and Aloha High Schools. We strongly support keeping the Elmonica students together from elementary school through high school. This provides a stable and secure learning cohort, especially important in a Title I environment. Another important, long-term impact this change would have on Elmonica Elementary is to its parent volunteer base. We were parent volunteers for the five years our older son attended Elmonica and can testify to the fact that Elmonica struggles to get parent involvement. If our small neighborhood is carved out and separated, we are afraid that families with school age children will move out and not be replaced. The impact this will have on Elmonica is significant. The parent volunteers at Elmonica come overwhelming from areas #3 and #4.

We thank you for the additional time and consideration you are putting into this process and looking at the concerns of the Waterhouse neighborhoods.

Thank you for considering moving our neighborhood (Area 3) back into the boundary for Westview High School, and thank you for your willingness to meet with community members. We look forward to our meeting with you on September 15.

Following is the proposal we mentioned in our public comments. It starts with the Phase II map and makes a small change:


- 1. **Return Area 3 to Westview High School** (as considered in the Aug 22 analysis)
 - This better follows the **proximity to school** criteria from policy JC.
 - Of the three areas you are considering moving back to Westview, Area 3 is the closest to Westview and the farthest from Aloha. In fact, we're farther from Aloha than all Elmonica students, including the significant number south of Walker Road that remain in the Westview boundary.
 - Unlike Areas 2 and 4, all of the residences in Area 3 are inside the proximity circles for Westview and none of the residences are in any of the proximity circles for Aloha.
 - It means lower **transportation costs**, as shown by the BSD's August analysis.
 - It better follows the **neighborhood unity** criteria from policy JC.
 - Area 3 is separated from the rest of Elmonica neighborhoods by Walker Road, currently being widened to five lanes in order to handle growing congestion. Our students ride the bus to elementary school because Walker Road is deemed a "hazardous area" according to BSD transportation policy.


Returning Area 3 to Westview would result in 100.8% capacity; a reduction of almost 9% from the current enrollment. If 100.8% is not acceptable, please consider an additional move that would bring capacity at Westview to under 100%, while better satisfying the school board's criteria from policy JC.

- 2. Move 32 Elmonica students living south of Walker Road and west of SW 173rd from Westview to Aloha. (These students live to the immediate west of the neighborhoods labeled Area 4 on your analysis. We call this Area 5 on the following page.)
 - It would free up enough space to return Area 3 to Westview, while keeping Westview below 100% capacity, therefore satisfying the **capacity** criteria from policy JC.
 - It better follows **proximity to school** criteria; Area 5 is closer to Aloha than is Area 3.
 - It better follows the **neighborhood unity** criteria. According to the school board, neighborhoods are to be divided along major arterial roads and by areas where backyards butt up against one another, but without through roads connecting those neighborhoods.
 - No through roads connect Area 5 with Elmonica neighborhoods to their west.
 - Area 5 students currently walk through Area 4 to Elmonica. Further, with the recent construction of SW 170th, SW 173rd is no longer an arterial road.

There are many other ways to return Area 3 to Westview or to Sunset (our closest high school). We believe this swap causes the least amount of disruption to the Phase II map, while better applying the criteria. Thank you for your consideration.









Map with Areas of Consideration and Proximity Circles

Superintendent Grotting,

Following up on my transportation safety email, this email corrects Superintendent Rose's statements in "SUPERINTENDENT'S HIGH SCHOOL BOUNDARY ADJUSTMENT DECISION" concerning school bus safety and validates the use of Crash Rate by the School Boundary Explorer to quantify school transportation safety. School bus crash rate, in fact, is similar to car crash rates even though the fatality rate of school bus occupants is lower than for cars.

"SUPERINTENDENT'S HIGH SCHOOL BOUNDARY ADJUSTMENT DECISION"

section "Criterion: Safety" incorrectly states: "Studies confirm students are at least 8 times safer in a school bus than when riding in a personal vehicle. Over 25 million students ride school buses each day in the U.S. without any serious accident."

These are misquotes from the executive summary of "The April 2002 Report to"



Every year, our nation's 450,000 public school buses travel more than 4.3 billion miles to transport 23.5 million children to and from school and school related activities.

...

American students are nearly eight times safer riding in a school bus than with their own parents and guardians in cars. The fatality rate for school buses is only 0.2 fatalities per 100 million vehicle miles traveled (VMT) compared to 1.5 fatalities per 100 million miles in cars.

...

Over the past 11 years, school buses have annually averaged about 26,000 crashes resulting in 10 deaths (per year).

Because of the National Traffic Safety Administration's focus on prevent traffic fatalities, their standard of safety is preventing death. The standard of safety for the Beaverton School District is preventing crashes. Many serious school bus crashes, injuries, and fatalities are reported each year, contrary to Superintendent Rose's assertions.

School bus crash and injury rate is similar to automobile crash and injury rates according to this study. The National Traffic Safety Administration quantifies school bus safety using crash rate, the same method used in the School Boundary explorer. This study finds that nationally, the school bus crash rate is 6 per million miles traveled. For comparison, the crash rate for all traffic through Beaverton is 4.70 per million miles traveled for Highway 217 and 0.38 per million miles traveled for Highway 26. Therefore, school bus crash rate is comparable and possibly higher than the crash rate of all vehicles. For school bus crashes, 37% result in injury to bus occupants. For automobile crashes in Beaverton, 46% result in injury, which is again similar to school buses.

Clearly Superintendent Rose's references to low school bus occupant fatalities does not satisfy our community's expectations for our children's safety. When I place my children on a school bus and expect them to arrive safely at school, I expect there to be no accidents, no injuries, and no fatalities. Based on "The April 2002 Report to Congress "School Bus Safety: Crashworthiness Research", a school bus is no more likely to avoid an accidents than a car. The only solution is, as mandated by the school board, to assign students to the schools with the safest routes.

Dear Superintendent Grotting, Mr. Phillips, Mr. Mead, Mr. Sparks, and Boundary Committee,

I would like to thank you for the time you have dedicated to considering public input to this process. My husband and I attended both the Sunset and Westview meetings with a group of Oak Hills parents and students, including our son, Connor -- a member of the class of 2020 and a current freshman at Westview. It is difficult to balance the factors of this decision, and I appreciate your willingness to listen to our concerns.

We have lived in the Oak Hills neighborhood since Connor was in preschool. We also have two daughters -- a 6th grader at Meadow Park and a 2nd grader at Oak Hills Elementary. All three children have deep friendships with students on both sides of Bethany Blvd. They enjoy experiences together both inside and outside of school -- from school projects to sports teams, marching band and volunteer activities. Their relationships with students on the west side of Bethany are just as strong as those east of Bethany. Yet only 2 percent of the Sunset sophomore class will be comprised of Oak Hills students and the numbers do not improve much in future years once other "grandfathering" clauses expire. The current boundaries create an island of ~20 kids per grade level that will be isolated from their social and support network once they go to high school.

We are most concerned about Connor who is slated to transfer to Sunset for his sophomore year under the most recent plan. We feel that removing him from the community of academic and social support that he has built over the last decade would be detrimental to him. Our "feeling" is backed by several research articles, including one from the National Center for Biotechnology Information, "Switching Schools: Reconsidering the Relationship Between School Mobility and High School Dropout", June 2012. It states, "Changing schools can affect educational achievement in many other ways. In addition to severing relationships between children and local neighborhood adults (and breaking ties between parents and the parents of their children's friends), changing schools alters important connections to teachers, peers and extracurricular opportunities and can disrupt instructional practices."

Additionally, we can't help but notice that the current President of the United States plans to break with tradition and stay in Washington DC so that his current sophomore can finish high school where she started. We agree with President Obama - it just makes sense to let students remain within their academic and social networks to keep the relationships with teachers, coaches, teammates and friends intact.

For the girls, we have more time to get them involved in activities that will broaden their academic and social networks, but it will be a challenge. For example, of the 36 students in our daughter's 6th grade Summa class at Meadow Park, only 4-5 would go to Sunset with the current boundary proposal. A few more from her band classes would attend Sunset but the overall pool of students she would know remains very small. Changing the boundary to return Oak Hills Elementary students to directly feed to Westview would mean that they could join a high school with the students they know from school and extracurricular activities.

Dear Superintendent Grotting,

Thank you for your continued leadership and support in the High School boundary decision process. Last night's session was very eye opening, and I appreciate having the opportunity to be heard and to listen.

There were two very important themes that came to light last night that I want to elevate, in your continued consideration of the situation regarding the small fraction of the Oak Hills community that is being split off from the whole. These two themes are the use of major arterials and the special considerations made to keep Elementary Schools together as single feeder schools. These are the facts that were elevated last night in light of these two factors:

- 1. The use of a major arterial (not a core principle for the decision making) for defining the boundary that sacrifices neighborhood unity at Oak Hills ES, which IS a core principle of the decision process
- 2. the special consideration made to keep Raleigh Hills ES together as a single feeder school
- 3. the special consideration made to keep Montclair ES together as a single feeder school
- 4. I believe Tori mentioned one additional neighborhood situation where special consideration was made to keep the Elementary School together, and trumping the walkability factor in doing so, and
- 5. The fact that the Oak Hills decision neglected all of these special considerations in the current proposal.

It was emphasized, and reemphasized throughout last night that there were special considerations made for multiple Elementary Schools within our district, to keep them whole as a feeder school to a single High School. This point was made by multiple members of the committee, including Todd Corsetti and Tori Pontrelli.

I ask that Oak Hills be given this same consideration. I am still extremely concerned with the lack of critical mass being moved from the Oak Hills-Westview feeder to create a new Oak Hills-Sunset feeder. In fact, I am quite envious of the schools where 30-40% movement is happening. In this case, whole communities and schools are being reassigned, and having this critical mass size-wise of support with a student body is so beneficial when significant boundary changes are being considered. If our entire Oak Hills ES community was being reassigned to Sunset, there would not be this issue.

By the fact that a very small portion of this community, less than 20 children of a school of 100-120 are being singled out and reassigned lacks clear reasoning to me. I can understand that, at a high level glance of the map, Bethany Blvd creates a new "easy line" arterial boundary, but when you dig in to look at the specific impact of drawing that 'easy line' it is clear this was a suboptimal line drawn.

I got the sense from John Huelskamp that this was a very quick, and possibly not well thought out decision to default to using this major arterial as a quick fix, easy boundary line. 143rd has been the major arterial and to move it over a few blocks to Bethany Blvd and create such division within an Elementary School community is inappropriate. I was pleased to hear that special consideration was given to keep other Elementary Schools together, and made a higher priority over walkability. Creating an arterial boundary is NOT one of the criterial to be used in this process, and drawing an artificial boundary that in effect divides an Elementary School community so lopsidedly. It is too divisive; it is not right and needs to be rectified.

The freshman class of Westview that is from Oak Hills and would be reassigned to Sunset is approximately 15 children: 8 boys and 7 girls. This represents 0.5% (less than 1%!) of Westview's capacity. Extremely nominal.

Please do not rip apart our community for the sake of 0.5%



Before I get into my spiel, I need to thank you all for volunteering for this very hard position in the community. I know it brings a lot of stress and anxiety from all the angry parents. I know you want all of the families and communities to be happy, and do what is best for the district as a whole. Again, I understand that these decisions that are made are made in the best interest for the parents and kids. Finally, I'm a 9th grade student writing this. The first group of kids that will be affected by this, because in the end, it's the students who are affected the most. I feel my opinion should be heard

I am from the Oak Hills neighborhood. My parents moved here when I was just 2 because they liked the community that I would be surrounded with. They were right. The past 10 years with the kids who went to elementary school with me have been the best of my life. Now, what will happen at the turn of the year is those of us in the Oak Hills Neighborhood will be forced to go to Sunset. And based on the population of Oak Hills roughly 20 kids should go to Sunset. However based on the amount that will stay at Westview because of reasons like being grandfathered in, varsity sports, AP classes, and administrative transfers shrinks 20 into around 11-12 kids. And these aren't the only friends I lose, I also lose the friends I have made through Meadow Park and the friends I will make this 9th grade year. The worst part about all of this is after I've been switched to sunset, and lost most of my friends, your chances of being in classes with any friends there goes down dramatic ally. I don't like my chances.

That reason might seem kind of dumb because "it's just about friends" but really, it isn't. I know just saying that it isn't doesn't give you a much better viewpoint on it, but just hear me out. Last year when I was in the class that I struggled with most (Algebra II), My teacher noticed that I seemed to work a lot more efficiently and got better test grades when I sat in a table group with my friends. I feel like this is because learning is more fun when you are next to some of your friends so you can remember the things you did that day better.

Next, I would like to address the proximity issues. On the boundary chart it says we are in walking distance, which is true. However, we may be in walking distance but the main problems here are time and back pain. I've walked to the Sunset Athletic Club a few times to go play basketball or workout with friends, and to get there it takes about 30 minutes when carrying less than 5 pounds of weight. However, when I put my backpack and trumpet on a scale, it works out to be around 25-35 pounds depending on whether I have books in or not. And studies have shown that carrying over 20% of your body weight can damage your spine or cause back pains, "Your spine isn't all that's in jeopardy. The soft tissue around it — supporting structures like ligaments and paraspinal muscles that attach to the spine — suffer a decreased range of motion" So obviously our parents aren't going to let us walk to school, we will just cause a bigger clog in the morning with all the cars, buses, and kids coming into sunset.

Finally, the last problem I would like to address with this is the fact that I don't see much point of being involved with westview. Because by going into extracurricular activities, sports, theatre, etc. All you are really doing is just making more relationships that
