Kristin Dietz, Vice President of EdTec, and Financial Business Manager of the FCPS, presented the following information:

- Consolidated net income is now \$2.96M, a slight increase from the previous forecast of \$2.95M mainly due to the following:
 - Increased non-capitalized equipment (\$76K)
 - \circ Decreased utilities per trend in actuals (\$76K)
 - o Increased contracted security (\$57K)
 - Decreased other miscellaneous operating expenses (\$26K)
- Cash balances and overall fiscal health remain very strong with all sties expected to end the year with positive cash balances

As for the 2021-2022 proposed budgets, all sites are showing positive net income:

- Consolidated budgeted net income for 2021-2022 is \$1.77M
- Reminder that a large portion of the ESSER II funds is earmarked for staff at FACS and FPC (see page 17 for the "theoretical" budget)
- Revenue assumptions and staffing assumptions are on pages 18-19
