Morada Middle School is located in North/East Stockton. Morada serves a very diverse population of 7th and 8th-grade students on a Modified traditional calendar. It operates on a 6 period day with classes, including ELA, math, social studies, science, PE, elective courses. The elective courses offered are Band, Strings, Choir, Science Elective, Computer, Leadership, AVID, and Mechanical Drafting, Art, Journalism,

Morada provides additional assistance to students in the morning and after-school Bridge Program. Athletics are offered via the Bridge Program. Our PBIS focus is SPIRT: Social Responsibility, Prepared, Initiative, Respectful, Integrity, and Take Ownership.

Our mission is to address the physical, social, intellectual, and emotional needs of students at this crucial age through a variety of instructional techniques, strategies, and interventions. Students are all provided with a daily planner to monitor daily assignments. Students are taught strategies to assist in daily assignments and test-taking techniques.

## School Facility Conditions and Planned Improvements

### AGE OF SCHOOL BUILDINGS:

Morada Middle School was built in 1965.

### MAINTENANCE AND REPAIR:

The Morada Middle School facilities' condition, including grounds and restrooms, are very good based on custodial staffing, a regular district painting and maintenance schedule and funding available for equipment and supplies. Custodial workers are assigned based on a district formula to ensure equity. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

### CLEANING PROCESS AND SCHEDULE:

A scheduled maintenance program is administered by Lodi Unified School District to ensure that all classrooms, restrooms and facilities are well-maintained and in good repair. Staff works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. Schools administered the Smarter Balanced Summative Assessments for ELA and mathematics, other assessments that meet the SBE criteria, or a combination of both, and they could only choose one of the following:

- Smarter Balanced ELA and mathematics summative assessments;
- Other assessments meeting the SBE criteria; or
- Combination of Smarter Balanced ELA and mathematics summative assessments and other assessments.
