## School Facility Conditions and Planned Improvements

### AGE OF SCHOOL BUILDINGS:

Beckman School sits on 10 acres and was completed in 1989. Three portable classrooms were added in 1998 and 1999 for class size reduction. There are 12 total portables; one relocatable restroom building; 14 regular classrooms; a computer lab; RSP room; library; preparatory kitchen; multi-purpose with stage and music room; administration building.

### MAINTENANCE AND REPAIR:

The Beckman School facilities' condition, including grounds and restrooms, are very good based on custodial staffing, a regular district painting and maintenance schedule and funding available for equipment and supplies. Custodial workers are assigned based on a district formula to ensure equity. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

### CLEANING PROCESS AND SCHEDULE:

A scheduled maintenance program is administered by Lodi Unified School District to ensure that all classrooms, restrooms and facilities are well-maintained and in good repair. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

## B. Pupil Outcomes

### State Priority: Pupil Achievement

#### Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

#### Options

Note that the CAAs could only be administered in-person following health and safety requirements.
