<u>Public Hearing on 2021-22 Budget</u> - Dr. Kimberly Rio, Assistant Superintendent for Finance reviewed the tentative budget timeline. On November 18th the recommendation for the tentative tax levy was reviewed, tonight is the Public Hearing for the Tentative Tax Levy and on December 16, 2021 will be the recommendation for the final tax levy approval. The total levy is at 2.4% which is a total dollar amount of \$29,444.099. We will continue to monitor the equalized assessed values of residential, commercial and industrial. We continue to monitor new development and the impacts of those on enrollment and pertaining to our economic landscape. The new 2021 property tax levy law under Public Act 102-0519 requires the Cook County Treasurer to certify by November 15th the amount of property tax revenues lost due to appeals. More information will be forthcoming on the new property tax law once it is available.
