

**ARTICULATION AGREEMENT BETWEEN
THE SCHOOL BOARD OF LAKE COUNTY, FLORIDA
AND SCHOOL BOARD OF PASCO COUNTY, FLORIDA
FOR THE MARCHMAN TECHNICAL COLLEGE**

THIS AGREEMENT is entered into by and between The School Board of Lake County, Florida, whose address is 201 West Burleigh Boulevard, Tavares, Florida 32778 (hereinafter referred to as the "LCSB"), and School Board of Pasco County, Florida, whose address is 7227 Land O' Lakes Boulevard, Land O' Lakes, Florida 34638 (hereinafter referred to as "PCSB").

NOW, THEREFORE, in consideration of the mutual benefits accruing to the parties to this Agreement, and for other good and valuable considerations, the receipt of which is hereby acknowledged, the parties agree as follows:

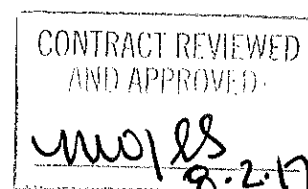
1. Purpose: The purpose of this Agreement is to permit students who complete the Television Production Program (8772100) at East Ridge High School, Eustis High School, and Lake Minneola High School as well as the Commercial Art Technology Program (8718000) at Lake Minneola High School to receive postsecondary credit in the PCSB Marchman Technical College Digital Cinema Program (K100100) and/or Commercial Art Technology Program (I480203).

2. Course Credit: PCSB agrees to extend four hundred fifty (450) hours of credit towards the Digital Cinema Production program, at no cost other than the application fee for admission, to eligible students who have completed the Television Production Program at Lake County Schools. PCSB agrees to extend four hundred fifty (450) hours of credit toward the Commercial Art program, at no cost other than the application fee for admission, to eligible students who have completed the Commercial Art Program at Lake County Schools.

3. Student Credit Transfer: The students receiving transferring credits must achieve a minimum GPA of "C" or better in either Commercial Art 1, 2, and 3 or Television Production 1, 2, and 3, and provide an official signed copy of their student transcript to the Marchman Technical College. In order to have these Marchman Technical College courses recorded on an official Marchman Technical College transcript, students must meet regular Marchman Technical College entrance requirements and complete the Marchman Technical College application and pay the application fee.

4. Terms: The initial term of this contract will commence upon execution of contract and shall remain in effect for three (3) years. It may be renewed for a three (3) year term, based upon mutual agreement of the parties, until otherwise terminated by either party as provided herein. Any mutually agreed upon changes will be by written amendments and will be effective at the beginning of renewal date.

This Agreement may be cancelled at any time by either party with thirty (30) days written notice. Students enrolled at Marchman Technical College under this Agreement at the time of termination shall be entitled to complete and receive credit for the enrolled courses.
