MINUTES OF THE SCHOOL BOARD REGULAR-ORGANIZATIONAL MEETING

A. CALL TO ORDER

Chairperson Hennen called the meeting to order at 7:00pm. All board members were in attendance including Amy Hennen, Tony Easter, Sarah Bowe, Michael Kreun, Marilyn Forsberg and new board members Sam Villella and Melody Skelly, along with Superintendent Dr. Jeff Ronneberg and student representatives Ellie Jeppson and Bella Sciara.

B. AGENDA APPROVAL

Motion by Easter, seconded by Bowe, to approve the agenda as presented. Motion carried unanimously with all members voting yes. (7-0)

C. OATH OF OFFICE

Chairperson Hennen administered the oath of office to new board members Sam Villella and Melody Skelly who were elected to the board in the November 2021 school board election, starting their 4-year term January 2022.

D. ORGANIZATION OF BOARD

1. Election of Chairperson

Nominations were called for the position of Spring Lake Park Schools School Board Chairperson. Hennen was nominated by Forsberg. No further nominations were made. By acclamation Hennen was re-elected School Board Chairperson for 2022 and assumed the Chair.

2. Election of Vice-Chairperson

Nominations were called for the position of Spring Lake Park Schools School Board Vice-Chairperson. Easter was nominated by Hennen. No further nominations were made. By acclamation Easter was elected School Board Vice-Chairperson for 2022.

3. Election of Clerk

Nominations were called for the position of Spring Lake Park Schools School Board Clerk. Forsberg was nominated by Bowe. No other nominations were made. By acclamation Forsberg was elected School Board Clerk for 2022.

4. Election of Treasurer

Nominations were called for the position of Spring Lake Park Schools School Board Treasurer. Bowe was nominated by Forsberg. No further nominations were made. By acclamation Bowe was elected School Board Treasurer for 2022.

5. Board Parliamentarian

Nominations were called for the position of Spring Lake Park Schools School Board Parliamentarian. Kreun was nominated by Easter.

Motion by Easter seconded by Bowe to designate Kreun as the Board's Parliamentarian who shall rule on all parliamentary procedures and questions. Motion carried unanimously with all members voting yes. (7-0)

E. ADJOURNMENT OF THE REGULAR-ORGANIZATIONAL MEETING

Motion by Forsberg, seconded by Easter to adjourn the meeting. Motion carried unanimously with all members voting yes. (7-0) Meeting adjourned at 7:06pm.
