

APPLICATION (Madison Residents Only) Early Entrance to 5-Year-Old Kindergarten

(**Acceptance of applications begins in *March* (no earlier) of a given school year. All applications must be received *prior* to August 1 of a given school year**)

To request early entrance into five-year-old kindergarten parents/guardians MUST complete this <u>application</u> and submit all required verifications/documents with the application. Requests must be received by August 1. No applications will be accepted/approved after August 1st.

As the Madison Metropolitan School District (MMSD) Board of Education policy (4011) indicates, children must be five years of age on or before September 1 to attend five-year-old kindergarten. The only exceptions are:

Students who turn five-years-old between September 2 and October 15. <u>Applicants must submit verification of the student's birth date (birth certificate or medical record)</u>. Such students will only be considered for early entrance into five-year-old kindergarten upon parent/guardian request.

This is the only criteria for early entrance to Kindergarten for which students may be assessed, unless otherwise determined by MMSD staff early entrance authority. Assessment for this criteria is **optional and not required. It is provided to families as a piece of information about the student for which the application has been submitted.**

- Students who have completed a formal four-year-old kindergarten program. (See the Early Entrance webpage for specific requirements and additional information.)
- Students who were admitted into five-year-old kindergarten in another public school district prior to moving into the Madison Metropolitan School District. Applicants must provide verification of enrollment and actual attendance in five-year-old kindergarten.
