California’s 2021–22 Budget Act, the federal American Rescue Plan Act of 2021, and other state and federal relief acts have provided local educational agencies (LEAs) with a significant increase in funding to support students, teachers, staff, and their communities in recovering from the COVID-19 pandemic and to address the impacts of distance learning on students. Parents were surveyed multiple times about the needs of their learners. The needs that have been identified through the surveys included the need for more ELL support, academic intervention, and support with the learning loss created by the pandemic. When surveyed, the facilitators expressed similar concerns. All community stakeholders had the opportunity to participate in the open board meeting for the adoption of the ELO Grant Plan and the LCAP, which includes the ESSER funds.

The information that was gathered from the surveys and the formal and informal feedback sessions with parents and facilitators was used in a multitude of ways when developing the plan.

One success was increasing the instructional coach time to 20 hours per week. The instructional coach observes facilitators, and reviews data to provide facilitators with on-going feedback. This includes feedback on effective instructional practices that directly effects learner outcomes. In addition, the instructional coach reviews data with the facilitators and develops plans to improve learners overall academic performance.

One challenge that ACLC experienced was hiring an full time ELD Coordinator. While still actively recruiting, this role has yet to be filled. To support the needs of the ELL's while in the search for this role, ACLC has increased the time of another qualified staff member. This has allowed for services to begin for the ELL's, though not in the original manner it was outlined in the LCAP.

Since ACLC has not been able to recruit a full time ELD Coordinator, funds have been shifted to provide a Campus Supervisor who provides learners with socioemotional support. The Campus Supervisor visits classrooms to check in on learners as well as provides a space when learners need to be heard and supported.

The continued pandemic is still a challenge. With dealing with the implications of learners having COVID or having to quarantine from COVID exposure, some learner's attendance has been inconsistent. This affects the consistency of the interventions being provided as well as increases the socioemotional support needs.

The fiscal resources are being used in a way that aligns with the LCAP and the plans submitted previously, with the exception of the above mentioned ELD Coordinator. The funds supported and will continue to support academics, school engagement, EL learners, foster youth, and learners that were impacted by distance learning. ACLC has increased the instructional coach support, which ties directly to learner outcomes.

California’s 2021–22 Budget Act, the federal American Rescue Plan Act of 2021, and other state and federal relief acts have provided local educational agencies (LEAs) with a significant increase in funding to support students, teachers, staff, and their communities in recovering from the COVID-19 pandemic and to address the impacts of distance learning on students. Section 124(e) of Assembly Bill 130 requires LEAs to present an update on the Annual Update to the 2021–22 LCAP and Budget Overview for Parents on or before February 28, 2022, at a regularly scheduled meeting of the governing board or body of the LEA.
