Northshore School District's commitment to serve the need for alternative learning opportunities for its students is evident at Secondary Academy for Success (SAS). SAS is a 5-day a week, 6 periods a day, grades 9-12 school. SAS embraces students whose learning styles require different instructional approaches, or those that need or want an alternative setting to the large comprehensive high school.

SAS students must meet the same graduation requirements and diploma standards required of all Northshore graduates. The difference is our delivery and support system. Students earn portions of credit every 15-20 days with 10 grading periods in a year, with no grades or homework. Students are strongly encouraged to look at options like community college, four-year college or technical college beyond 12<sup>th</sup> grade. SAS juniors and seniors are also encouraged to pursue Running Start, WaNIC, Satellite classes or career ready introduction programs.

SAS is part of the state and national green school projects partnering with McKinstry Corporation. McKinstry is involved with SAS staff to provide curricular opportunities for students to learn more about the skills required for jobs in the high demand area of sustainable development. SAS also works in tandem with the State Department of Education to implement projects in our school to improve our "green."

Northshore School District administers Smarter Balanced Assessments (SBA) in English/Language Arts (ELA) and math in grades 3-8, SBA ELA in grade 10 and SBA Math in grade 11; Measurements of Student Progress (MSP) in Science for grades 5 and 8; End-of-Course (EOC) in math for grades 9 and 10; and EOC in Biology in grade 10 to students annually in compliance with state and federal laws.
