All public comments should be sent to PublicInput@hamden.org, with the subject of the message stating the name and date of the meeting (ex. "May 12 Operations Committee Meeting"). The name and Hamden address of the person submitting public comment must be included in the message. Remarks should be brief and concise, with a maximum length of three minutes (about 450 characters). Comments should start with a 2-3 sentence summary that will be read instead of the entire message in the event that there is a large number of comments and reading each of them in their entirety would extend beyond the time allotted for public comment. **Public comments will be accepted up to 1 hour before the meeting begins.**
