Based on analytical results, the aggressive flush was successful at reducing copper concentrations at all but two fixtures initially identified above the action level. All fixtures except the drinking fountain at the sink in the Music Room and the faucet in the Counselor's office are safe to be put back into service.

The remaining two fixtures above the action level should continue to remain out of service until further testing or remediation is completed.
