

Information on Quarantine and Isolation

For **quarantine** and **isolation**: Stay home. Do not go to school, work or attend social activities. Do not allow visitors in your home. Additional information for **isolation**: Stay in a specific "sick room" or area and use a separate bathroom if available. See below for information on number of days you are required to quarantine and isolate.

Quarantine is for when you might have been exposed to the virus and may or may not have been infected. Isolation is for when you have been infected with the virus, even if you don't have symptoms.

You do not need to quarantine following an exposure, IF you have had a laboratory-confirmed positive COVID-19 test result within the past 90 days, have recovered, and no longer have symptoms.
