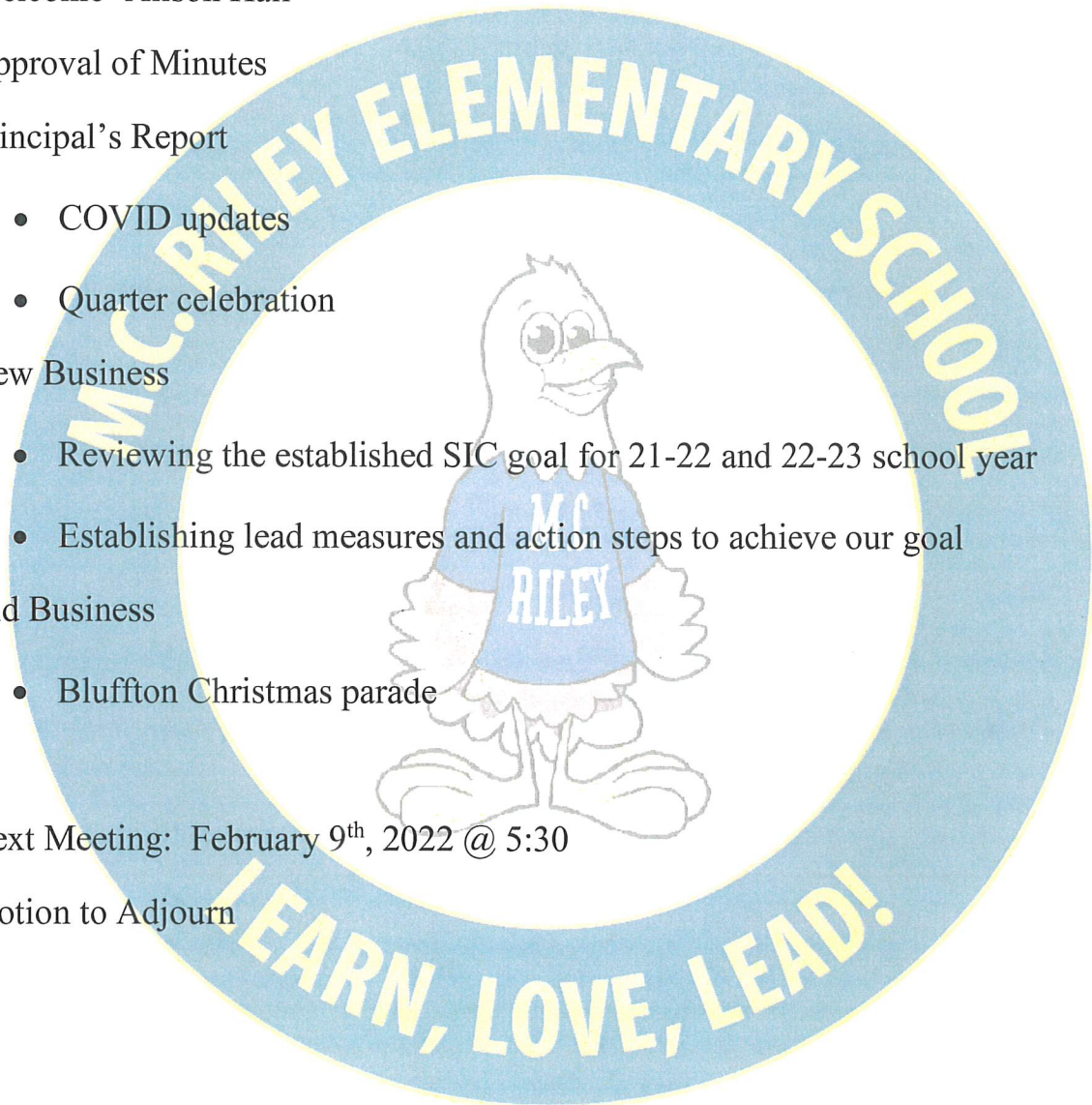

SIC Meeting Minutes

January 12, 2021

Meeting started at 5:30 p.m.

Reviewed notes from November 2021 meeting; December meeting was a joint SIC-School Board Meeting

New Business

1. **Principal Updates:** Mrs. Ford provided an update about report cards and 2nd quarter celebrations – teachers will be sending out information soon. She also provided a COVID update that the school was doing its best to keep students safe and healthy.
2. **SIC Goal:** Mrs. Hall started a discussion regarding the goal for 2021-2022 and 2022-2023:
 - a. Goal – PR for the school: By May of 2023, as a SIC, we will work to increase relationships with the Bluffton community and MC Riley Elementary and Early Childhood Center.
 - b. Discussion included field trips within the community (local parks, the library, the Farmers' Market and other businesses in the community). Discussion also included how to measure the goal, including Facebook posts and relationships with local businesses. Many parents and businesses follow the page, along with other Beaufort County administrators and previous MCRE staff members.
 - c. Discussion also included information about incentive programs and what businesses work closely with MCRE. These businesses include: Mi Tierra, Olive Garden, Wendy's and Chick Fil A. Mrs. Copeland, MCRE's parent liaison, stated that she is in touch with other businesses to build those partnerships and is looking for other incentives that don't include food.
 - d. Mrs. Hall asked the SIC to reach out to other businesses (restaurants or activity-based businesses) to see who else would like to partner with the school.
 - e. Discussion also included doing events outside, including a health fair. Mrs. Ford is going to look into this, especially with COVID concerns.

Old Business

1. **Bluffton Christmas Parade:** Singing Eagles participated in the parade and the Christmas Tree lighting. Event went well. First year the Singing Eagles walked in the parade versus rode on a float.
