Based on analytical results, the aggressive flush was unsuccessful at reducing copper concentrations at five of the six fixtures remaining above the action level. The aggressive flush was successful at the faucet in Room 13. As such, the faucet in Room 13 can be put back into service.

The remaining five fixtures above the action level should continue to remain out of service until further testing or remediation is completed.
