Keith-

Fulcrum received drinking water analytical results for Tri-Tech Skills Center (TTS). Results report six samples with elevated lead and one sample with elevated copper concentrations. The spike we included in this batch (labeled DF-38 in the analytical results) is reporting at 14  $\mu$ g/L for lead and 1,200  $\mu$ g/L for copper, although we know these concentrations should be the action level for lead of 15  $\mu$ g/L and copper, 1,300  $\mu$ g/L. As such, it is likely all lead and copper concentrations reported at or above the spiked sample concentration is at or above the action level. A summary of sample locations for each is below:

Lead-

KF-05: 23  $\mu$ g/L, south faucet in center island of kitchen DF-15: 15  $\mu$ g/L, drinking fountain along west wall of Commons area KF-26: 30  $\mu$ g/L, southernmost faucet along west wall of Nursing (Room 120) KF-27: 25  $\mu$ g/L, center faucet along west wall of Nursing (Room 120) KF-28: 41  $\mu$ g/L, northernmost faucet along west wall of Nursing (Room 120) CF-34: 28  $\mu$ g/L, center faucet in Digipen classroom (Room 150)

Copper-

DF-13: 1,200 µg/L, drinking fountain in Welding (Classroom 210)
