THE POSITION OF CHIEF FINANCIAL OFFICER**

Duration: July 1, 2021 – June 30, 2023

Includes all benefits provided by Corporation Policy Manual for administrative employees.

Base salary for 2021-2022 is \$150,378.00

The school corporation will provide a locally built Toyota Camry, fuel, and required service and maintenance for business use. The vehicle may also be used for up to 3,000 miles per year for personal use subject to taxation at the current Internal Revenue Service mileage rate. In lieu of the use of the corporation vehicle the employee may opt for an automobile allowance of \$6,000 per contract year to be added to the base contract salary. If the employee opts for the automobile allowance rather than the use of the vehicle there will be no additional payment for mileage or related expenses.

The total base salary for the 2021-2022 contract year plus \$6,000 automobile allowance equals \$156,378.00.

A 401a contribution of 4% will be paid on the base contract, and automobile allowance. Employee will be a member of the Indiana Public Employee's Retirement Fund and TSC will pay the 3% employee contribution to said fund each contract year.
