Stafford MSD will begin accepting Non-Resident Student Transfer Applications for new and renewal students living outside the boundaries of the district for the 2022-2023 school year on Monday, March 21, 2022. You may access the transfer application from the SMSD website at https://www.staffordmsd.org/becomeaspartan/non-resident-student-transfer or you may obtain a transfer application from any SMSD campus front office.

The deadline date for all transfer applications is Friday, April 8, 2022. **Remember, there** are no automatic renewals! You must apply within the application period in order to be considered. If you do not apply within the application period, you must return to your home school or other school of choice.

APPLICATION FOR NON-RESIDENT TRANSFERS 2022-2023

Renewal Transfer: Currently enrolled at SMSD, Application submissions begins March 21, 2022. Deadline date is April 8, 2022. Notification for acceptance/denial is May 9, 2022.

Spartan Transfer*: Applies to students whose parent/guardian are employees of SMSD or City of Stafford employees who do not reside in the SMSD attendance zone. Application submissions begins March 21, 2022. Deadline date is April 8, 2022. Notification for acceptance/denial is May 9, 2022.

STEM Magnet Transfer: Applies to students who have been accepted into the STEM Magnet Program who do not reside in the SMSD attendance zone.

Early College and Career High School Program: Applies to students who have been accepted into the Early College and Career High School Program who do not reside in the SMSD attendance zone.

Sibling Transfer: Applies to students who are siblings to a magnet student who have been accepted into the STEM Magnet Program who do not reside in SMSD attendance zone. Siblings must meet minimum criteria such as satisfactory attendance, satisfactory discipline, passing grades and provide results of standardized testing. Application submissions begins March 21, 2022. Deadline date is April 8, 2022. Notification for acceptance/denial is May 9, 2022.

Space Availability Transfer**: Applies to students who do not reside in the SMSD attendance zone who meet minimum criteria such as satisfactory attendance, satisfactory discipline, passing grades and provide results of standardized testing. Limited spaces are available under this category and grade level space must be available. Application submissions begins March 21, 2022. Deadline date is April 8, 2022. Notification for acceptance/denial is June 3, 2022.

Completed applications must be submitted to the appropriate SMSD school along with a copy of:

- Current proof of residence (Deed of Trust; Lease Agreement; Electricity bill; Water bill or Gas bill).
- Current and previous years report card
- Attendance record
- Conduct/Discipline Records
- Results of Standardized Testing

Completed applications will be processed on a first-come, first-served basis; subject to approval based on available space and staff capacity. Each application and accompanying documentation will be reviewed independently without regard to other siblings that may also request enrollment. Additionally, student portfolios and/or letters of recommendation will be reviewed, if submitted.

APPLICATIONS WITHOUT REQUIRED DOCUMENTS ARE CONSIDERED INCOMPLETE AND WILL NOT BE PROCESSED.

SMSD NON-RESIDENT ENROLLMENT

Non-residents may apply to enroll their children without a tuition charge (grades K-12), according to the following stipulations:

- 1) Annually, the Superintendent may review the Non-Resident Student Transfer Process.
- 2) Applications for Non-Resident Student Transfer are approved annually.
- 3) The District shall approve the Non-Resident Student Transfer based on available space, staff capacity, student conduct records, and student attendance history.
- 4) All Renewal Transfers, Spartan Transfers, STEM Magnet Transfers, Early College & Career High School Program, Sibling Transfers, and Space Availability Transfer applications must be submitted to the appropriate SMSD campus.

The Superintendent has the authority to accept or reject any transfer request, provided that such action is without regard to race, religion, color, sex, disability, or national origin. A parent may appeal the denial of a transfer application or non-renewal of a transfer in accordance with school board policy FNG (local).

NON-RENEWAL

The Superintendent or Superintendent's designee has the authority to non-renew any transfers as provided in the transfer agreement. Students who transfer into the District shall follow all rules and regulations of the District; including, but not limited to:

- 1) District Policies and Regulations
- 2) Student Code of Conduct
- 3) Attendance and Discipline Requirements

Please initial the following:

- I understand that, if approved, the transfer request is granted for the 2022-2023 school year unless revoked due to discipline or attendance violations as outlined in the Local Innovation Plan (see district website: www.staffordmsd.org).
- I understand that falsification or omission of information is a violation of state law and can lead to legal action.

I have read a copy of the policy concerning student transfers and the UIL eligibility requirements for competition, available online at www.staffordmsd.org and at each campus.

____ I understand that no transportation will be provided. Parent must transport to and from school.

- It is the parent/guardian's responsibility to contact the school to complete the registration packet within 10 days of receiving the approval of the transfer.
- I understand that each year I must apply to be a non-resident student transfer. There's no automatic renewal. If I don't reapply within the application period, I will be withdrawn and must return to my home school.
