The proposals are reflective of identified roof replacement and restoration work.

Note: The roofing projects work are being procured via the Keystone Purchasing Network (KPN) state contract. KPN representatives reviewed the roofing materials, scope of work, and other relevant details at previously held LT Facilities Planning Committee Meetings attended by various School Board Members. The above featured projects are slated for completion prior to the start of the 2022-2023 School Year.

**9.B.** Approve the attached amendment to EI Associates Architectural & Engineering services contract relative to the design and construction of the STSD High School Concession Stand Project in the not to exceed amount of \$14,500.00.

Note: The above amendment relates to required scopes of work identified as limited topographic survey, site infiltration testing, subsurface investigation and geotechnical test borings, and sewage planning module. These services extend beyond the scope of work outlined in the existing EI Associates proposal. It is further noted that the company to perform this work, Dawood Engineering is a Minority Business Enterprise (MBE) that is credited towards the districts ongoing goal to achieve 15% to 20% participation with such qualified providers on professional design and construction projects. It is further noted that action is being requested without previous discussion to assist with maintaining compliance with this project timeline.

**9.C.** Approve the attached amendment to El Associates Architectural & Engineering services contract relative to the design and construction of the STSD High School Intercom Paging Project in the not to exceed amount of \$2,500.00.

Note: The above amendment relates to a required system/equipment performance review necessary to ensure that the newly installed intercom system meets the district's need. The initial design of the system addressed the replacement of the core equipment (motherboard) and did not address end equipment necessary to secure and maintain properly operating speakers/communications. The performance review will identify any gaps in planned service levels so that they can be addressed via change orders as deemed necessary or via alternative procurement options. This work must occur in order for the high school intercom service to meet operational requirements for the 22-23 school year and beyond. It is further noted that action is being requested without previous discussion to assist with maintaining compliance with this project timeline.
