The Amherst Safety Town program will be held the weeks of June 6th and June 20th. Morning and afternoon sessions are offered each week. Each session is filled on a first come, first serve basis, and session preferences are not guaranteed. **Participating children must be entering Kindergarten in the fall 2022 school year at an Amherst school or reside within the City of Amherst.**

Classes meet at the Amherst Beaver Creek Metro Parks, behind the police station, at 913 North Lake Street, and will be held rain or shine. School Resource Officers Ryan Lamb, Greg Ford, and Sgt Brian Bowers will be directing instruction.

Children should wear weather/activity appropriate clothing and shoes. For safety reasons, no flip flops or open-toe shoes are permitted. Please help your child learn his/her name, address, and phone number before coming to Safety Town.

Complete the attached registration and KidPrint forms and return by May 10, 2022. A \$30.00 fee is required at the time of registration, which includes a T-shirt and daily snack for each child.

Parents will be notified by email as to what session your child will be attending. **Class confirmation notices will be sent to the email address provided within 2 weeks of receiving your forms.** (If you do not receive anything to your Inbox, please remember to check your junk/spam folder also)
