| Physical activities and sports | No restrictions to the exercise of physical and sports activities (APS) | Physical and sporting activities authorized outdoors as well as indoors. is also lifted for all staff as well as for middle and high school students.

In schools, after a confirmed case:

Continuation of learning in the presence and realization of a self-test on D+2.

In middle and high schools, after a confirmed case:

Pupils under the age of 12 and pupils aged 12 and over with full vaccination, identified at-risk contacts, continue with the lessons in person and carry out a self-test on D+2.

Pupils aged 12 and over identified as at-risk contacts and not having a full vaccination continue for 7 days with distance learning and carry out an antigen or PCR test at the end of the isolation.

For all contact cases (from CP):

Wearing a mask is strongly recommended for 7 days after the occurrence of the confirmed case.
