Dear WSD 4K and Early Childhood families,

Welcome to the 2021-2022 school year. The 4K and Early Childhood staff eagerly anticipates forming a strong and positive partnership with you and your child. Since you are your child's foremost influential teacher, collaborating together will best prepare your child for future academic and social success. We will communicate regularly by group emails and phone calls as well as bi-weekly newsletters. If possible, please plan to attend our "Parent at School" event the first week of each month.

In this handbook you will find many useful items such as our safety, snack, and bus policies, information about transporting and visiting the 4K Learning Academy, our school calendar, and important educational and curricular priorities. Our policies are crafted to keep your child safe in the most stimulating learning environment possible. Please note that to improve the safety of our students, staff, and parents, the district has secured entrances at district buildings. When entering the 4K Learning Academy, you will need to be buzzed in after the school day has started. All visitors are required to check in at the school office before proceeding anywhere in the building. Your cooperation is greatly appreciated.

Please note that there are policies in the District Handbook that relate to such things as media events, field trips, prescription procedures, etc. Also included are the Wausau School District's Key Interests which are the basis of all current and future educational decisions.

You will find our 4K rules on a poster you can hang at home. The expectation for all of our children is that "we make good choices." The five rules are the cornerstone of our work on social-emotional and behavior skills at school. All of the rules can easily be applied at home. Talk about the rules and praise your child enthusiastically when you see him/her follow them.

We welcome you as part of our District 4K family, where state-recognized programs and fun, individualized learning opportunities occur every day so that every student gets the same opportunity for success. 4K Academy FREQUENTLY ASKED QUESTIONS

1. WHAT TIME IS SCHOOL IN SESSION?

AM session: 8:25 a.m. to 11:00 a.m. **PM session:** 11:40 a.m. to 2:15 p.m.
(drop off 8:20 a.m.) (drop off 11:35 a.m.)

2. HOW ARE ABSENCES REPORTED?

- You must call school to report the absences. When calling, tell us how long your child will be out of school and the reason for the absence.

- Call First Student at 715-842-2268 (if your child rides the bus).

3. WHAT ARE THE PROCEDURES WHEN MY CHILD RIDES THE BUS?

- Be ready, waiting, and visible at the bust stop at least 10 minutes before your scheduled pickup or drop-off time. The times can vary due to absent students. **An adult must always meet the bus.**
- Load and unload your child onto and off of the bus.
- Call First Student at 715-842-2268 to report absences on days your child will not be riding the bus.
- If you move or change daycare providers after completing the bus request form, contact the 4K & EC Programs office at G.D. Jones at 715-261-0265 to update your address. The 4K & EC office will then notify the bus company of the changes.
- After a change is requested it takes one to two weeks to adjust the route.
- Note the following:
 - If an adult is not present, the child will be returned to school and the parent will need to pick the child up at the 4K Academy. This is extremely stressful and confusing for the child as their teacher will not be available to meet or supervise them.
 - If a child remains at school one hour past school dismissal (past 12:00 p.m. for morning students and past 3:15 p.m. for afternoon students), law enforcement may be contacted.
 - If your child repetitively returns to school, we will ask you to come in for a meeting with the principal and social worker to brainstorm solutions for a smooth bus ride home for your child.

Due to the time it takes First Student to set up routes, no busing changes or additions will be made from August 9 until September 10. Parents of students who enroll during this time period will need to transport their child until busing arrangements can be arranged.

4. HOW CAN I ADD OR CHANGE BUSING FOR MY CHILD?

Please make all busing requests through the 4K & EC Programs office at G.D. Jones School at 715-261-0265. Please do not call First Student.

Information for any bus changes can be taken over the telephone. Remember any daycare must be located in our transportation/attendance areas assigned to your 4K site.

5. WHAT ARE THE PROCEDURES WHEN I TRANSPORT MY CHILD?

Drop - off

- Many parents choose to transport their child to the 4K Learning Academy. If you choose to do so, please make sure your child is at school by the start time (8:25 am or 11:40 am) to avoid loss of valuable instructional and learning time for your child.
- **Parents must accompany their child into and out of school during pickup and drop off times.** If you are dropping your child off, **staff will meet students at the doors 5 minutes prior to start time, i.e. 8:20 a.m. and 11:35 a.m.**
- You must follow the traffic rules outlined by the school building. This includes parking in designated parking spots and not stopping, standing, or parking in the drop-off/pick-up lane.
- Please wait in the designated spot with your child until a school adult supervisor is available. The parent may then leave and the supervisor will walk the children to their classrooms.
- Please provide supervision for all children in your care and do not leave children unattended in vehicles.

Pick-up

- Please wait in the designated spot and a school staff will bring the children to that area at dismissal time.
- For the safety of you and your child, please avoid crossing between parked buses and always use the crosswalk.
- Park in designated parking spots when leaving your vehicle.

The doors to our school buildings are locked and you will be buzzed in at the main entrance only. All visitors are required to check in at the office, register using the raptor system (a state issued photo ID is required) and put on a visitor badge before proceeding anywhere in the building. It is our policy that every visitor must check in at the office and wear a visitor badge.

6. WHAT IF I WANT TO PICK MY CHILD UP EARLY?

If you wish to pick your child up early, please stop into the office to sign your student out of school. All visitors, including parents, are required to complete the raptor registration process using a state issued photo ID before going to visit a classroom.

7. WHAT IS THE EMERGENCY SCHOOL CLOSING PLANS FOR 4K?

When it is necessary to close school during the middle of the day, school closing or delay information will be sent to you via School Messenger®, the District's electronic notification system, and announced over radio and television stations. Parents of 4K students are responsible for picking up their child at the Learning Academy. Students will not be transported by bus. In the event there is a 2-hour delay, all 4K classes are canceled.

8. ARE THERE FEES FOR 4K?

There is a \$40.00 snack/activity fee. This covers 2 field trips, a daily snack, and a daily milk. This required fee covers the entire school year.

9. WHO DO I CONTACT IF WE MOVE OR HAVE CHANGES TO PHONE NUMBER OR EMAIL?

Please notify the 4K office any changes including: address, email, phone number, emergency contact changes by calling 715-261-0265.

10. MAY I SEND A BIRTHDAY TREAT?

If you choose to celebrate your child's birthday at school, please consider sending a non-food birthday treat. Any food items sent for sharing must contain an ingredient label, be nut free, and made in a nut free facility. Items that are determined to place children's health at risk will be discarded or returned to parents.

11. WILL MY CHILD GO OUTSIDE EVERY DAY?

YES! PLEASE DRESS YOUR CHILD FOR OUTSIDE RECESS EVERY DAY! Research has provided evidence of the far-reaching power of regular exercise in improving the learning and emotional and physical well-being of students. Regular exercise creates an environment in which the brain is ready, willing, and able to learn. **If it is cold or rainy, we will use the gross motor area as a substitute.**

12. CAN I VOLUNTEER?

WE NEED and APPRECIATE ALL VOLUNTEERS. You may volunteer once during the school year or on a regular basis. Volunteers are an integral part of an efficient, high-quality school. This also gives your child the message that "school is an important place to be." 13. HOW CAN I LEARN MORE ABOUT WHAT MY CHILD IS DOING IN SCHOOL?

Parents are welcome to talk with teachers, 4K principal or building principal if they have any questions. To reach the 4K principal call the 4K & EC Programs office at 715-261-0265. Watch for the 4K CONNECTION, the 4K newsletter, every other week. **In addition, you will be invited to connect with your child's classroom every month to observe a lesson and participate in an activity with your child.** This has been an extremely popular activity for both parents and students.

The Wausau School District has a "phone messenger" system that will call you and leave a voice message with any emergency information or reminders. You may receive messages from both the 4K Learning Academy and the school building.

14. WHAT OTHER EDUCATIONAL OPPORTUNITIES ARE OFFERED?

As part of the 4K program, we offer over 90 hours of opportunities for families to learn more about their child's development as well as fun parent-child activities around the community. Please read our 4K newsletter to learn about these activities.

15. CAN MY CHILD GO TO 4K FOR TWO YEARS?

Please note that 4K programming is intended for one year only. Requesting a second year of 4K is considered retention and will be subject to Wausau School District policy that requires a case-by-case approval. Thank you for planning accordingly.

16. CAN MY CHILD ATTEND KINDERGARTEN AT THE SAME SITE AS 4K?

Wausau School District kindergarten placement will be at your neighborhood school regardless of where your child attends 4K.

17. WHAT SUPPLIES DOES MY CHILD NEED?

EARLY CHILDHOOD SUPPLY LIST

- 4 glue sticks (jumbo size preferred)
- 2 large boxes of facial tissue
- Backpack large enough to hold a folder
- Extra change of clothes for your child labeled with name in Zip-lock bag
- Diapers/wipes for your child to have at school (if needed)
- Student activity fee for the entire year. This covers a daily snack and milk. Cash or check made out to the "WSD 4K & Early Childhood Programs". The snack fee can be dropped off in the 4K office or given to your child's teacher.
 - Class meets 5 days a week = \$40.00
 - Class meets 4 days a week = \$35.00
 - Class meets 3 days a week = \$30.00
 - Class meets 2 days a week = \$25.00
 - Class meets 1 day a week = \$20.00

4K SUPPLY LIST

- 1 4-oz. bottle of white glue
- 1 box of crayons, 24 count
- 1 watercolor set, 8 color count
- 1 container of playdough (any color)
- 1 package of washable markers (pip-squeak preferred)
- 2 large boxes of facial tissues
- 4 glue sticks - (jumbo size preferred)
- Waterbottle (label with name)
- Large backpack, big enough to hold a two-pocket folder (which we will supply) and snow pants for winter. Please avoid wheeled backpacks for safety reasons
- Extra set of clothing in a zipper storage bag with child's name printed on bag
- \$40.00 student activity fee for the entire year (if writing a check, make payable to the "WSD 4K & EC Programs"). This covers a daily snack, milk and field trips.

Health Information

Your child should be kept home or will be sent home for the following health issues:

- Fever (temperature 100 degrees F or greater) – child should be fever-free for 12 hours before returning to school
- Vomiting/frequent diarrhea
- Upper respiratory illness with frequent cough/drainage
- Strep throat – until 24 hours after treatment has begun
- Pink eye – until 24 hours after treatment has begun
- Undiagnosed or untreated skin rash or sores that cannot be covered

You can help your child stay healthy by encouraging frequent and thorough hand washing. Hand washing is the single most important defense against disease.

Medications

A medication form completed by the parent must be on file at the school office for all medications, both prescription and over the counter. A doctor must sign the form for any prescription medication. Please contact the school's health aide with any questions regarding your child's medications.

TEACHING AND LEARNING

WAUSAU SCHOOL DISTRICT 4K CURRICULUM AND ASSESSMENT

Children learn through exploring and play! There is a great deal of new research indicating that the skills we teach and when we teach them are critical to development, including a child's success in reading and his/her ability to regulate his own feelings and make friends. Because of rapid brain development, this critical learning has to take place as early as possible through the partnership of parents and teachers. In early childhood programming, children are provided with opportunities to explore and apply new skills through child and teacher initiated activities. We use the Wisconsin Model Early Learning Standards as the foundation to the Wisconsin Common Core State Standards and our Wausau School District Program Goals to guide our curricular and assessment decisions.

The following is a summary of curriculum components:

Happily Ever After: This literacy component of our curriculum is rooted in solid, current research. Each three-week unit consists of 10 lessons that are designed to prepare children for future reading success. "Take-home" books are sent home with each story. You will get parent letters with each unit giving you ideas about how to practice skills at home.

Hegerty: The Heggerty Pre-Kindergarten curriculum uses nursery rhymes to introduce preschool students to language play. The lessons include eight phonological and phonemic awareness skills, taught in a systematic progression. Learners develop alphabet knowledge through daily practice with an alphabet song and letter name and sound practice. Nursery rhymes are taught each week so that by the end of preschool students have built a repertoire of classic nursery rhymes as they learn to enjoy language play!

Handwriting Without Tears: This is our handwriting curriculum. Research supports the active teaching of writing as it is an expression of what we are thinking and reading. Plus it builds fine motor skills.

The Pyramid Model-Social Emotional Foundations of Early Learning (SEFEL): Our staff has advanced training in helping children to identify and regulate their emotions, problem solve their frustrations, and follow rules and expectations. You will hear a lot about "Tucker Turtle."

Nursery Rhymes: As part of our curriculum, we use traditional nursery rhymes and fingerplays. Nursery rhymes also greatly enrich young children's vocabularies and supply some early lessons in the ways our language works and encourages thinking skills.

Assessments: Our students are checked regularly on benchmarks in all areas of development and assessed specifically on vocabulary development, social emotional development, and a fall and spring 4K Developmental Assessment. Across our WSD 4K programs we use the Individual Growth Development Indicators (myIGDIs) screening instrument to measure students' developing knowledge of important literacy fundamentals, monitor progress, and design instruction to children's specific needs. We also complete the b.e.s.t. social emotional screener two times during the school year.

Reporting: During the year, you will meet with your child's teacher for conferences two times (1st quarter and 3rd quarter). You also will receive a standards-based report card twice a year (2nd quarter and 4th quarter).
