



# BSMS PARENT AND FAMILY ENGAGEMENT POLICY

## 2021-2022 School Year

In support of strengthening student academic achievement, Butner-Stem Middle School receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). The policy establishes the school's expectations for parent and family engagement and describes how the school will implement a number of specific parent and family engagement activities, and it is incorporated into the school's plan submitted to the local educational agency (LEA).

Butner-Stem Middle School agrees to implement the following requirements as outlined by Section 1116:

Parent and Family Engagement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- Parents play an integral role in assisting their child's learning
- Parents are encouraged to be actively involved in their child's education at school
- Parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child
- Other activities are carried out, such as those described in Section 1116 of the ESSA

### JOINTLY DEVELOPED

Butner-Stem Middle School will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- Hold monthly meetings of the Twin Talon Club (our PTO and Booster Club)
- Review Title I Programming at each Twin Talon Club meeting
- Accept feedback from families and solicit input at monthly Twin Talon Club meetings

Butner-Stem Middle School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

## **COMMUNICATIONS**

Butner-Stem Middle School will take the following actions to provide parents of participating children the following:

- Timely information about the Title I programs
- A flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parent and family engagement.

## **BUILDING CAPACITY OF SCHOOL STAFF**

Butner-Stem Middle School will provide training to educate teachers and staff in the value and utility of contributions of parents.
