**ORDINANCE # 318**

**AN ORDINANCE ENTITLED “AMBULANCE CORPS TO PROVIDE FOR EMERGENCY MEDICAL SERVICES DELIVERY SYSTEM” REPEALING AND REPLACING ORDINANCE # 162 ENTITLED “AMBULANCE CORPS TO PROVIDE FOR EMERGENCY MEDICAL SERVICES DELIVERY SYSTEM”**

BE IT ORDAINED by the Town of Vernon that Ordinance #162, codified as Section 2-3 of the Code of Ordinances of the Town of Vernon, is hereby repealed and replaced as follows:

**Sec. 2-3. – Ambulance corps to provide for emergency medical services delivery system.**

- (a) The town ambulance corps shall be the provider of the town’s emergency medical services delivery system.
- (b) The ambulance corps shall prepare and submit its governing bylaws and any future amendments thereto to the town council for its approval, which shall not be unreasonably withheld.
- (c) The ambulance corps shall remain a volunteer organization.
- (d) The town shall provide workers’ compensation coverage and liability insurance for the ambulance corps.
- (e) The ambulance corps’ annual budget shall be approved by the town council and the revenues generated by the ambulance corps shall be deposited into the town’s general fund.
- (f) The ambulance corps’ purchases shall be subject to the procedures set forth in the Charter which govern purchases by town agencies.

**Is hereby repealed and the following is substituted in lieu thereof:**

**Ambulance corps to provide for emergency medical services delivery system.**

- (a) The town ambulance corps shall be the provider of the town’s emergency medical services delivery system.
- (b) The ambulance corps shall prepare and submit its governing bylaws and any future amendments thereto to the town council for its approval, which shall not be unreasonably withheld.
- (c) The ambulance corps shall consist of volunteers and paid personnel as authorized by the town council.
- (d) The town shall provide workers’ compensation coverage and liability insurance for the ambulance corps.
- (e) The ambulance corps’ annual budget shall be approved by the town council and the revenues generated by the ambulance corps shall be deposited into the town’s general fund.
- (f) The ambulance corps’ purchases shall be subject to the procedures set forth in the Charter which govern purchases by town agencies.
