Required documentation for Scholarship Applications

You will need the following documents/photos in either JPEG or PDF format, in individual files, ready to upload:

- A passport photo of the student taken within six months up to the date of application (JPEG only and click [here](#) for photo guidelines)
- Student's Birth Certificate (original official notarised translations of Birth Certificate that are not in English)
- Student's Passport (photo page only)
- Student's Singapore Citizenship Certificate (if applicable)
- Student's Permanent Resident Re-entry permit (if applicable),
- Dependent Pass, both front and back copy (if applicable)
- Student Pass, both front and back copy (if applicable)
- Baptism Certificate (applicable only if student is Catholic)
- MOE Exemption Letter for Mother Tongue (if applicable)
- MOE In-Lieu Exemption Letter for Mother Tongue (if applicable)
- Student's latest school reports for three years up to the date of application (report for the full academic year e.g. Term Report, Progress Report, Mid year report, Final Report)
- PSLE Results Slip including the T-Score or Banding Score (if applicable)
- Any supporting documentation relating to Educational Testing done within 2 years up to the date of application and/or Educational Psychology reports (if applicable)
- A statement from the applicant's current Principal or Form Teacher (printed on official School Letterhead, with a School Stamp and Principal's or Form Teacher's signature on it)
- Applicant's personal statement

You will also need to provide information regarding the following information:

- History of the current and previous two (2) schools attended (where applicable)
- Details of Co-Curricular/Non-Academic involvement (inside and outside of school)

Additional documents for Lasallian Scholarship, Merit-Based Means Tested Scholarships, and Foreign Scholarship Applications:

- Income/Tax Statement of all the working adults of the Household (IRAS for local Singapore applicants)
