**School Bond** Measure Follow-Up

**November 2022** a) Joy Gabler, Superintendent, presented for information the November 2022 Bond Measure Follow-Up. She stated she brought it back to give the Board the opportunity to talk about it and decide if they are interested in moving forward with the survey. If the Board decides to move forward, we will need to bring

forward a contract for approval at the next Board meeting. Joy shared a facility master plan cost sheet to show the various projects needed and the cost per site. Trustee Strickland stated the district certainly needs the money. Vice-President Revious believes the selling point should be Woodrow Wilson and its parking extension and drop off relocation due to the safety of students. David Endo stated WW needs a lot of work. Our priority is safety upgrades, but the parking lot and relocation of drop-off can definitely be part of the conversation if we move forward. President Garner asked with the extension of TK will we need additional building and will the State help with cost. David Endo answered we have the space. In regard to financial help from the State, they will only help if we can prove we have a hardship. We don't have a hardship, so it eliminates that. President Garner stated there is a need, is everyone okay with moving forward with study. Trustee Garcia agrees they should, and Vice-President Revious also agree with moving forward with the study. Trustee Strickland does not believe the time is right to place a Bond Measure on the ballot in November 2022 but will support the Board's direction. Superintendent Gabler stated this is just to move forward with the survey, depending on the results of the survey the Board can decide if the district should move forward with the bond. David Endo stated Jason works on contingency bases. They won't support the bond if they know it will fail because they won't get paid.

#### PAC Meeting #2

Doug Carlton, Director of Program Development, Assessment & Accountability, presented for information a report from the District Parent Advisory Committee for the meeting held on January 19, 2022 (Meeting #2). The PAC received information on the following topics: the Local Control Accountability Plan (LCAP), the California School Dashboard and State Indicators, test scores in ELA and Math, English Learner progress, programs and services to support academic achievement, review of programs and services, use of funds provided through the Budget Act of 2021, and one-time federal funds to support recovery from the COVID-19 pandemic. The PAC made the following recommendations: the PAC members expressed concern of the decline in test scores between the 2018-2019 and 2020-2021 school years, the PAC recognizes that in-person learning is the most effective form of learning, every effort should be made to ensure schools remain open and students remain in class, the PAC recommends that the district have programs, services, and incentives for students to motivate them to work hard and catch up, the PAC recommends that the district implement paraprofessionals in classrooms to work in classrooms providing teachers greater opportunity to give students individualized instruction, and allow parent volunteers back into classrooms to provide additional support. The Superintendent responded and concurred with the recommendation.

**DELAC Meeting** b) Lucy Gomez, Director of Curriculum, presented for information a report from the District English Learner Advisory Committee for the meeting held on January 20, 2022 (Meeting #2). The DELAC received information on the following topics: the Local Control Accountability Plan, State and Local LCAP Indicators, State test scores in ELA and mathematics including the percentage of students scoring

proficient on the CAASPP, the progress English learners made learning the English language including the percentages of EL students proficient on the ELPAC at the district and for each school, and Programs and Services for English learners. The DELAC made the following recommendations: the DELAC expresses concern over the decline in state test scores in ELA and mathematics, the DELAC commends the district on the growth of the EL student subgroup in ELA, the DELAC recommends further study of the achievement levels of EL students in ELA, and possible revision of the 2023-2024 LCAP target for this group of students, the DELAC notes that keeping schools open is the best form of learning, the DELAC recommends that the district make every effort to keep schools open, the DELAC realizes the importance of reclassification of EL students, the DELAC recommends that the district work toward giving EL students the tools and support that are necessary for reclassification, the DELAC recommends that the district focus on the underperforming subgroups and provide these students with tools support to close achievement gaps, the DELAC recommends that the district have an expert on integrated ELD at each of the school sites using an instructional coaching model, and the DELAC recommends that the district identify/study those individual schools or people who have success in raising the English proficiency of EL students and replicate their results at other sites. The Superintendent responded and concurred with the recommendation.

### Policy 6164.4: Identification And Evaluation Of Individuals For Special Education

Original Adopted Date: 04/21/2004 | Last Revised Date: 09/19/2007

The Board of Trustees recognizes the need to actively seek out and evaluate district residents from birth tothrough age 21 who have disabilities in order to provide them with appropriate educational opportunities in accordance with state and federal law.

The Superintendent or designee shall develop processes to determine when an individual is establish a comprehensive child find system that includes procedures for the identification, screening, referral, assessment, and triennial assessment of individuals eligible for special education, as well as procedures for the services and shall establish systematic procedures for special education program identification, screening, referral, assessment, planning, implementation, and review of the special education and related services provided to such individuals., and triennial assessment. (Education Code 56301)

The district's identification procedures shall include systematic methods for utilizing referrals from The Superintendent or designee shall establish a method whereby parents/guardians, teachers, agencies, appropriate professionals, and other members of the public, and others may refer an individual for assessment for special education services. Identification procedures shall be coordinated with school site procedures for referral of students whose with needs that cannot be met with modifications to the regular instructional program. (Education Code 56302)

The Superintendent or designee shall notify parents/guardians, in writing, of their rights related to identification, referral, assessment, instructional planning, implementation, and review, including the right to consent to any assessment concerning their child. In addition, the Superintendent or designee shall notify parents/guardians of district's procedures for initiating a referral for assessment to identify individuals forwho need special education services. (Education Code 56301)

### Regulation 6164.4: Identification And Evaluation Of Individuals For Special Education

Status: ADOPTED

Original Adopted Date: 05/16/2001 | Last Revised Date: 09/19/2007

The Superintendent or designee shall ensure that the district's child find process includes the collection of data and, at reasonable intervals, the screening of such data to determine if students are making adequate progress, as appropriate.

A student shall be referred for special educational instruction and services only after the resources of the regular education program have been considered and used where appropriate. (Education Code 56303)

However, the district shall ensure that evaluations of children suspected of having a disability are not delayed or denied because of the implementation of response to intervention strategies.

A parent/guardian or the district may initiate a request for an initial evaluation to determine if the student is a student with a disability. (34 CFR 300.301)

When a verbal referral is made, staff shall offer assistance to the individual to make the request in writing and shall assist the individual if the individual requests such assistance. (5 CCR 3021)

All referrals from school staff for <u>an initial evaluation</u> special education and related services shall include a brief reason for the referral and description of the regular program resources that were considered and/or modified for use with the student <u>and</u>, when appropriate, the results of intervention. This documentation shall not delay the timelines for completing the assessment plan or assessment. , and their effect. (5 CCR 3021)

### **Initial Evaluation for Special Education Services**

Before the initial provision of special education and related services to a student with a disability, the district shall conduct a full and individual initial evaluation of the student. (34 CFR 300.301; Education Code 56320; 34 CFR 300.301)

<u>Upon receiptWithin 15 days</u> of <u>athe</u> referral of any student for special education and related services, <u>the district shall develop</u> a proposed evaluation plan <u>shall be developed within 15 calendar days</u>, <u>unless the parent/guardian agrees in writing to an extension. This 15-day period does</u> not <u>countinginclude</u> days between the student's regular school sessions or terms, or <u>calendar</u> days of school vacation in excess of five school days, <u>unless the parent/guardian agrees</u>, in <u>writing</u>, to an extension. <u>from the date of receipt of the referral</u>. If the referral is made within 10 days or less prior to the end of the student's regular school year <u>or term</u>, the proposed evaluation plan shall be developed within 10 days after the beginning of the next regular school year <u>or term</u>. , <u>or the student's regular school term</u>. In the case of the student's school vacation in excess of five school days, the 15-day deadline shall recommence on the date the student's regular school days reconvene</u>. (Education Code 56043, 56321)

The proposed evaluation plan shall meet all of the following requirements: (Education Code 56321)

- 1. Be in a language easily understood by the general public
- 2. Be provided in the native language of the parent/guardian or other mode of communication used by the parenttheparent/guardian unless it is clearly not feasible
- 3. Explain the types of evaluation assessment to be conducted
- 4. State that no individualized education program (IEP) will result from the <u>evaluation</u> assessment without parent/guardian consentguardianconsent

A copy of the notice of a parent/guardian's rights and procedural safeguards shall be attached to the evaluation plan.

(<del>cf. 6159 - Individualized Education Code 56321 Program</del>)

The proposed written evaluation plan shall include a description of recent assessments conducted, including available independent assessments and assessment information requested by the parent/guardian to be considered, as well as information indicating the student's primary language and the student's primary language proficiency as determined by Education Code section 52164.1. (5 CCR 3022)

<u>Before Prior to</u> conducting an initial evaluation, the district shall provide the parent/guardian with prior written notice in accordance with 34 CFR 300.503. In addition, as part of the evaluation plan, the parent/guardian shall receive written notice that includes all of the following information: <u>(Education Code 56329;</u> (34 CFR 300.304, 300.<u>502, 300.</u>504; <u>Education Code 56329</u>)

- 1. Upon completion of the administration of tests and other evaluation materials, an IEP team meeting that <u>includes the includes the parent/guardian</u> or <u>the parent/guardian's his/her</u> representative shall be scheduled pursuant to Education Code 56341. At this meeting, the team shall determine whether or not the student is a student with disabilities, as defined in Education Code 56026, and shall discuss the evaluation, the educational recommendations, and the reasons for the recommendations.
- WhenIn making a determination of eligibility for special education, the <u>district</u>student shall not determine that the student is <u>disabled be determined to be a studentwith a disability</u> if the <u>primarydeterminant</u> factor <u>for such determination</u> is lack of appropriate instruction in reading, <u>including the essential components of reading instruction as defined in 20 USC 6368</u>, lack of <u>appropriate</u> instruction in mathematics, or limited English proficiency, <u>if the student does not otherwise meet the eligibility criteria under 34 CFR 300.8</u>.
- 3. A copy of the evaluation report and the documentation of determination of eligibility shall be given to <a href="the-parent/the-parent/guardian">the-parent/the-parent/guardian</a>.
- 4. If <a href="the-a">the-a</a> parent/guardian disagrees with an evaluation obtained by the district, the parent/guardian has the right <a href="to-obtain-to-obtain">to-obtain-to-obtain</a>, at public expense, an independent educational evaluation (<a href="IEE">IEE</a> of the student from qualified specialists, in accordance with 34 CFR 300.502. <a href="The-parent/guardian is entitled to-only-one-such evaluation at public expense each time the district conducts an assessment with which the parent/guardian disagrees.
  - If the district observed the student in conducting its evaluation, or if its evaluation procedures make it permissible to have in-class observation of thea student, an equivalent opportunity shall apply to the IEE. independent educational evaluation. This equivalent opportunity shall apply to the student's current placement and setting as well as observation of the district's proposed placement and setting, if any, regardless of whether the IEE independent educational evaluation is initiated before or after the filing of a due process hearing proceeding.
- 5. The district may initiate a due process hearing pursuant to Education Code 56500-56508 to show that its evaluation is appropriate. If the final decision resulting from the due process hearing is that the evaluation is appropriate, the parent/guardian maintains the right for an <a href="LEEindependent educational evaluation"><u>LEEindependent educational evaluation</u></a>, but not at public expense.
  - If the parent/guardian obtains an <u>IEEindependent educational evaluation</u> at private expense, the results of the <u>IEEevaluation</u> shall be considered by the district with respect to the provision of a free appropriate public education (FAPE) to the student, and may be presented as evidence at a due process hearing regarding the student. If the district observed the student in conducting its evaluation, or if its evaluation procedures make it permissible to have in-class observation of a student, an equivalent opportunity shall apply to an <u>IEEindependent educational evaluation</u> of the

student in the student's current educational placement and setting and in, if any educational placement and setting, proposed by the district, regardless of whether the <u>IEEindependent</u> educational evaluation is initiated before or after the filing of a due process hearing.

6. If <a href="thea-">thea-</a> parent/guardian proposes a publicly financed placement of the student in a nonpublic school, the district <a href="shall have-shallhave">shallhave</a> an opportunity to observe the proposed placement and, if the student has already been unilaterally placed in the nonpublic school by the <a href="student's">student's</a> parent/guardian, the student in thate proposed placement. <a href="Any such observation shall only be of the student who is the subject of the observation and <a href="shallmay">shallmay</a> not include the observation or evaluation of any other student in the proposed placement unless that other student's parent/guardian consents to the observation or evaluation. <a href="The results of any observation or evaluation of another student">The results of any observation or evaluation of another student in violation of Education Code 56329(d) shall be inadmissible in any due process or judicial proceeding regarding FAPE of that other student.

(cf. 5145.6 - Parental Notifications)

(cf. 6159.1 - Procedural Safeguards and Complaints for Special Education)

### **Parent/Guardian Consent for Evaluations**

Upon receiving the proposed evaluation plan, the parent/guardian shall have at least 15 days to decide whether or not to consent to the initial evaluation. assessment. The district shall not interpret parent/guardian consent for initial evaluation assessment as consent for initial placement or initial provision of special education services. ((34 CFR 300.300, 34 CFR 300.301; Education Code 56320, 56321; 34 CFR 300.300)

Informed parental consent means that the parent/guardian: (Education Code 56021.1; (34 CFR 300.9)

- 1. Has been fully informed, in the parent/guardian's native language or other mode of communication, of all information relevant to the activity for which consent is sought, in his/her nativelanguage or other mode of communication
- 2. Understands and agrees, in writing, to the assessment to the carrying out of the activity for which parent/guardian consent ishis/her consentis sought and the consent describes that activity and lists the records (if any) that will be released and to whom 3. Understands that the granting of consent is voluntary on his/her part and may be revoked at any time
- 3. Understands that the granting of consent is voluntary on the parent/guardian's part and may be revoked at any time
- 4. Understands that if the parent/guardianhe/she revokes consent, that revocation is not retroactive (i.e., it does not negate an action that has occurred after the consent was given and before the consent was revoked). The district is not required to amend the education records of a student to remove any reference to the student's receipt of special education and services if the student's parent/guardian submits a written revocation of consent after the initial provision of special education and related services to the student.}

The district shall make reasonable efforts to obtain the informed consent of the parent/guardian for an initial evaluation or reevaluation of a student. (Education Code 56321; 34 CFR 300.300, 300.322)

The district shall maintain a record of its attempts to obtain consent, which may include: including: (34 CFR 300.300, 300.322)

1. Detailed records of telephone calls made or attempted and the results of those calls

- 2. Copies of correspondence sent to the parent/guardian and any responses received
- 3. Detailed records of visits made to the parent/guardian's home or place of employment and the results of those visits

If a parent/guardian refuses to consent to the initial evaluation or fails to respond to a request to provide consent, the district may, but is not required to, pursue an evaluation by utilizing the procedural safeguards, including the mediation and due process procedures pursuant to 20 USC 1415 and 34 CFR 300.506-300.516. ((34 CFR 300.300); Education Code 56321; 34 CFR 300.300)

For a student who is a ward of the state and not residing with <a href="the-student's-his/her">the student's-his/her</a> parent/guardian, the district shall make reasonable efforts to obtain the informed consent from the parent of the student for an initial evaluation to determine whether the student is a student with a disability. The district may conduct an initial evaluation without obtaining informed consent if any of the following situations exists: (34 CFR 300.300): Education Code 56321.1; 20 USC 1414; 34 CFR 300.300)

- 1. Despite reasonable efforts to do so, the district cannot discover the whereabouts of the parent/guardian of the studentthestudent.
- 2. The rights of the parent/guardian of the student have been terminated in accordance with <a href="mailto:state-California">state-California</a> law.
- 3. The rights of the parent/guardian to make educational decisions have been subrogated by a judge in <a href="accordance with state-accordancewith California">accordance with state-accordancewith California</a> law and consent for an initial evaluation has been given by an individual appointed by the judge to represent the student.

### (cf. 6159.3 - Appointment of Surrogate Parent for Special Education Students)

The district need not obtain parent/guardian consent before reviewing existing data as part of an evaluation or <u>reevaluation</u>, <u>or before</u> administering a test or other evaluation that is administered to all students, unless consent is required from the parents/guardians of all students. <u>(Education Code 56321;</u> 434 CFR 300.300)

#### **Conduct of the Evaluation**

Within 60 calendar days of receiving parental consent for the initial assessment of a student, not counting days between the student's regular school sessions, terms, or days of school vacation in excess of five schooldays, a determination whether the student is eligible for special education and the educational needs of the student shall be made, an IEP team meeting shall occur, and an IEP shall be developed, unless the parent/guardian agrees in writing to an extension, pursuant to Education Code 56344. If the 60-day time is interrupted by a student school vacation, the 60-day time shall recommence on the date that student schooldays reconvene and a meeting to develop an IEP for the student shall be conducted within 30 days of a determination that the student needs special education and related services. (Education Code 56043, 56344)

However, when a referral has been made for a student 30 days or less prior to the end of the regular school year, an IEP required as a result of an assessment of the student shall be developed within 30 days after the commencement of the subsequent regular school year. (Education Code 56043, 56344; 34 CFR 300.301, 300.323)

The district shall complete the determination as to whether the student is a student with a disability, conduct the initial evaluation to determine his/her educational needs, and develop an IEP within 60 days

of receiving informed parent/guardian consent for the evaluation. (34 CFR 300.300, 34 CFR 300.301; Education Code 56344)

The evaluation shall be conducted by qualified personnel who are competent to perform the assessment as determined by the district. - county office of education, or special education local plan area (SELPA). (Education Code 56320, 56322)

In addition, evaluations and reevaluations shall be administered by qualified personnel who are competent in the oral or sign language skills and written skills of the student's primary language or mode of communication and have a knowledge and understanding of the cultural and ethnic background of the student. If it is clearly not feasible to do so, an interpreter shall be used, and the assessment report shall document this condition and note that the validity of the assessment may have been affected. The normal process of second-language acquisition, as well as manifestations of dialect and sociolinguistic variance shall not be diagnosed as a disabling condition. (5 CCR 3023)

The screening of a student by a teacher or specialist to determine appropriate instructional strategies for curriculum implementation shall not be considered to be an evaluation for eligibility for special education and related services. (Education Code 56321; 20 USC 1414; 434 CFR 300.302)

In conducting the evaluation, the district shall use a variety of assessment tools and strategies to gather relevant functional, developmental, and academic information about the student. The district shall also use any information provided by the parent/guardian that may assist the district in making the determination as to whether the student is a student with a disability and, if so, the necessary components of <a href="the student'shis/her">the student'shis/her</a> IEP when the IEP is developed, including information related to enabling the student to be involved in and to progress in the general education curriculum. (34 CFR 300.304)

The district's evaluation shall not use any single measure or assessment as the sole criterion for determining whether a student is a student with a disability and for determining the appropriate educational program for the student. The assessment shall use technically sound instruments that may assess the relative contribution of cognitive and behavioral factors in addition to physical or developmental factors. \_(34 CFR 300.304)

The district shall also ensure that assessments and other evaluation materials provide relevant information that directly assists persons in determining the student's educational needs and are: (34 CFR 300.304; Education Code 56320; 34 CFR 300.304)

- 1. Selected and administered so as not to be discriminatory on a racial, cultural, or sexual basis
- Provided and administered in the student's native language or other mode of communication and in the form most likelymostlikely to yield accurate information on what the student knows and can do academically, developmentally, and functionally, unless it is clearly not feasible to so provide or administer
- 3. Used for the purposes for which the assessments or measures are valid and reliable
- 4. Administered by trained and knowledgeable personnel <u>except that individually administered tests of intellectual or emotional functioning shall be administered by a credentialed school psychologist</u>
- 5. Administered in accordance with any instructions provided by the producer of the assessments
- 6. Tailored to assess specific areas of educational need and not merely designed to provide a single general intelligencegeneralintelligence quotient

7. If administered to a student with impaired sensory, manual, or speaking skills, selected and administered to <a href="mailto:best ensure-bestensure">best ensure-bestensure</a> that the results accurately reflect the student's aptitude or achievement level or whatever other factors the test purports to measure, <a href="mailto:rather than reflecting the child's impaired sensory, manual, or speaking skills (unless those skills are the factors that the test purports to measure).">purports to measure)</a>.

Students shall be assessed in all areas related to the suspected disability, including, if appropriate, health and development, vision (including low vision), hearing, motor abilities, language function social and emotional status, general intelligence, academic performance, communicative status, self-help, orientation and mobility skills, career and vocational abilities and interests, and social and emotional status. When appropriate, a developmental history shall be obtained. For students with residual vision, a low vision assessment shall be provided in accordance with guidelines established pursuant to Education Code 56136. and motor abilities. The district shall ensure that the evaluation is sufficiently comprehensive to identify all of the student's special education and related service needs, whether or not commonly linked to the disability category in which the student has been classified. (Education Code 56320; (34 CFR 300.304)

As part of the initial evaluation and any reevaluation, the IEP team and other qualified professionals; shall, if appropriate, review existing evaluation data on the student, including evaluations and information provided by the parents/guardians; current classroom-based local or state assessments and classroom-based observations; and observations by teachers and related services providers. On the basis of that review and input from the student's parent/guardian, the team shall identify what additional data, if any, are needed to determine: ((34 CFR 300.305; Education Code 56381; 34 CFR 300.305)

- 1. Whether the student is a student with a disability, or in the case of a reevaluation, whether the student continues to continues to have a disability, and the educational needs of the student
- 2. The present levels of academic achievement and related developmental needs of the student
- 3. Whether the student needs, or continues to need, special education and related services
- 4. Whether any additions or modifications to the special education and related services are needed to enable <u>the student</u> to meet the measurable annual goals set out in <u>the student'shis/her</u> IEP and to participate, as appropriate, in the general education curriculum

If a student has transferred from another district in the same school year or leaves this district, the district shall coordinate with the student's prior or subsequent district as necessary and as expeditiously as possible to ensure prompt completion of full evaluations. (34 CFR 300.304)

### **Evaluation Report**

### **Eligibility Determination**

Upon completion of the administration of assessments and other evaluation measures, a group of qualified professionals and the parent/guardian shall determine whether the child is a student with a disability and the student's educational needs. In interpreting the data, the group shall draw information from a variety of sources, including aptitude and achievement tests, parent/guardian input, and teacher recommendations, as well as information about the student's physical condition, social or cultural background, and adaptive behavior. The group shall ensure that the information obtained from these sources is documented and carefully considered. (34 CFR 300.306)

The personnel who evaluate the student shall prepare a written report of the results of each evaluation. The report shall include, but not be limited to, the following: (Education Code 56327)

- 1. Whether the student may need special education and related services
- 2. The basis for making the determination
- 3. The relevant behavior noted during the observation of the student in an appropriate setting
- 4. The relationship of that behavior to the student's academic and social functioning
- 5. The educationally relevant health, developmental, and medical findings, if any
- 6. For students with learning disabilities, whether there is such a discrepancy between achievement and ability that it cannot teannot be corrected without special education and related services
- 7. A determination concerning the effects of environmental, cultural, or economic disadvantage, where appropriate
- 8. The need for specialized services, materials, and equipment for students with low incidence disabilities, consistent with consistent with Education Code 56136

### **Eligibility Determination**

Upon completion of the administration of assessments and other evaluation measures, a group of qualified professionals and the parent/guardian shall determine whether the student is a student with a disability as defined in 5 CCR 3030 and 34 CFR 300.8 and, if so, the student's educational needs. In interpreting the data, the group shall draw information from a variety of sources, including aptitude and achievement tests, parent/guardian input, and teacher recommendations, as well as information about the student's physical condition, social or cultural background, and adaptive behavior. The group shall ensure that the information obtained from these sources is documented and carefully considered. (34 CFR 300.306)

When making a determination of eligibility for special education and related services, the district shall not determine that a student is disabled if the primary factor for such determination is a lack of appropriate instruction in reading, including the essential components of reading instruction pursuant to 20 USC 6368 of the No Child Left Behind Act, lack of instruction in mathematics, limited English proficiency, or that the student does not otherwise meet the eligibility criteria. ((34 CFR 300.306; Education Code 56329; 34 CFR 300.306)

The normal process of second-language acquisition, as well as manifestations of dialect and sociolinguistic variance, shall not be diagnosed as a disabling condition. (5 CCR 3023)

If a determination is made that a student has a disability and needs special education and related services, an IEP shall be developed within a total time not to exceed 60 days, not counting days between the student's regular school sessions, terms, or days of school vacation in excess of five school days, from the date of the receipt of the parent/guardian's consent for evaluation, unless the parent/guardian agrees, in writing, to an extension. (34 CFR 300.306; Education Code 56043)

### **Independent Educational Evaluation**

The parents/guardians of a student with a disability have the right to obtain an independent educational evaluation at public expense under the same criteria that the district uses for a district-initiated evaluation. An independent educational evaluation is defined as an evaluation conducted by a qualified examiner who is not employed by the district. (34 CFR 300.502)

Public expense means that the district either pays for the full cost of the <u>IEEindependent educational</u> evaluation or ensures that the evaluation is otherwise provided at no cost to the parent/guardian. (34 CFR 300.502)

### (34 CFR 300.502)

The parents/guardians of a student with a disability have the right to obtain an IEE at public expense under the same criteria, including the location of the evaluation and the qualifications of the examiner, that the district uses for a district-initiated evaluation. (34 CFR 300.502)

The parent/guardian is entitled to only one <u>IEEindependent educational evaluation</u> at public expense each time the district conducts an evaluation with which the parent/guardian disagrees. <u>(Education Code 56329; </u>434 CFR 300.502)

If a parent/guardian has requested an <a href="IEEindependent educational evaluation">IEEindependent educational evaluation</a>, the district may ask for thea reason that <a href="Image: the parent/guardian">Image: the parent/guardian</a> he/she objects to the district's evaluation. \_However, the parent/guardian is not required to provide <a href="an explanation and the district may not unreasonably delay either providing the IEE at public expense or filing a due process complaint to request a due process hearing to defend the public evaluation. the reason to the district." (34 CFR 300.502)

Upon receiving the request for an <u>IEE</u>independent educational evaluation, the district shall, without unnecessary delay, either: (34 CFR 300.502)

- 1. File a due process complaint to request a hearing to show that its evaluation is appropriate
- 2. Ensure that an <u>IEEindependent evaluation</u> is provided at public expense, unless the district <u>demonstrates</u> at <u>a hearingahearing</u> that the evaluation obtained by the parent/guardian did not satisfy the district's criteria

If a due process hearing decision determines that the district's evaluation is appropriate, then the parent/guardian may obtain an <a href="IEE">IEE</a> independent evaluation</a> but not at public expense. <a href="IEE">(Education Code</a> 56329; (34 CFR 300.502)

In any decision made with respect to providing FAPE to a student with a disability, the result The results of any IEEan independent evaluation obtained by the student's parent/guardian, whether at public or private expense, shall be considered by the district if it meets district criteria. Any such result also in any decision made with respect to FAPE and may be presented as evidence at a hearing on a due process complaint. (Education Code 56329; (34 CFR 300.502)

#### Reevaluation

A reevaluation shall be conducted when the district determines that the educational or related services needs of the student, including improved academic achievement and functional performance, warrant a reevaluation or if the student's parent/guardian or teacher requests reevaluation. Such reevaluations shall occur every three years, unless the parent/guardian and district agree in writing that a reevaluation is unnecessary. A reevaluation may not occur more than once a year, unless the parent/guardian and the district agree otherwise. ((34 CFR 300.303; Education Code 56043, 56381; 34 CFR 300.303)

The district shall ensure that any reevaluations of the student are conducted in accordance with the evaluation procedures pursuant to 34 CFR 300.304-300.311. (34 CFR 300.303)

Before entering kindergarten or first grade, as the case may be, children with disabilities who are in a preschool program shall be reevaluated to determine if they still need special education and services. \_IEP teams shall identify a means of monitoring the continued success of children who are determined to be eligible for less intensive special education programs. \_to ensure that gains made are not lost by a rapid removal of individualized programs and supports for these children. (Education Code 56445)

### Policy 6164.41: Children With Disabilities Enrolled By Their Parents In Private School

Status: ADOPTED

Original Adopted Date: 09/19/2007

The Board of Trustees recognizes its obligations under <u>state and</u> federal <u>and state</u> law to <u>locate</u>, identify, <u>evaluate</u>, and provide equitable services to children voluntarily enrolled by their parents/guardians in private schools located within the district.

### (cf. 0430 - Comprehensive Local Plan for Special Education)

The Superintendent or designee shall ensure that activities to locate, identify, and evaluate children with disabilities enrolled by their parents/guardians in private schools within the district are comparable to activities undertaken for individuals with disabilities aged three to 22 in public schools within the district. ((34 CFR 300.131); Education Code 56171; 34 CFR 300.131)

### (cf. 6164.4 - Identification and Evaluation of Individuals for Special Education)

The Superintendent or designee shall develop a budget for the provision of services to children with disabilities enrolled by their parents/guardians in private school based on the proportionate share of federal funds received and the number of eligible children, including the possibility of mid-year enrollees, and the types of services to be provided.

Regulation 6164.41: Children With Disabilities Enrolled By Their Parents In Private School

Status: ADOPTED

Original Adopted Date: 09/27/2017

#### **Definitions**

Parentally\_-placed private school children with disabilities means children with disabilities who are voluntarily enrolled by their parents/guardians in a private school or facility within district boundaries, including children who are attending a private school or facility within district boundaries but who reside in another district or state. (34 CFR 300.130, 300.131)

*Private school or facility* means a private full-time day school, including a religious school, located within district boundaries, that has filed an affidavit with the California Department of Education pursuant to Education Code 33190 and is registered in the California Private School Directory.

### **Consultation with Private School Representatives**

The Superintendent or designee shall consult with all private school representatives and representatives of parents/guardians of parentally\_placed private school children with disabilities during the design and development of equitable services for the children. In order to ensure a meaningful and timely consultation, the consultation shall include: (Education Code 56301; (20 USC 1412(a)(10)(A)(iii3)); 34 CFR 300.134; Education Code 56301)

- 1. The child find process and how parentally\_-placed private school children suspected of having a disability <a href="mailto:can participate">can participate</a> equitably
- 2. <u>The manner in which How</u> parents/guardians, teachers, and private school officials will be informed of the child find process
- 3. The determination of the proportionate share of federal funds available to serve parentally\_-placed private school children with disabilities and how this share is calculated
- 4. How the consultation process <u>among district staff, private school officials, and representatives of parents of parentally-placed private school children with disabilities will operate throughout the school year to ensure that identified children <u>can meaningfully canmeaningfully</u> participate in equitable services</u>
- 5. The provision of equitable special education and related services including how, when How, where, and by whom such equitable services will be provided including a discussion about the types of services, alternate service delivery mechanisms, how services will be apportioned if funds are insufficient to serve all of the identified children, and how and when those decisions will be made
- 6. In the event that the district and private school disagree on the provision of or the types of services, how the district will provide the private school officials with a written explanation of the reasons that the district chose to not provide the services

When meaningful and timely consultation has occurred, the district shall obtain a written affirmation signed by the representatives of participating private schools. If the private school representatives do not provide the affirmation within a reasonable period of time, the district shall forward documentation of the consultation process to the California Department of Education. (34 CFR 300.135; Education Code 56172; 20 USC 1412; 34 CFR 300.135)

After the consultation has occurred, the district shall ensure an annual count of the number of parentally-placed children with disabilities attending private schools located within the district. This count shall be conducted between October 1 and December 1 each year and shall be used to determine the amount the district must spend on providing equitable services to the children in the subsequent fiscal year. (34 CFR 300.133) **Provision of Services** 

A child with a disability parentally\_-placed in a private school has no individual right to receive some or all of the

-special education and related services that he/she would have been received receive if enrolled in public school. Such a child may receive a different amount of services than students with disabilities in public schools. (34 CFR 300.137, 300.138)

### (cf. 6164.4 - Identification and Evaluation of Individuals for Special Education)

The district shall evaluate all identified parentally\_-placed private school children with disabilities for purposes of considering them for equitable services. \_This evaluation shall be conducted in accordance with the timelines and procedures for evaluating public school students with disabilities pursuant to 34 CFR 300.300-300.311 and as specified in BP/AR 6164.4 - Identification and Evaluation of Individuals for Special Education, including obtaining parent/guardian consent and providing the parent/guardian with a copy of the procedural safeguards notice.\_ (34 CFR 300.131, 300.504)

### (cf. 6159.1 - Procedural Safeguards and Complaints for Special Education)

If n order to ensure that each child entitled to special education and related services from the district receives an offer of a free appropriate public education (FAPE), the district where the child resides in the district and is eligible for an shall develop an individualized education program (IEP), for each identified child who attends a private school located in the district shall make a free appropriate public education (FAPE) available to and who resides in the child. district.

However, the district <u>isshall</u> not <u>required to</u> develop an IEP if the parent/guardian makes clear <u>thehis/her</u> intention to keep the child enrolled in private school. In such situations, the district shall obtain written certification confirming the parent/guardian's intention to keep <u>thehis/her</u> child enrolled in private school, including the fact that <u>the parent/guardianhe/she</u> is not interested in the development of an IEP or the district's offer of FAPE. If the parent/guardian does not provide confirmation in writing, the district shall obtain oral confirmation of the parent/guardian's intention and confirm the conversation in writing.

If the child resides in a different district, then this district and the district of residence shall work together to ensure that the parent/guardian receives an offer of FAPE in accordance with law.

The district shall develop and implement an individual service plan (ISP) for each identified private school child with a disability enrolled by their parents/guardians in a private school within the district's boundaries an individual services plan (ISP) that describes the equitable services that the district will provide, as determined agreed to by the district after the consultation process with and private school representatives. during the consultation process. (34 CFR 300.138)

The ISP shall be developed, reviewed, and revised consistent with 20 USC 1414. 34 CFR 300.121-300.324. A representative of the private school shall be invited to attend each ISP team meeting. If the representative cannot attend the meeting, the district shall use other methods to ensure the representative's participation, including individual or conference calls. (34 CFR 300.137, 300.138)

### (cf. 6159 - Individualized Education Program)

The district may provide services on the private school premises, including a religious school, to the extent consistent with law. The services shall be provided by personnel meeting the same standards as personnel providing services in the public school except that private elementary school and secondary school teachers who are providing equitable services to parentally-placed private school children with disabilities do not have to meet the special education teacher qualification requirements specified in 34 CFR 300.156. The personnel shall either be district employees or contractors of the district. (34 CFR 300.138, 300.139)

The district shall offer transportation to the child if services are provided on a site other than the child's school and the ISP team determines that transportation is necessary for the child to benefit from or participate in the services provided in the ISP. Depending on the timing of the services, the district shall provide transportation from the child's school or home to the service site and from the service site to the child's school or home. (34 CFR 300.139)

The district may place equipment and supplies in a private school for the period of time necessary to provide the services pursuant to the ISP. All such equipment shall remain the property of the district and must be able to be removed without remodeling or causing damage to the private school. The district shall remove the equipment when no longer required by the child, when the child no longer attends the private school, or when removal is necessary to prevent unauthorized use. (34 CFR 300.144)

### **PURPOSE:**

Education Code Section 17014 requires the Board of Education to certify as part of the school district's annual budget process that a plan has been prepared for completing major maintenance, repair, and replacement requirements for state-funded school facilities.

To meet this plan requirement and to ensure that all Hanford Elementary School District (HESD) facilities are maintained in good repair, HESD has (1) established a School Facilities Inspection System to identify, budget, and schedule maintenance needs; (2) established and maintains a Routine Restricted Maintenance account within the General Fund for ongoing and major maintenance of HESD buildings, pursuant to Education Code Section 17070.75; and (3) has established a separate fund for purposes of Deferred Maintenance, pursuant to Education Code Section 17582.

Staff hereby requests that the Board certify that a Comprehensive Facilities Maintenance Plan has been established pursuant to Education Code Section 17014.

### HANFORD ELEMENTARY SCHOOL DISTRICT COMPREHENSIVE FACILITIES MAINTENANCE PLAN (ROUTINE RESTRICTED AND DEFERRED MAINTENANCE PROGRAMS)

### 1. OVERVIEW

The Hanford Elementary School District (HESD) participates in the State School Facility Program (SFP) and in the Deferred Maintenance Program (DMP). The SFP requires participating districts to assure that State-funded projects are kept in good repair. In order to ensure that facilities are maintained in good repair, the SFP and DMP programs require districts to have a School Facilities Inspection System in place, and also require that funds be budgeted and expended to make necessary repairs.

To meet these requirements, HESD has (1) established a School Facilities Inspection System; (2) established and maintains a restricted account (Routine Restricted Maintenance, Resource 8150) within the General Fund for ongoing and major maintenance of HESD buildings, pursuant to Education Code Section 17070.75; and (3) has established a separate fund for purposes of Deferred Maintenance (Fund 1400), pursuant to Education Code Section 17582.

HESD will identify maintenance concerns through the Facilities Inspection System that utilizes an annual evaluation with the Facility Inspection Tool and a work order system, will plan and schedule the work using routine work orders and the Deferred Maintenance Program, and will fund the necessary repairs using a combination of Routine Restricted Maintenance (RRM) funds and Deferred Maintenance funds.

The HESD shall budget the statutory minimum annually for RRM Projects and shall at least transfer the statutory amount of the unrestricted General Fund revenue into the RRM account, for no less than twenty (20) years. HESD shall set-aside the at least the statutory minimum of its current year Local Control Funding Formula as its match for DMP projects.

Unexpended balances in the RRM account and the Deferred Maintenance Fund shall be carried forward to be spent on maintenance expenditures in future years.

Annually before September 30, the RRM Account Certification shall be completed and filed by the Chief Business Official when required. The DMP will be updated by the Facilities Department in accordance with the current statute.

#### 2. ROUTINE RESTRICTED MAINTENANCE EXPENDITURES

The RRM Account shall be used for "maintenance" of HESD facilities. The California School Accounting Manual defines maintenance as:

"Activities involved with repairing, restoring, or renovating school property, including grounds, buildings, site improvements, building fixtures, and service systems."

RRM Account expenditures will be made as allowed by the Office of Public School Construction (OPSC). OPSC has identified four types of maintenance that may be accomplished using RRM Account funds:

- 1. <u>Breakdown</u>: The emergency maintenance to equipment necessary to continue normal school functions.
- 2. <u>Operating</u>: Work necessary for a component to function and operate properly (i.e., lubrication, belt replacement, tune up, replacement of lighting ballasts).
- 3. <u>Preventive</u>: Regularly scheduled maintenance based on life-cycle projection of various components.
- 4. <u>Overhaul</u>: Periodic major repair or replacement of operating parts and components of equipment.

Education Code Section further defines major maintenance as "all actions necessary to keep flooring, siding, painting, floor and window coverings, fixtures, cabinets, heating and cooling systems, landscaping, fences, and other items designated by the Governing Board of the school district in good repair."

HESD will use the RRM funds for expenditures as indicated above.

In addition to the expenditures indicated above, the expenditures listed below are necessary for maintenance of HESD facilities, are eligible to be paid from RRM funds, and may be partially charged to the General Fund, Resource 8150 as appropriate.

- 1. Facilities Department management and technicians
- 2. Facilities Department office staff
- 3. Contracted maintenance workers
- 4. Office supplies necessary for maintenance functions
- 5. Maintenance supplies (nails, hammers, paint, brushes, wood, pipe)
- 6. Staff development to keep staff up to date on the latest technology
- 7. Equipment (vehicles, tools, machine rentals)

#### 3. DEFERRED MAINTENANCE EXPENDITURES

Deferred Maintenance projects include but are not limited to major repair or replacement of building parts and components. Major maintenance for Deferred Maintenance purposes includes asbestos abatement, classroom lighting, electrical, floor covering, HVAC, painting, paving, plumbing, roofing, underground tanks, wall systems, and lead based paint abatement.

The Facilities Department will determine whether projects are more appropriately paid through the RRM or the DMP.

#### 4. ANNUAL REVIEW AND UPDATING

The Comprehensive Facilities Maintenance Plan will be reviewed annually as part of the annual budget process and will be updated as needed. This plan, including any components or updates, will be available for public review during normal working hours.

### ITEM:

Consider approval of contract for survey services.

### **PURPOSE:**

The District would like to conduct a survey to assess the public's opinion on the projects that have been identified in the Facilities Master Plan and the financing thereof. Isom Advisors facilitates such surveys and has been approached to draft an agreement to conduct a phone survey to assess such.

### **FISCAL IMPACT:**

The cost of the survey is not to exceed \$12,500.

## Consulting Services Agreement

This CONSULTING SERVICES AGREEMENT (this "Agreement") is dated as of the latest date set forth on the signature page hereto (the "Effective Date") and is entered into by and between Isom Advisors, a Division of Urban Futures Inc., a California corporation ("Advisor"), and the Hanford Elementary School District ("District").

### Advisor agrees to:

- 1. Prepare a telephone-based tracking survey of the voters of the District, the purpose of which is to collect updated information on the feasibility of a voter approved tax measure in the District.
- 2. Survey an audience that consists of a random sample of registered voters that represents a subset of the various demographics in the community (i.e. age, political party, ethnicity, parent/non-parent, gender, and geographic location)
- Test specific project support and tax tolerances and overall support for a local school district tax measure.
- 4. Prepare a summary survey presentation to be presented to the District and Board at a public board meeting.

### District agrees to:

1. Fully cooperate and assist Advisor in providing appropriate background data unique to the District including project lists for the development of the survey on behalf of District.

### **Consideration:**

- 1. In consideration for the above services, District agrees to pay Advisor pursuant to the following:
  - a. The fee for the survey will be not to exceed Twelve Thousand Five Hundred Dollars (\$12,500) and is to be paid upon presentation of results to the District.
  - b. This agreement shall terminate with 30 days written notice from either party sent via certified mail.

### **Arbitration:**

In the event of a dispute between the parties regarding the terms or performance of this Agreement, the parties agree to decide this dispute under the rules of the American Arbitration Association.

### **Complete Agreement:**

The parties agree that this Agreement is the complete agreement between the parties superseding all prior written or oral agreements between the parties. The parties further agree that this Agreement can be altered or modified only through a writing signed and dated by both parties.
