DEFINITIONS

Respiratory Symptoms: Respiratory symptoms may include coughing, wheezing, shortness of breath, and chest tightness. **Sensitive Students**: Sensitive students may include those with asthma, cystic fibrosis, chronic lung disease, congenital heart disease, compromised immune systems, or other respiratory problems.

PROCEDURES FOR IMPLEMENTATION

I. Parent Notification and Action

- A. At the beginning of every school year, each school that provides outdoor recess or outdoor physical education (PE) classes to its students shall notify parents of the district's outdoor air quality policy and these procedures. A sample letter that principals may use to inform parents of this information is located in the school leadership and performance section of the District Document Center.
- B. Parents, with the advice of their health care provider, must inform the school secretary or school nurse, if their child is sensitive to poor air quality, and therefore should have limited outdoor physical education when the air quality is poor (hereafter referred to as "sensitive students").

II. School Responsibilities

- A. Every day the principal or designee shall check the outdoor air quality before outdoor PE classes are held or the students are allowed to play outside at recess.
- B. The principal or designee shall check the current Particulate Matter (PM2.5) levels provided by the Utah Department of Health (DOH) at least once daily. Because air quality changes throughout the day, the district encourages checking the PM2.5 levels before each scheduled recess.
- C. This information can be accessed on the DOH website, www.airquality.utah.gov, by clicking on "current conditions." The DOH provides other options for obtaining this information such as email alerts, downloading an air quality app, telephone updates, etc.
- D. The following categories provide guidelines for when outdoor physical activity is appropriate based on the air quality. Principals, or their designees, in their sole discretion, may restrict outdoor physical activity at even lower PM2.5 levels.
 - When the PM2.5 level is between 35.5 55.4 ug/m³, sensitive students and students with respiratory symptoms should remain indoors for recess and PE classes.
 - 2. When the PM2.5 level is above 55.5 ug/m³, all students should remain indoors for recess and PE classes.
- E. After checking the PM2.5 levels, the principal or designee must notify the staff when students should stay indoors.

III. Salt Lake City's Idle Free Ordinance

- A. When picking up or dropping off students from a district school, drivers should be aware that state law prohibits unnecessary vehicle idling for more than two minutes.

IV. Air Quality Flag Program

- A. Schools may choose to participate in the Air Quality Flag Program, which was developed by the Environmental Protection Agency (EPA) and uses brightly colored flags based on the EPA Air Quality Index (AQI) to notify people and their communities about outdoor air quality conditions.
- B. Participating schools raise a flag each day that corresponds to their local air quality forecast.
- C. The Air Quality Flag Program is designed to increase awareness of air quality, not make decisions about recess.
 - 1. Principals must still determine the appropriateness of having students engage in outdoor physical activities based on the outdoor air quality.
- D. The Utah Asthma Program has a limited number of flag sets available to organizations and schools for free; school principals can contact asthma@utah.gov to receive a free air quality flag kit.
