

## **DIRECTOR DISTRICT BOUNDARIES**

It is the responsibility of the Board of Directors to establish the boundaries of the internal director districts of the school district, and to redistrict the director districts as necessary.

The Board of Directors, with the assistance of the administration, the ESD and the State Redistricting Commission, shall develop a plan of proposed director districts within eight months of any of the following events:

1. 1. Receipt of federal decennial census data;
2. 2. Consolidation of the district with one or more other districts;
3. 3. Transfer of territory to or from the district;
4. 4. Annexation of territory to or from the district; or
5. 5. Approval by a majority of the district's voters of a proposal to divide the district into director districts.

The plan of proposed director districts shall meet the following criteria:

1. 1. The districts shall be as nearly as possible equal in population;
2. 2. The districts shall be as compact as possible and consist of geographically contiguous area;
3. 3. The districts shall not favor or disfavor any racial group or political party; and
4. 4. The districts shall as much as possible coincide with natural boundaries and existing communities.

Any registered voter in the district may challenge the plan within 45 days of the plan's adoption by requesting that the superior court review the plan for compliance with the four criteria listed above.

### **Director District 1 Narrative Descriptions** (as of November 2022 redistricting)

Starting at the intersection of school district boundary and Stickney Island Rd. Meandering easterly on Stickney Island Rd to Park Dr. Southeast on Park Dr to W Main St. Easterly on W Main St to N Harkness St. North on N Harkness St to W 2nd St. East on W and E 2nd St to Shuksan St. South on Shuksan St to E Main St. East on E Main St to Blair Dr. South on Blair Dr to Reeds Ln. East on Reeds Ln to the 2020 Census city limits for Everson. Clockwise on the 2020 Census city limits for Everson to the Nooksack River in Section 31, Township 40, Range 04E. Southerly on the Nooksack River to the school district boundary. Clockwise on the school district boundary to the point of the beginning.

### **Director District 2** (as of November 2022 redistricting)

Starting at the intersection of northeast corner of Section 25, Township 40, Range 04E. West 3.5 miles, more or less, to the North/South centerline of Section 21, Township 40, Range 04E. North 2 miles, more or less, to E Badger Rd. West on E Badger Rd to the school district border. South on the school district border to Stickney Island Rd. Meandering easterly on Stickney Island Rd to Park Dr. Southeast on Park Dr to W Main St. Easterly on W Main St to N Harkness St. North on N Harkness St to W 2nd St. East on W and E 2nd St to Shuksan St. South on Shuksan St to E Main St. East on E Main St to Blair Dr. South on Blair Dr to Reeds Ln.

East on Reeds Ln to the 2020 Census city limits for Everson. Clockwise on the 2020 Census city limits for Everson to the Nooksack River in Section 31, Township 40, Range 04E.  
 Southerly on the Nooksack River to the school district boundary. East and north on the school district boundary to the eastern border of Section 25, Township 40, Range 04E.  
 North on said section line to the point of the beginning.

**Director District 3** (as of November 2022 redistricting)

Starting at the intersection of northeast corner of Section 25, Township 40, Range 04E. West 3.5 miles, more or less, to the North/South centerline of Section 21, Township 40, Range 04E.  
 North 2 miles, more or less, to E Badger Rd. West on E Badger Rd to the school district border.  
 Clockwise on the school district border to the eastern border of Section 25, Township 40, Range 04E. North on said section line to the point of the beginning.

**Director District 4** (as of November 2022 redistricting)
