Mr. Oslwen C. Anderson, Jr., Business Manager, provided an update on the repairs at the high school because of a sewer blockage. The district engaged 4 different companies to rectify the problem. East Coast Trenchless found extensive corrosion and was able to repair approximately 60 feet of sewer piping. As a result of the blockage, the high school was closed for 3 school days.

Paige Mullen and Ava Waters, Student Representatives, presented updates on activities from the high school and the middle school. (attached to BoardDocs)

Mr. Dwayne DeFoor, Alumni Association President, shared updates from the Alumni Association and HANNA Foundation. The HANNA Pantry volunteers logged 323 hours and served 301 families in January. Upcoming events include The Susquehanna Invitational Golf Tournament on June 24, 2022, Candy Scramble on Saturday, April 2nd at Roscoe Warner Field and Springfest on Saturday, May 7, 2022. Mr. Defoor shared that stakeholder meetings have been held regarding the new fieldhouse. Note # 1: In accordance with the above recommendation the requested approval relates to all plumbing construction required at both the High School and Middle School in connection with Auditorium and Bathroom Renovations on the 1st floor of each of these schools.

Note # 2: In accordance with the above recommendation the requested approval secures the completion of parking lot improvements and resurfacing at the High School, Sara Lindemuth/Anna Carter Kindergarten Center (SL/AC) and Administration Building. Due to a current shortfall in funding, the Middle School and Thomas W. Holtzman, Jr. Elementary are recommended for deferment until additional financing can be secured.
