### August 18, 2020 BOARD OF EDUCATION MEETING – BOARD BITS

The Allen East Local School Board of Education meet in regular session on Tuesday, August 18, 2020 at 7:00 P.M.

The roll call was marked and the pledge recited.

The Minutes of the July 7, 2020, regular session, Board of Education meeting were approved as read.

Report of the Chief Fiscal Officer was given and approved as presented.

Report was given by Allen East Superintendent, Mr. Rentschler.

In new business the Board accepted, adopted, discussed and recognized:

- Purchase of 90 Apple iPad Airs - \$43,000.
- Purchase Edgenuity – 40 elementary digital academy licenses - \$88,000.
- Purchase Nitrile gloves and supplies from Key Janitorial supply - \$5,768.75.
- Nickles Bakery, Inc. supplier of bakery products in 2020-2021.
- Reiter Dairy supplier of dairy products in 2020-2021.
- Winegardner Petroleum, LLC supplier of petroleum products in 2020-2021.
- 2020-2021 bus routes and stops.
- Use of football field by local youth athletic teams July, 2020 through October, 2021.
- Expense allowance for students participating in state tournament competition.
- Contract with Allen County Sheriff's Department to provide police protection for athletic events and extra-curricular activities.
- Non-public school transportation resolution for parents who reside in Allen East and whose students attend parochial schools.
- Designated September 13-19, 2020 as Arts in Education week.
- Resolution with Wood County Education Service Center for Wood county Juvenile Detention Center and Juvenile Residential Center of Northwest OH.
