D. English Learners at Lincoln

- a. Current EL percentages are close to 20% and rising
 - i. Languages spoken: Spanish, Filipino, Farsi, Hindi, Punjabi, Vietnamese
- b. ELPAC
 - i. First taken when entering school for the first time
 - ii. Based on that score, students will receive various supports within their regular content classrooms
 - iii. ELD Support Staff
 - 1. ELD Specialist: Pauline Kim
 - 2. Bilingual Aide: April Puell
 - 3. Reading Specialist: Latsamy Colla
 - iv. **Q** - Do they receive these supports in English or Spanish?
 - 1. **A** - Instruction is given in English.

E. Reclassification

- a. Students can qualify as fluent English proficient (RFEP)
 - i. Overall 4 on all parts of the ELPAC
 - ii. Mid or Above Grade Level on all parts of the iReady

F. EL Intervention and Support at Lincoln (Outside Classroom)

- a. Student Success Team (SST)
 - i. Students can be referred by Teachers, School Personnel, or Parents
 - ii. SSTs are available for any students who are at high-risk for academic failure for any number of reasons

- b. 504 Plans
 - i. Involves school records, parent input, etc
 - ii. For students with disabilities (physical or mental) to support them to be successful in the classroom
 - iii. Different than an IEP
 - 1. IEP will give service minutes outside of their regular classroom for support
 - 2. 504s will give students support within their regular classroom
 - iv. **Q** - Would a student with an IEP still receive EL supports?
 - 1. **A** - In the IEP there is a section referencing EL supports and instructions needed, so that the EL instruction is included within the IEP.
