In response to your FOIA request submitted on Feb. 4, please see the attached copies of the current Crime Policy, General/School Leaders Liability Policy, and General Liability Certificate of Insurance.

The District's Annual Comprehensive Finance Report and the Approved General Fund Budget book (p. 108) contain a schedule of outstanding general obligation bonds through June 30, 2021. SCSBIT provides manuscript (i.e. custom) policies in South Carolina tailored to the unique needs of school districts. SCSBIT typically does not use forms from The Association for Cooperative Operations Research and Development (ACORD) in their policies because they are generic standardized forms.
