<u>Health Concerns:</u> occasional monitoring is required, but currently the physical and/or social emotional condition is uncomplicated.

Behaviorally Disabled: conduct disorders; learning disabilities; ADHD.

Total school population for 2021-2122 is 1697 students. As of September 2021, all classes are graded, with students ranging in age from 13 to 20 years old. The grade levels represented are 9-12. Of the 269 classified students, 269 receive services at the high school. An additional 41 student receive services under 504. Communication between health professionals is by phone, fax, e-mail, and regular meetings. The certified school nurses reinforce one another in the event of any emergency. Regular meetings of CSNs are planned as needed to discuss continuity of service, identification of needs, health planning, etc.
