SWIS - PROBLEM BEHAVIOR	INFINITE CAMPUS - BEHAVIOR EVENT	Definition for Major Violation
ABUSIVE LANGUAGE/INAPPROPRIATE LANGUAGE/PROFANITY	ABUSIVE/INAPPROPRIATE LANGUAGE/PROFANITY -or- VERBAL AGGRESSION <i>[multiple options in IC - please see definition]</i>	Student engages in profane, vulgar or obscene behaviors. Student causes, creates or distributes or attempts to cause, create or distribute profane, vulgar, or obscene material.
ARSON	ARSON	Student plans and/or participates in malicious burning of property.
BOMB THREATS/FALSE ALARM	BOMB THREATS -or- FALSE FIRE ALARMS/911 REPORTING <i>[multiple options in IC - please see definition]</i>	Student delivers a message of possible explosive materials being on-campus, near campus, and/or pending explosion.
BULLYING	BULLYING	The student engages in behaviors such as, hazing, menacing, taunting, intimidation, subjecting others to physical contact, or other threatening language or behavior, including but not limited to the use of electronic or online methods.
DEFIANCE/INSUBORDINATION/NON-COMPLIANCE	DEFIANCE/INSUBORDINATION/NON-COMPLIANCE	Student engages in refusal to follow directions or talks back.
DISRESPECT	DISRESPECT	Student delivers socially rude or dismissive messages to adults or students.
DISRUPTION	DISRUPTION	Student engages in behavior causing an interruption in a class or activity. Disruption includes sustained loud talk, yelling, or screaming; noise with materials; horseplay or roughhousing; and/or sustained out-of-seat behavior, any conduct that materially or substantially interferes with another student's access to educational opportunities or programs, including the ability to attend, participate in and benefit from instructional and extracurricular activities.
DRESS CODE VIOLATION	DRESS CODE VIOLATION	Student wears clothing that does not fit within the dress code guidelines practiced by the school/district.
FIGHTING	FIGHTING	The student assaults, batters, or physically, sexually or verbally abuses a teacher, another student or other school personnel.
FORGERY/THEFT/PLAGIARISM	FORGERY -or- THEFT <i>[multiple options in IC - please see definition]</i>	Forgery: The student has signed a person's name without that person's permission or claims someone else's work as their own. Theft: Student is involved by being in possession of, having passed on, or being responsible for removing someone else's property.
GANG AFFILIATION DISPLAY	GANG AFFILIATION DISPLAY	Student uses gesture, dress, and/or speech to display affiliation with a gang.
HARASSMENT	HARASSMENT/DISCRIMINATION -or- THREAT/INTIMIDATION <i>[multiple options in IC - please see definition]</i>	Harassment/Discrimination is intimidation, annoyance, or alarm to another person by threats of or actual physical contact or violence; the creation, by whatever means, of a climate of hostility, intimidation, fear of harm, humiliation, or embarrassment; or the use of language, conduct or symbols in such manner as to be commonly understood to convey hatred, contempt, or prejudice or to have the effect of insulting or stigmatizing an individual. Harassment/Discrimination is behavior based on race, color, national origin, age, religion, marital status, political beliefs, sex or disability that is sufficiently severe, pervasive, or objectively offensive that it adversely affects a student's education or creates a hostile or abusive educational environment. <i>Threats that are independent of discrimination should be coded in Infinite Campus as "Threats". ... Students shall not threaten to cause injury or harm to another person. Threat shall refer to a communication made by any means including but not limited to electronic and/or online methods.</i>
INAPPROPRIATE DISPLAY OF AFFECTION	INAPPROPRIATE DISPLAY OF AFFECTION	Student engages in inappropriate, consensual (as defined by school) verbal and/or physical gestures/contact, of a sexual nature to another student/adult.
INAPPROPRIATE LOCATION/OUT OF BOUNDS AREA	INAPPROPRIATE LOCATION/OUT OF BOUNDS AREA	Student is in an area that is outside of school boundaries (as defined by school).
LYING/CHEATING	CHEATING -or- OTHER INAPPROPRIATE BEHAVIOR <i>[multiple options in IC - please see definition]</i>	Cheating: The student falsifies a document, delivers a message that is not true, or claims someone else's work as their own. Lying: Student delivers message that is untrue.
OTHER BEHAVIOR	INAPPROPRIATE SEXUAL BEHAVIOR -or- OTHER ILLEGAL ACTS/ITEMS -or- OTHER INAPPROPRIATE BEHAVIOR -or- POSSESSION/USE OF NOXIOUS SUBSTANCE <i>[multiple options in IC - please select the most appropriate option based on the description of the behavior on the referral form]</i>	Student engages in problem behavior not otherwise listed.

Office Discipline Referral Definitions

PHYSICAL AGRESSION	PHYSICAL AGRESSION	Student engages in actions involving serious physical contact where injury may occur (e.g., hitting, punching, hitting with an object, kicking, hair pulling, scratching, etc.).
PROPERTY/DAMAGE/ VANDALISM (Also Property Misuse)	SCHOOL PROPERTY DAMAGE/VANDALISM/MISUSE	Any student, organization, or group of students that participates in activities that destroy, deface, damage or remove school property or personal property on school property or at school-sponsored activities.
SKIP CLASS	SKIPPING SCHOOL/CLASS	Student leaves or misses class or leaves the building without permission.
TARDY	TARDY TO SCHOOL/CLASS	Student is late (as defined by the school) to class or the start of the school day.
TECHNOLOGY VIOLATION	TECHNOLOGY VIOLATION	Student engages in inappropriate (as defined by Acceptable Use Policy and Procedure) use of cell phone, pager, music/video players, camera, computer and/or other device.
USE POSSESSION OF WEAPONS	POSSESSION/USE OF FIRE ARM -or- POSSESSION/USE OF KNIVES <i>[multiple options in IC - please see definition]</i>	Student is in possession of knives and/or fire arms (real or look alike). See school/district policy.
USE/POSESSION OF ALCOHOL	POSSESSION/USE OF ALCOHOL	Includes the purchase, possession, attempt to possess, use, being under the influence, selling, or transferring of alcoholic beverages on school property, at any location of a school-sponsored activity, or en route to or from school or a school-sponsored activity.
USE/POSSESSION OF DRUGS	DRUG LOOK-A-LIKE -or- POSSESSION/USE/TRANSFER OF DRUG <i>[multiple options in IC - please see definition]</i>	Includes the purchase, possession, attempt to possess, use, being under the influence, selling, or transferring of the following on school property, at any location of a school-sponsored activity, or en route to or from school or a school-sponsored activity: 1) Controlled drug substances and drug paraphernalia; 2) Substances that "look like" a controlled substance. In instances involving look-alike substances, there must be evidence of the student's intent to pass off the item as a controlled substance; or 3) Unauthorized prescription, OTC (over-the-counter), and other abused or controlled substances.
USE/POSESSION OF TOBACCO	POSSESSION/USE OF TOBACCO	Student is in possession of or is using tobacco.
