A – VISION 2030: FINANCE & INFRASTRUCTURE Discussion Item: Committee Report

FINANCE

1. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the Proposed Tentative Budget for Fiscal Year 2017-2018 for submission as follows:

WHEREAS, in addition to the public hearing scheduled to be held on May 2, 2017, the Board of Education discussed the 2017-2018 School District Budget and provided opportunity for public comment at each Board meeting where the Board discussed the 2017-2018 Budget from December 1, 2016 through March 7, 2017; and

WHEREAS, the tentative 2017-2018 School District Budget requires the use of Health Care Cost Adjustments in the amount of \$438,306.00 and

WHEREAS, the school district policy (Expenses - #9250) and N.J.A.C. 6A:23A-7.3 provides that the Board of Education shall establish in the annual school budget a maximum expenditure for the 2017-2018 school year; and

WHEREAS, that the Sayreville Board of Education hereby establishes the school district travel maximum for the 2017-2018 school year at the sum of \$15,000.00 and be it further resolved that the School Business Administrator shall track and record these costs to insure that the maximum is not exceeded. Current 2016-2017 school-year expenditures are \$4,011.94 and budget is \$15,000.00; and

WHEREAS, the 2017-2018 Budget Comparison with Justification Reports include the supporting documentation for this 2017-2018 Budget and also contains an itemization of certain expenditures and revenues required under administrative regulations; and

NOW, THEREFORE, BE IT RESOLVED, that the Sayreville Board of Education adopt the Proposed Tentative Budget for Fiscal Year 2017-2018 for the School District General Fund Budget of \$86,250,544.00, including a local tax levy \$60,289,602.00; and

NOW, THEREFORE, BE IT RESOLVED, that the Sayreville Board of Education adopt a Proposed Tentative Budget for fiscal school year 2017-2018 for the school district special revenue fund budget of \$2,098,432.00; and

NOW, THEREFORE, BE IT RESOLVED, that the Sayreville Board of Education adopt a Proposed Tentative Budget for fiscal school year 2017-2018 for the school district debt service fund budget of \$3,593,277.00, including a local tax levy \$3,445,666.00.

2. The Superintendent recommends and so moves the Board of Education of Sayreville to approve a Public Hearing on the 2017-18 School Budget on May 2, 2017, at 7:30 PM in the Sayreville War Memorial High School Cafeteria.

 - g. RJC Charities and the Auto Tech Club hosting a fundraiser car show for Jaclyn Squillace at the Sayreville War Memorial High School on Sunday, June 4, 2017, from 8:00 am to 2:00 pm in the parking lot. Rain date will be Sunday, June 11, 2017.

h. Stardust Musicals for Kids holding a musical theatre summer workshop at the Sayreville War Memorial High School on Mondays through Thursdays, from July 24 through August 8, 2017, from 8:30 am to 2:30 pm in the chorus rooms. Performance will be on Wednesday, August 9, 2017, from 6:00 pm to 9:00 pm in the auditorium. Fees in accordance with schedule.

- 5. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the use of one Board bus on Saturday, March 11, 2017, to transport approximately fifteen bus drivers and aides to Northern Burlington Regional Middle School in Columbus, NJ to attend the School Bus Driver Safety 2017 seminar. Fuel cost in the amount of \$45.10 to be paid by the Board of Education.
- 6. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the following trips:
 - a. On Sunday, March 26, 2017, sixty members of the Sayreville B.I.C. and chaperones to Bow Tie Cinemas in Aberdeen. Two Board buses will be utilized at a cost of \$227.17 (salary \$216.17 fuel \$11.00) per bus for a total cost of \$454.34 to be paid by the Sayreville B.I.C. Association. Buses will depart from Wilson School.
 - b. On Friday, March 31, 2017, twenty-seven students from the Sayreville High School French Honor Society and two teachers to Montclair State University to attend French Day 2017. One Board bus will be utilized at a cost of \$349.49 (salary \$310.99 fuel \$38.50) to be paid by the students.
 - c. On Thursday, April 20, 2017, forty-five 4th grade Samsel Upper Elementary School TAG students (Group 1) and two teachers to Meadowlands Environmental Center in Lyndhurst. One Board bus will be utilized at a cost of \$288.17 (salary \$242.72 fuel & tolls \$45.45) to be paid by the Board of Education.

- d. On Wednesday, April 26, 2017, forty members of the Sayreville High School Choir and two teachers to TD Bank Ball Park in Bridgewater to perform the national anthem. One Board bus will be utilized at a cost of \$278.30 (salary \$254.10 fuel \$24.20) to be paid by the Sayreville Board of Education.
- e. On Thursday, May 11, 2017, twenty-eight members of the Sayreville High School Choir and two teachers to Ambassador Theatre, New York, NY. Students will observe world-class artists performing American Music Standards. One Board bus will be utilized at a cost of \$316.43 (salary \$265.48 fuel & tolls \$50.95) to be paid by the SWMHS Choral Parents Association.
- f. On Monday, May 15, 2017, eighty-nine Sayreville Middle School TAG and Student Council members, nine teachers and two chaperones (if needed) to YMCA Camp Bernie, Port Murray, NJ. Three Board buses will be utilized to drop off at a cost of \$240.46 (salary \$174.46 fuel \$66.00) per bus for a total of \$721.38 to be paid by the Board of Education.
- g. On Wednesday, May 17, 2017, three Board buses will be utilized to return students and staff from Camp Bernie to Sayreville Middle School at a total cost of \$721.38 to be paid by the Board of Education.
- h. On Tuesday, June 6, 2017, ninety-seven Wilson School students and seven teachers to Burkes Park for the 3rd grade moving-up picnic. Three Board buses will be utilized in a four-way move at a cost of \$87.84 (salary \$83.44 fuel \$4.40) per bus for a total cost of \$263.52 to be paid by the Wilson School PTO. Alternate date: Wednesday, June 7, 2017.

RESOLUTION IN COMMON CAUSE WITH THE KINGSWAY REGIONAL SCHOOL DISTRICT SEEKING A JUDICIAL ORDER FROM THE SUPREME COURT TO COMPEL THE STATE OF NEW JERSEY TO PROVIDE SCHOOL DISTRICTS WITH SCHOOL FUNDING CONSISTENT WITH THE FUNDING FORMULA ENACTED IN THE SCHOOL FUNDING REFORM ACT

WHEREAS, SAYREVILLE PUBLIC SCHOOL DISTRICT ("DISTRICT") is a local public school district committed to providing the students whom the District serves with a thorough and efficient public education, as guaranteed to all students under the New Jersey State constitution; and

WHEREAS, the District believes that the school funding which it has received from the State of New Jersey has been incorrect and inconsistent with that which the District should have received pursuant to the funding formula enacted in the School Funding Reform Act of 2008,

WHEREAS, the District believes that the incorrect and inconsistent school funding which it has received from the State of New Jersey has negatively affected the District's mission to provide its students with a thorough and efficient public education; and

WHEREAS, the District wishes to pursue its legal right to receive school funding from the State of New Jersey which is consistent with the funding formula enacted in the School Funding Reform Act of 2008 so that the District may better provide its students with a thorough and efficient public education; and

WHEREAS, the Kingsway Regional School District has filed a motion to intervene in the <u>Abbott v. Burke</u> matter before the New Jersey Supreme Court and seeks a judicial order from that Court to, *inter alia*, compel the State of New Jersey to provide all public school districts in New Jersey with school funding which is consistent with the funding formula enacted in the School Funding Reform Act of 2008; and

WHEREAS, the District believes that it is in the best interests of the public which the District serves to join in the Abbott v. Burke matter in common cause with the Kingsway Regional School District and also seek a judicial order from the Supreme Court to, *inter alia*, compel the State of New Jersey to provide all public school districts in New Jersey with school funding which is consistent with the funding formula enacted in the School Funding Reform Act of 2008;

IT IS HEREBY RESOLVED that SAYREVILLE PUBLIC SCHOOLS seeks to intervene in the <u>Abbott v. Burke</u> matter and a judicial order from the Supreme Court to, *inter alia*, compel the State of New Jersey to provide all public school districts in New Jersey with school funding which is consistent with the funding formula enacted in the School Funding Reform Act of 2008; and it is

FURTHER RESOLVED that the Superintendent, Business Administrator, and Board Solicitor are hereby authorized to take such steps as necessary to intervene in the pending matter and to join in the arguments already set forth by the Kingsway Regional School District.
