FINANCE

1. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the Resolution on Transfers for the month of April 2016.

2. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the Transfer Spreadsheet in accordance with S-1701 for the month of April 2016.

3. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the list of bills dated May 17, 2016 prepared by the Board Secretary in the amount of \$2,499,655.24 for the Operating Account.

4. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the list of bills dated May 17, 2016 prepared by the Board Secretary in the amount of \$ 238,939.00 for the Cafeteria Account.

5. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the list of bills dated April 2016 prepared by the Board Secretary in the amount of \$11,710.00 for the Athletic Account.

WHEREAS, the Board has considered and balanced the benefits of receiving additional revenue as a result of E-Rate consulting services against the absence of any reasonable potential for risks involved in awarding a contract for such services; and

WHEREAS, the Board estimates that the cost to the Board for the E-Rate Consulting will be below the current bid threshold; and

WHEREAS, the award of the E-Rate consulting concession shall be based upon the most advantageous proposal, price and other factors considered pursuant to N.J.S.A. 18A:18A-37(a) and N.J.A.C. 5:34-9.4(g); and

WHEREAS, the Board estimates that it will incur minimal direct costs as a result of the of the E-Rate consulting services concession;

NOW, THEREFORE, BE IT RESOLVED that the Board authorizes the procurement of E-Rate consulting services as a concession pursuant to N.J.S.A. 18A:18A-1, et seq., N.J.A.C. 5:34-9.4; and

BE IT FURTHER RESOLVED that the Business Administrator/Board Secretary is hereby authorized to solicit and receive informal quotations from prospective vendors and to award a contract for such services to the vendor that offers the most advantageous proposal, price and other factors considered.

15. The Board of Education of Sayreville approved the following resolution:

WHEREAS, the Sayreville Board of Education (“Board”) and taxpayers of the Sayreville Public School District will benefit from the cost savings realized by the correction of billing errors that may exist in the Boards energy bills and by the utilization of alternative efficient energy procurement methods; and

WHEREAS, the Board intends to solicit quotations and potentially award a concession contract to a vendor who can provide energy audit services for a period not to exceed two (2) years with the option to renew for an additional two (2) years; and

WHEREAS, the Board has considered and balanced the benefits of receiving additional revenues as a result of the energy audit services against the absence of any reasonable potential for risks involved in awarding a contract for such services; and

WHEREAS, the Board estimates that the cost for energy audit services will be below the current bid threshold; and

WHEREAS, the award of the energy audit services concession shall be based upon the most advantageous proposal, price and other factors considered pursuant to N.J.S.A. 18A:18A-37(a) and N.J.A.C. 5:34-9.4(g); and

WHEREAS, the Board estimates that it will incur minimal direct costs as a result of the of the energy audit services concession;

NOW, THEREFORE, BE IT RESOLVED that the Board authorizes the procurement of energy audit services as a concession pursuant to N.J.S.A. 18A:18A-1, et seq., N.J.A.C. 5:34-9.4; and

BE IT FURTHER RESOLVED that the Business Administrator/Board Secretary is hereby authorized to solicit and receive informal quotations from prospective vendors and to award a contract for such services to the vendor that offers the most advantageous proposal, price and other factors considered.

Discussion Item: Committee Report

CURRICULUM

1. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the Credit Completion Summer Program for students in grades 6-8 at Sayreville Middle School from July 5 to August 11, 2016. The program will run Monday through Thursday (except for the first week which will run Tuesday through Friday) from 7:50AM to 1:00PM. Students not meeting the promotion requirements will only be permitted to enroll in outside courses if Sayreville does not offer the course.

2. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the donation of the CATCH (Coordinated Approach to Child Health) activity program to Arleth Elementary School from the South Amboy YMCA. The activity kit included materials, instructions and training. It was designed to provide over 300 activities that engage students in fun and motivating age-appropriate activities.
