

**A – VISION 2030: FINANCE & INFRASTRUCTURE**

**Discussion Item: Committee Report**

35. The Superintendent recommends and so moves the Board of Education of Sayreville to approve the following resolution:

**WHEREAS**, the Sayreville Board of Education (“Board”) and the students, staff and taxpayers of the Sayreville Public School District will benefit from additional revenues generated from advertising on Board property and websites; and

**WHEREAS**, the Board intends to publicly advertise for proposals from vendors capable of soliciting and securing companies to provide advertising for fees payable to the Board; and

**WHEREAS**, the Board anticipates that the contract would be for a period not to exceed five (5) years; and

**WHEREAS**, the Board has considered and balanced the benefits of receiving revenue in exchange for advertisement against the absence that such revenue would have on the Board’s budget and the relatively low risk involved in such a project; and

**WHEREAS**, the Board estimates that the total value of the advertising contract would be in excess of \$40,000.00; and

**WHEREAS**, the award of the contract shall be in accordance with the competitive contracting procedures pursuant to N.J.S.A. 18A:18A-4.1 through 4.5; and

**WHEREAS**, the Board estimates that it will incur minimal direct costs as a result of the advertising contract;

**NOW, THEREFORE, BE IT RESOLVED** that the Business Administrator/Board Secretary is hereby authorized to solicit competitive contracting proposals from prospective vendors for the management and acquisition of paid advertising on Board property as a concession pursuant to N.J.S.A. 18A:18A-2 and -4.1 and N.J.A.C. 5:34-9.4.
