

**EDUCATIONAL SERVICES ENROLLMENT CONTRACT 2021 - 2022 ACADEMIC YEAR**

***In accordance with Peruvian Government's Law 27665, regarding "Protection of the Family's Economy Law regarding payment of tuition to Private Educational Institutions," and as established with Law 29571, Protection's Code and Consumer Defense, all parents must be informed of the following notwithstanding the additional terms included.***

- Teaching Method:** Parents and/or guardians declare that the provision of educational services offered by Colegio Roosevelt will be carried out under the educational teaching method which is established sporadically by the Ministry of Education in the exercise of its guiding functions (e.g. face-to-face, remote or an alternation or combination thereof or similar) and according to the best practices implemented by Colegio Roosevelt. The change of method and any relevant aspects related to the educational services provided by Colegio Roosevelt will be promptly communicated to parents and/or guardians.
- Cost of the service:** Parents and/or guardians declare to know and agree with the information related to the cost of educational service described below and the other conditions informed upon the student's acceptance to Colegio Roosevelt, as well as the legal and philosophical framework observed by Colegio Roosevelt and the School's Internal Bylaws. Parents and/or guardians understand that Colegio Roosevelt's Board of Directors has the right to review tuition fees annually. Parents and/or guardians declare to know and agree to (i) the monthly tuition fee and reduced monthly fees with elective tuition reductions indicated in the table in this section, respectively; (ii) that, to the extent that parents and/or guardians comply with the requirements established for this purpose in the Registration Online, have the right to opt for the monthly tuition with elective reduction, (iii) that the option referred to in numeral (ii) above can be exercised both, when performing the Registration Online process on the school's web portal (ROL) and at any later time during the school year 2021-2022, as long as educational services are provided exclusively under the teaching method of remote teaching by sending an email to [admissions@amersol.edu.pe](mailto:admissions@amersol.edu.pe), and (iv) that monthly tuition fees with elective reduction will only apply for the period when educational services are provided exclusively under the remote education method. Colegio Roosevelt will inform parents and/or guardians in a timely manner of the date from which educational services will no longer be provided exclusively under the educational modality of remote teaching, in accordance with the provisions issued by the Ministry of Education.

The elective tuition reduction is also valid for the July matriculation fee. Elective tuition reductions are only applicable during months when the School is exclusively under distance learning. The Financial Assistance Program and elective tuition reductions are mutually exclusive and are not applicable simultaneously nor will Colegio Roosevelt grant them to the same student.

During these times of uncertainty and economic distress, Colegio Roosevelt needs your support. We thank all families who are able to continue paying the full tuition throughout next school year. Your commitment to our program and school community is invaluable.

\* Will vary depending on months in distance learning for those who choose the elective reductions.

3. **Tuition Fees:** The annual school fees include tuition and can be paid in ten (10) monthly installments: July (enrollment), August to December (Semester I) and March to June (Semester II). The dues for the payment of the monthly tuitions will be the last day of each month as indicated in the table below.

- The annual tuition for 12th graders will be divided into 9 monthly installments: July (tuition), August to December and from March to May (\$1,846 per month)

4. **Financial Assistance Program:** Considering the exceptional situation many Colegio Roosevelt families are facing, within the framework of the Health Emergency and the National State of Emergency, and aligned with our core values, the scope and resources of the Financial Assistance Program will continue for the 2021-2022 school year. This program provides to families who require assistance and upon compliance with the procedure and evaluation described in the documentation that will be provided to those who request it to the email address [financialaid@amersol.edu.pe](mailto:financialaid@amersol.edu.pe), financial assistance under the deferred payment of monthly tuition and reduction of monthly tuition. The Financial Assistance Program is different from the monthly tuition with elective reduction modality, mentioned in section 2. While benefiting from the Financial Assistance Program or monthly elective tuitions are choices for parents and/or guardians, both are mutually exclusive and are not eligible simultaneously nor will Colegio Roosevelt grant it to the same student.

5. **Matriculation Fee:** The matriculation fee is equivalent to the July tuition and is due on the 31st of that month. New students accepted to Colegio Roosevelt after the academic year has started, must pay a tuition fee equivalent to one-month tuition.

It is important to mention that, even if the parents and/or guardians have complied with the Registration Online process on the school's web portal (ROL), registration will not proceed and the student may not complete the following academic year in the event that the economic obligations agreed in this contract against Colegio Roosevelt have been breached, except in cases that have been the subject of a deferred payment agreement. The above is applicable without prejudice to the provisions of section 10. If this assumption is filed, Colegio Roosevelt will report 30 calendar days before the end of the academic year on non-continuity of educational services as a result of the above-indicated breaches.

6. **Annual Transportation Fee:** School transportation is optional. In case the school provides the transportation service, the conditions under which it will be provided, including the amount of the monthly fee, will be communicated in a timely manner to the parents and/or guardians. Those interested in contracting this service may pay it in the amount and number of installments that will be informed in a timely manner. Such fees shall expire on the last day of the corresponding month. Any changes to the service and the amount of the monthly fee, if provided the service, will be communicated in a timely manner to the users of the same.

7. **Penalty Interests:** Penalty interests will be charged on monthly payments made after the due date referred to in section 2 above, respectively, which will be accrued automatically. The default interest rate shall be equivalent to the maximum rate set by the Central Reserve Bank of Peru – BCR which is applicable, as published on the official portal of the BCR. Notwithstanding the foregoing, such interest shall not apply (i) to monthly tuitions which expire during the period provided by educational services solely under the educational modality of remote teaching, as required by Colegio Roosevelt, and (ii) in cases of approved deferred payment agreements under the Financial Assistance Program.

8. **Sports and other Extracurricular Activities:** Most sports and extracurricular activities have no additional cost to the applicable monthly tuition. However, there are some extracurricular activities that require additional payments, such as: photography, swimming academy, Suzuki classes, Classroom Without Walls Program, Out-of-School Adventure Education, among others. The cost of activities at an additional cost will be timely informed to users, as appropriate. In any event, these extracurricular activities shall be carried out and adapted to the health protocols established by the competent authorities for this purpose.

9. **School Policies:** Parents and/or guardians commit themselves to support the policies and procedures of Colegio Roosevelt outlined in the Parent Handbook located in the link [https://registration.amersol.edu.pe/Rolforms/POLICY MANUAL 2021.pdf](https://registration.amersol.edu.pe/Rolforms/POLICY%20MANUAL%202021.pdf) which we declare we have revised and accepted.

10. **School Certificates:** According to applicable law, Colegio Roosevelt has the right to withhold the school certificates corresponding to the periods of unpaid tuition fees.

11. **Medical Information:** Parents and/or guardians attest that the medical information provided is accurate and complete.

12. **Technology Digital Citizenship Agreement:** Parents and/or guardians declare that they have reviewed, understand and agree with the statements listed in the Digital Citizenship Agreement that their minor child/children under my guardianship will sign during the first month.

I agree that non-compliance with the School Policies, Internal Regulations and Digital Technology Conduct Agreement, which I have reviewed and agree with, could result in the suspension or cessation of my child's (or minor under my guardianship) studies and that tuition for the next school year is not guaranteed. I also declare that I have been informed that, in case there are unpaid economic obligations to Colegio Roosevelt for the 2020-2021 academic year, except in the case of a deferred payment agreement under the Financial Assistance Program, my child (or minor under my guardianship) will not be enrolled for the following academic year and, in the case of unpaid tuitions, it will be possible to retain the corresponding certificate of study. Finally, I assume the commitment to comply on time with the payment of school tuition as set out in this document. This contract regulates the provision of educational services exclusively during the year 2021-2022 and will be terminated without any subsequent act at the end of that school year, except for the benefits provided by Colegio Roosevelt or parents or guardians, as the case may be, that must be implemented subsequently as agreed between them, as well as the policies of Colegio Roosevelt and the provisions of the educational authority.

## ANNEX OF THE EDUCATIONAL SERVICES ENROLLMENT CONTRACT 2021 - 2022 ACADEMIC YEAR

In addition to the information contained in sections 2 and 5 of the Educational Services Enrollment Contract 2021 - 2022 Academic Year regarding the cost of the educational service, parents and / or guardians of new applicants are informed of the following applicable payments:

- **Application Fee** (non refundable, non transferable): **\$500** per student
- **One-time Entrance Fee** (non refundable, non transferable): **\$18,500** per student. A \$1,000 must be paid in advance. This payment is refundable if the student is not accepted, non refundable if the student is accepted but the parents decline the opening. Once the student is accepted, parents must pay the balance of the entrance fee (minus the \$1,000 paid as a deposit).

**Note:** When a refund of the entrance fee is applicable, parents shall be informed in a timely manner about the process, as well as the amount to be refunded, in accordance with the internal regulations of Colegio Roosevelt and the applicable legal provisions on this matter, after evaluation of the return request that is submitted.

I declare that I agree with the terms and conditions applicable to the provision of educational service provided by Colegio Roosevelt regarding the economic aspects described in this Annex, which is an integral part of the Educational Services Enrollment Contract 2021 - 2022 Academic Year.
