Minutes of the Regular and Executive Session of November 15, 2016

DISTRICT HIGHLIGHTS

- On November 4, 2016, the Eisenhower Elementary School Staff participated in the Jeans for Troops program. Proceeds went to the GI Go Fund. The GI Go Fund has created a model for providing unparalleled support to our military veterans, leading the way with innovative services for veterans to help them with employment, homelessness and connecting to their benefits. Eisenhower outdid the last two years' fundraiser of \$236 and \$240 by raising \$255 this year. Congratulations to the Eisenhower Staff for this worthwhile endeavor!
- The *Dollars for Denim* collection at the Samsel Upper Elementary School, during the month of November 2016, was used to obtain and deliver gift certificates to local restaurants which will assist the family of our own Nico Oneto. Many staff members helped organize the blood drive for Nico. The drive was a great success, in collecting over 175 pints of blood, as well as handwritten, heart-felt messages for Nico to read. We ask that you continue to keep Nico and his family in your thoughts. Thank you, everyone!
- On November 18, 2016, the students at the Sayreville Middle School had the opportunity to hear a speaker from the Travis Manion Foundation. This presentation challenged the sixth, seventh and eighth graders to live by the "If Not Me, Then Who" ethos. The Travis Manion Foundation (TMF) was founded after the 2007 death of Lt. Travis Manion, USMC, who was killed by a sniper while saving his wounded teammates in Iraq. The foundation was created by his mother, the late Janet Manion, to carry the legacy of character, service and leadership that our servicemen and women embody. The inspiration and movement is rooted in the words Travis spoke before leaving for his second and final deployment; "If not me, then who?" TMF inspires students to act rather than stand on the sidelines. This movement towards doing rather than waiting for someone else is the purpose of the TMF and one that the students heard loud and clear!
- Congratulations to the Sayreville War Memorial High School Bomber Football Team for their State Championship win on Saturday, December 3, 2016 at Rutgers University's High Point Solutions Stadium. They won the NJSIAA North Jersey, Section 2, Group 4 Championship, defeating Middletown North with a score of 41 to 14! We will be honoring these student athletes at the December 20, 2016 Board of Education meeting.
