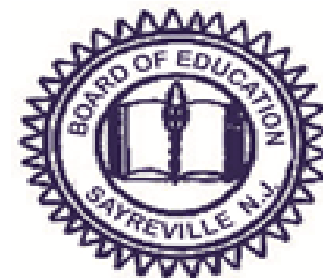


DISTRICT HIGHLIGHTS

- ▶ We would like to thank the Sayreville Fire Department and Fire Marshall Kevin Krushinski for arranging and implementing the fire trucks to go to each of the elementary schools, including the Little Stars Program at the Selover School, to help educate the children on fire prevention and also show them a fire truck up close. All of the children were excited to have this opportunity.
- ▶ Sayreville Middle School celebrated its 7th Annual Pink Out. Inspired by the struggle of a student's mother, Ms. Taylor and the physical education department established the Annual Pink Out as a way to educate students about breast cancer. On October 10th, Sayreville Middle School students participated in a breast cancer walk around the football field during physical education class. The field was lined with large informational signs about breast cancer prevention and the importance of early detection. In addition to the walk, the entire middle-school community was encouraged to wear pink to show support for those diagnosed with breast cancer.

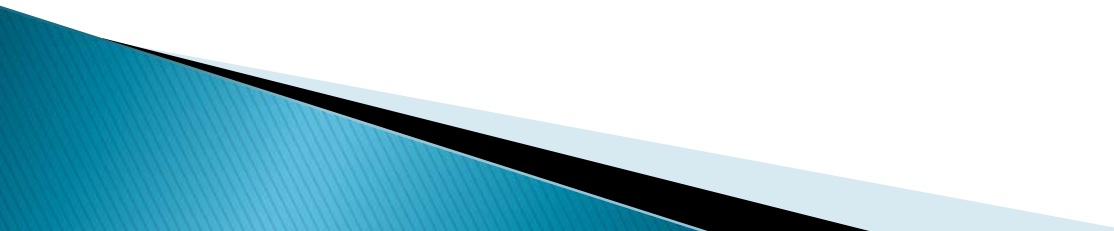


