CALL TO ORDER

The Governor Wentworth Regional School Board meeting was called to order at 7:00 pm.

AGENDA REVIEW

Ms. Cuddy-Egbert added discussion on the location of the April meeting and an out-of-state field trip request form.

ACCEPTANCE OF MINUTES/MANIFESTS

PUBLIC INPUT

- Jessica Williams, Wolfeboro, asked the status of the two notices served to the School Board at the last meeting. She said there is a deadline to schedule a public meeting. She asked that signed manifests be posted on the website within 72 hours of board approval. Ms. Williams said some board members are regularly absent and it is discouraging because it may delay business being conducted.
- Nate Williams asked if the Board has a position on House Bill 1646 relative to representation on a cooperative school district board. This bill requires cooperative school district boards to have an elected member from each pre-existing district and that the members would be voted within their own towns. Mr. Williams believes the current practice is a disservice to the smaller communities.

SUPERINTENDENT'S REPORT

Welcome by Principal Fournier/Math Presentation

Principal Fournier welcomed everyone and Curriculum Coordinator Kaitlin Hills introduced the District Math coaches. A slideshow and presentation was given explaining how students are learning math in the classrooms.

Election Results

Ms. Cuddy-Egbert read the election results. She congratulated Mr. Deshaies and returning members Mr. Pittman and Mr. Streeter. She thanked the communities for passing all articles.

Wood Estate Expendable Trust

Ms. Cuddy-Egbert said New Durham School, Tuftonboro Central School, Ossipee Central School, and Effingham Elementary are requesting \$10,200 from the Wood Estate Expendable Trust Fund to host Camp Invention for a week during the summer of 2022.

Motion: To approve the distribution of \$10,200 from the Wood Estate Expendable Trust Fund to bring Camp Invention to New Durham School, Tuftonboro Central School, Ossipee Central School, and Effingham Elementary during the summer of 2022.

Vote: Motion passed 7-0-0 on a roll call vote.

COVID Update

Ms. Cuddy-Egbert said COVID cases are minimal, masks are optional, and furniture is returning to typical spacing. The COVID hot line is disconnected so families should notify their school nurse if they have a positive COVID case.

Mr. Widmer informed Fallon Peacock that there is a student representative scholarship for 2022. He advised Board members that there are many workshops being offered. He said information regarding the formation of a new National School Boards Association is still in process.

CHAIRMAN'S REPORT

COMMITTEE REPORTS

Mr. Widmer said the Board will reorganize at the next meeting voting in a chair and vice chair and committee assignments will be decided. He asked the Board to let him know before the April meeting what committees they are interested in serving on.

Academic Affairs

Ms. Seibel said the committee addressed Policy BEA, Board Meetings and Policy BEDH, Public Participation at Board Meetings. They discussed bills currently in legislation that may affect these policies so the committee will wait to revise these policies to see if new laws may impact the current policy. If this is the case, they will await guidance from the NH School Boards Association and legal counsel if necessary. They also had a brief Student Health and Wellness discussion. Ms. Seibel asked if there are any students experiencing "long Hauler" COVID symptoms and if so, what supports are in place. Ms. Cummings said the District has not received any reports of this, but provides accommodations for students who suffer from extended illnesses identified in a 504 plan.

Advanced Planning

Ms. Cuddy-Egbert addressed the petition for a special meeting issued to the District pertaining to face coverings; making them optional for all students as well as employees and visitors. She said masks are optional so this is a mute issue. Petitions to hold a special meeting require signatures from 5% of registered voters. Ms. Cuddy-Egbert consulted the district attorney and school boards do have the authority to make decisions in various matters and requiring masks was acceptable during the pandemic.

- Jessica Williams, Wolfeboro, respectfully disagreed with Ms. Cuddy-Egbert and would like a special meeting held. She also asked that the policy adoption and policy revision process be reviewed.
