The Governor has signed legislation that candidates must submit a petition containing the signatures of 25 eligible voters or 2% of the number of voters who voted in the 2021 budget vote, whichever is greater. This petition must have 25 signatures of legitimate residents of the Onteora Central School District.

Our attorneys have confirmed that digital signatures are not allowed – the petition must have original signatures.

Also attached is the first expenditure statement. Please complete it and return it to me by April 18, 2022 with the completed petition. This also needs to have original signatures, so it can be dropped off at our Central offices.

CAMPAIGN EXPENDITURE AND CONTRIBUTION STATEMENTS FOR CANDIDATES FOR

MAY 17, 2022 ELECTION

- In accordance with Sections 1528 and 1529 of the Education Law, as recently revised, all candidates for member of the Board of Education must file three campaign expenditure and contribution statements.
 1. The first statement is due on or before the 30th day before the election (April 18, 2022) (spent under \$500);
 2. The second statement is due on or before the 5th day before the election (May 12, 2022) (spent more than \$500);
 3. The third statement is due within 20 days after the election (by June 8, 2022).
- If a Board candidate expends and/or others expend on his/her behalf less than \$500, and the aggregate amount of contributions to the candidate does not exceed \$500, a sworn statement (see next page) to that effect must be filed with the District Clerk no later than April 18, 2022. No other expenditure statements will be due, unless the Board candidate expends more than \$500 or receives more than \$500 in contributions or loans, in the time before the election. A sworn statement must be filed with both the District Clerk and the Commissioner of Education (see next page).
- The campaign expenditure and contribution statements must be completed, signed by the Board candidate and notarized by a notary public.
- If a Board candidate expends more than \$500 or receives more than \$500 in contributions or loans, a sworn statement must be filed with both the District Clerk and the Commissioner of Education (see next page) and must include the following statement:
 - Dollar amount of any contribution or transfer or the fair market value of any item which is other than money;
 - The name and address of the transferor, contributor or person from whom received;
 - If the transferor or contributor is a political committee, the date of receipt, the dollar amount of every expenditure, and the name and address of the person to whom it was made;
 - The date of the expenditure(s) and a description of the expenditure(s).
- Any contribution or loan that exceeds \$1,000 received after the close of the period covered in the last statement before the election must be reported within 24 hours after receipt. That statement must be completed, signed by the candidate and notarized.
 - includes payments for travel expenses, writing, printing and transmission costs of any letter, circular or other publication containing a statement of position or views of the candidate or other person upon public or other questions, including stationery, and postage, telegraph, telephone and public messenger service.
