RECORD OF BOARD PROCEEDINGS (MINUTES)

SPRINGFIELD, KY AUGUST 26, 2021 TAX HEARING/REGULAR SESSION/EXECUTIVE SESSION

The Washington County Board of Education met in a Tax Hearing/Regular Session/Executive Session at the Washington County TEL Center at 5:30 p.m. on the 26th day of AUGUST, 2021 with the following members present:

Board chair Curtis Hamilton led the pledge of allegiance, and board member Jeremy Thompson read the mission statement. Mr. Hamilton welcomed all in attendance and proceeded with the meeting.

Parent and community member Brandi Swift read a statement concerning school taxes.

Tax Hearing

Mrs. Judy Spalding, Chief Finance Officer, read the proposal of the recommended tax. A public hearing was held to hear comments regarding a proposed general fund tax levy of 59.2 cents on real property and 61.0 cents on personal property. This is .6 cents less than the 2021 rate. The General Fund tax levied in fiscal year 2021 was 59.8 cents on real property and 61 cents on personal property and produced revenue of \$3,905,355.90. The proposed General Fund tax rate of 59.2 cents on real property and 61 cents on personal property is expected to produce \$4,206,704.96. Of this amount \$575,329.12 is from new and personal property. The compensating tax for 2022 is 57 cents on real property and 59.4 cents on personal property and is expected to produce \$4,055,725.65. The general areas to which revenue of \$303,348.96 above 2021 revenue is to be allocated are as follows: Cost of collections, \$8,972 and instruction \$317,266. The General Assembly has required publication of this advertisement and information contained herein. Legislative Liaison Jeremy Thompson reported that the Interim Joint Committee on Education met on August 3, 2021. The American Enterprise Institute was present to discuss "All Races to Achieve Greatness" in education. The committee also discussed student assignment and public input/discussion on Critical Race Theory. The Kentucky Department of Education and the LRC Office of Educational Accountability was present and stressed no book should be used in a classroom unless it is on the approved state list. The Kentucky Science Center also gave a presentation. The Budget Review Subcommittee on Education met on August 4, 2021. The Kentucky Lottery was present and gave an overview on 2020 record sales and the amounts going to education. The was also a discussion that included AP testing and early literacy as related to KRS 164.207.
