# SPRINGFIELD, KY MAY 17, 2021 REGULAR SESSION

The Washington County Board of Education met in a Regular Session at the WC TEL Center at 6:00 p.m. on the 17<sup>th</sup> day of MAY, 2021 with the following members present:

Board member Jeremy Thompson led the pledge of allegiance and board chair Curtis Hamilton read the mission statement.

#### **ACT Wall of Fame**

The board and Superintendent Dr. Cochran recognized WCHS sophomore Dawson Coulter who earned a 28 on the ACT, and thus will have his name and score on WCHS's ACT Wall of Fame. Dawson was absent from the recognition.

## Legislative Liaison Report

Board member Jeremy Thompson reported that there were no Committee meetings held since the last board meeting to report on at this meeting. All board members were given a copy of all education related bills passed during the 2021 session.

The district activity fund total budget is \$234,207.

The school activity fund total budget is \$373,314.

Our capital outlay and building funds total \$476,727 and \$1,432,599. A total of \$1,297,252 will be used toward debt service.

Debt service budget for next year is \$1,511,997 for principal and interest payments. SFCC provides \$214,745 towards our debt service.

School food service has a budget of \$2,352,643. Budgeted salaries, fringe and on behalf payment equal \$645,610, operating costs are \$1,085.883 and a budgeted contingency of \$500,000. The indirect cost is budgeted at \$91,150.

Daycare has a budget of \$394,400.

Scholarship fund budget is \$18,882.

#### General Fund:

General fund received \$9,761,599 in revenue and spent \$7,487,765 in expenditures. SEEK revenue and payroll expenditures will be comparatively down from prior years due to Coronavirus Relief Funds being used to offset state SEEK funding in the general fund. The amount was \$757,322.

#### Special Revenue Fund:

Year-to-date expenditures for salaries and fringe are \$1,645,199 and operational expenditures are \$927,014. Payroll expenditures are up due to \$757,322 Coronavirus Relief Fund being used to offset state SEEK funding in the general fund.
