As parent or legal guardian, you remain fully responsible for any acts of the named student(s).

For and in consideration of the student(s) being allowed to participate in this program, and other valuable consideration, the undersigned parents, guardians or legal representatives, on behalf of the student(s) and the student's parents, personal representatives, assigns, heirs, and next of kin, do hereby release and hold harmless Bishop John J. Snyder High School, Inc., its employees and agents of said parties engaged in this particular program, and their personal representatives or assigns, from any loss or damage on account of any injury to the person or the personal property, of the student(s), or death, caused by negligence or otherwise, while the student(s) are engaged in the bus transportation program.
